No. STM. 21/75/200, the 8th January, 1976. Whereas the State of National Emergency has been proclaimed by the President under Clause (1) of Article 352 of the Constitution of India

And

Whereas with a view to maintain adequate supplies and to secure equitable distribution and availability of essential Commodities at prices fixed by the Government.

Now, therefore, the Lt. Governor of Mizoram in exercise of powers under Sub-rule (2) of Rule 114 of the Defence and Internal Security of India Rules 1971 as amended from time to time, and all other powers enabling him in this behalf do hereby order that the possession of Bogus Ration Card or Ration Card showing bogus or excess units or furnishing wrong statements in applications for ration cards for procurement of essential commodities would be offences under the said Rules. Any person violating the order shall be punishable under the provisions of the said Rules.

This order shall come into force with effect from 1st January, 1976.
