No. LAD/C- 2/74/60, the 13th February, 1976. Whereas the Lt. Governor (Administrator) of Mizoram is satisfied that circumstances exist for appointing a Commission to examine and report on certain specified matters relating to the Pawi District Council;

Now, therefore, the Lt. Governor (Administrator) of Mizoram, in exercise of the powers conferred on him watch paragraph 11 of the Sixth Schedule to the Constitution of India, is pleased to appoint an one-man Enquiry Commission consisting of Shri S.P. Aggarwal, I.A.S., Deputy Commissioner of Lunglei District, to enquire into the affairs of the Pawi District Council, and to submit its report to the Lt. Governor (Administrator) within 45 days from today.

Terms of reference for the Commission will be:

- 1. Whether the Pawi District Council have been functioning with the ambit of powers/functions specified under the Sixth Schedule to the Constitution;
- 2. On comparision between the funds sanctioned since 1972 and the expenditure incurred, whether the Council have made appropriate use of the funds and whether the accounts are properly maintained.
- 3. What should be the strength of the Council staff and what are their functions/duties and whether the Council is overstaffed or recruitments made indiscrimately without regard to necessity and qualifications.
- 4. Whether there have been financial or administrative irregularities in the utilisation of funds:
 - 5. Whether the Council have duly utilised the development grants.
- 6. What is the general ability and efficiency of the Council visa vis development of the Pawi people.
- 7. Whether the Council have framed laws and applied them in accordance with the necessities.
 - 8. Whether there are necessities for further legislation on specific subjects.
- 9. What is public support/general reputation of the Executive Committee of the District Council among the public.

The Commission may inter alia, also suggest-

- 1. If the Council, as it is, should be allowed to function etc. recommendations should be made or.
 - 2. Whether the existing Council should be dissolved. This Notification supercedes notification No. LAD/C-2/74/15 dated 23. 2. 1975.
