### ANNEXURE I

Terms, conditions and duties of Wild Life Advisory Board under the Govt. of Mizoram will be as follows :—

- (1) The Board shall meet at least twice in a year.
- (2) The Board shall regulate its own procedure (including the quatum).
- (3) No act or proceeding of the Board shall be invalid merely by reason of the existence of any vacancy therein or any defect in the constitution thereof or any irregularity in the procedure of the Board, not effecting the merits of the case.
- (4) Duty of the Board is to advise the Govt. of Mizoram in the following matters :—
  - (a) in the selection of areas to be declared as sanctuaries, National Parks, game reserves and closed areas and the administration thereof.
  - (b) in formulations of the policy in granting licenses and permits under the Wild Life (Protection) Act, 1972.
  - (c) in any matter relating to the amendment of any Schedule, and
  - (d) in any other matter connected with the protection of wild life, which may be referred to it by the State Govt.

The non-official members of the Board are entitled to DA/TA at the rate admissible to Grade I officers to performance of the above duties.

### ADVERTISEMENTS

No. PLN. 90/76/74, the 31d March, 1976 Applications in standard forms are invited from citizens of India for the post of a Research Officer (Gd-I) in the Planning Cell, under the Planning Department, Govt. of Mizoram in the scale of pay of Rs. 350-30-500 (EB)-30-650-(EB)-35-1000/- p.m. (pre-revised scale) plus other allowances as admissible in Mizoram from time to time under the rules.

2. Application will be received by the undersigned upto 15th April, 1976.

3. **QUALIFICATIONS :** A candidate must be atleast 2nd Class M.A. in Economics or Statistics from any recognised University. Knowledge of the local language will be desirable,

4. **AGE :** A candidate should not be more than 30 years, but not less than 21 years on the 1st January, 1976. The upper age limit is relaxable by 5 years for Scheduled Castes/ Tribes and upto 45 years for displaced persons migrated from East Pakistan on or after 1.1.1964, but before 25.3.1971, repatriated from Burma and Ceylon (now Sri Lanka) who migrated on or after 1.1.1963 and 1.11.1964 respectively and those who are in Government Service under the Government of Mizoram.

5. There is no age limit for the candidates serving under the Government Office.

6. Applications should be accompanied by a Treasury Challan of Rs 5/- (Rs 2.5) in the case of Shedule Castes/Tribes and War Service Personnels, persons migrated from East Pakistan on or after 1.1.1964 but before 25.3.1971 and persons repatriated from Burma and Ceylon (now Sri Lanka) on or after 1.1.63 and 1.11.1964 respectively, credit into the Treasury under the head "296-Secretariat Economics Services- "Application Fee, etc." which will not be refundable.

7. Preference may be given to the persons having experience in the line.

8. No T.A./D.A. will be payable to the candidates who are called for interview.

9. Candidates in Government Service and Statutory bodies should apply through proper channel.

10. Canvassing directly or indirectly will disqualify a candidate.
