- 1. To enquire into the rates of Minimum Wages of all persons borne on any Scheduled Employment.

- 3. To review the rates of Minimum Wages of the Scheduled Employees in relation to the cost of living index as may be necessary from time to time.
- 4. The terms of Office of the non-official members of the Committee shall be for two years commencing from the date of issue of this notification or till his successer is nominated.
