TERMS & CONDITIONS :---

(a) The function of the Committee shall be advisory in nature, and all decisions of the Committee shall have to be referred to the Government for final decision.

(b) The terms of office for the above members of the board shall be normally two years with effect from the date on which the Board is constituted. The members shall hold office during the pleasure of the Lt. Governor of Mizoram.

(c) The Committee shall ordinarily meet once in every three months.

(d) The notice for the Board-meeting shall be issued at least fifteen days before the date of the meeting by the Secretary with prior approval of the Chairman.

(e) A member shall cease to hold office, if he is absent from three consecutive settings without permission of the Chairman of the Committee.

(f) Six members shall form the quorum. If there be no quorum, the Committee shall be adjourned to a subsequent date. No quorum will be necessary for adjourning the meeting.

(g) In absence of the Chairman, the members present shall elect one of the members present to preside over that particular meeting.

(h) Non-official members will be entitled to T.A./D.A. admissible to Grade I Government Officers and M.L.As. as admissible under Rule No. 3 of the Mizoram Salaries and Allowances of Members of the Legislative Assembly ACT, 1973.
