No. LRR. 115/76/4, the 24 April 1976. The Committee on Land Tenure System in Mizoram constituted under Notification No. LRR. 115/73/1 dated the 23rd April, 1974 having expired on the 31.3 1976 the Administrator of Mizoram is pleased to reconstitute the said Committee afresh with the following members under the Chairmanship of the Minister-in-charge Revenue to Study the existing land Tenure System in Mizoram, and to recommend to the Government, the appropriate land tenure system to be adopted and finally legislated in Mizoram.

The Committee shall start functioning immediately. The tenure of the Committee will expire on 30-9-'76 unless otherwise extended. TA/DA would be admissible to non-official members at the rate as admissible in respect of journey/ halts on tour to a first grade officer of the Central Government serving in connection with the administration of the Union Territory.
