In pursuance of the provisions contained in section 4 of the Mizo District (Agricultural Land) Act, 1963, section 3 of the Lushai Hills District (House sites) Act 1953 and section 8 of the Mizo District (Land and Revenue) Act, 1957 and the Rules made thereunder, all the lands allotted to the BRTF/Project Pushpak and other Government Departments but since abandoned or relinquished will revert back to Government as soon as they are abandoned or relinquished. No Village Council/Government Department or the allottee has the right of use, disposal or subletting of such lands. Such occupation and possession without prior approval of Government is liable to eviction/ejectment according to appropriate provisions of law now in force.

## ORDER

No. CB. 787-95/76/VIII-8, the 14th June, 1976. Whereas it is necessary to regulate movements of vehicular traffic in the interest of public safety and to avoid accidents and since there exist sufficient grounds for proceeding under section 74/75 of Motor Vehicles Act (No. 4 of 1939).

2. Now, therefore, I Shri A.D. Souza, IPS, Superintendent of Police, Aizawl District hereby order that :—

(1) No vehicle is allowed to proceed towards Zarkawt from Bungkawn Police Point via Bara Bazar main road. All vehicles will follow Upper Bazar Road.

(2) No vehicle is allowed to proceed towards Bungkawn Police Point via Bara Bazar Road from Dawrpui Church Point. All vehicles should follow Bara Bazar main road.

(3) All vehicles coming from Babutilla and Civil Hospital side, while proceeding towards Bungkawn, will follow Upper Bazar road upto Dawrpui Church Point and then will proceed via Bara Bazar Road.

3. It is further ordered that blowing of horn on the main road from the Divisional Forest office, Aizawl to the traffic junction near the Post office is also prohibited.

This order shall take effect from 14th June, 1976 and shall remain in force untill further orders.
