No. LRR. 19/(A)/73-76/82, the 15th December, 1976. Whereas it appears to the Government of Mizoram that land required to be taken by the Government at the expense of the Deputy Commissioner Atzawl District for a public purpose viz. location of S.D.O. (Civil) Office Complex which is situated at Champhai. In the Aizawl District of Mizoram : it is hereby declared that, for the above purpose, land belonging to Shri Paul Zakhuma of Shillong measuring more or less 1,87,200 sqft of standard measurement bounded on the :--
