March Session, Held At The Council Chamber  
On 29th March 1967:

## 1st. Sitting.

Chairman : Pu Lubuaia. Chairman.

CHAIRMAN : Nikum March 1966 thla tira kan inkhawm kan ram buaina avangin vawiinah kan chhunzawm thei chauh va. Kan ram buaina avangin tun tumah payah hian kim lo takin leh hun chép takin kan ti ta a. Kan ram mawphurtu kan nih hi kan lantir zel tur a ni. Tûn tum kan jhu khâwmah hian kom lo takin kan ti dâwn a.

Development lamte leh Receipt lamte tih theih engmah a awm ta lo va. Chuvangin, nikum lama kan Budget-te chau

engmah awmze nei u ni ta meuh lo va. Chuvangin, kan Executive Member te'n nikum lama Budget-te chau sawifiah ngai leh tūl an tihne han sawi sela a tha ang.

#### PU H. K. BAWICHHUAKA : (C.E.M)

Pu Chairman, tuna i han sawi ang khan nikum March, ni 2-ah khan kan kum khat Budget (1966-67) chu Present a ni tawh a, a copy pawh member te'n in neih theuh ka ting a. Kan hriat tawh angin nikuma Budget present tawh sa leh a bak resolution tamtak chu M.N.F. te'n buaina an siam tek avangin kan chhunzawm thei ta lo va, tunah hian kan chhunzawm leh thei ta chauh a ni a, hei pawh bi vannei thlak tak a ni. A dan ang chuan Session inkar hi, thla li (4) a ral hman tur a ni lo va; hetianga session neih theih tawh loh chu. Governor-in a phal leh theih tak avangin kan tihne chauh a ni a.

Tin, kan Budget present tawh sa pawh khan awmzia a nei hiei thei tawh lo va. Kan pawisa hmu tur anga kan tihlan pawh kan hmu thei ta lo reng reng a. B.R.T.F. ten kawng an laja an thing leh lung tribal zawng zawngte pawh hi cahian lak kan tun a. Deficit pawh a lan dan nen khan a inang ta lo hle a. Education lamah erawh chuan a pangngai kan hmu thei a. Thil dang reng rengah chuan kan hmuh tum ang hmuh a awm ta lo a ni, Leiman nuai kua

hmuh theih turah khan, nuai hnih che che kan hmu thei ta chauh mai a. Education lamah hian nuai thum lai kan hmang tawh a, chu chu engtia tithei nge kan nih member te'n min briatpui pawh a ngai a ni.

Chu mi avang chuan tora lak tur kan neih mekte nen nuai riat emaw chu min tum sak tawh a. Nimahscia, kan indaih lohna chu nuai hnih dawn lai a la ni tho a ni.

#### OFFICIAL BILL: AMENDMENT THE CONSTITUTION OF DISTRICT COUNCIL RULES OF 1951

PU H. K. BAWICHHUAKA (C. E. M) Pu Chairman, District Council Constitution hi rin loh lam atangin harsatna a lo thleng a. Harsatna tlu "emergency" a lo awm hian dante hi siam that nawk nawk a ni thin a. Emergency ah chauh loh chuan tih tul lo te a awm bawk a. Normal condition a awm loh avangin kan dan pawh siam that a lo tul ta a. A tul ta chu:—

JANUARY 31, 1969.

"Rule 36 (3) Provided in the event of an emergency, the Chairman of the District Council, in consultation of the Chief Executive Member, may summon the District Council oftener and at shorter notice than what has been provided in sub-rule (2)" hi a ni a.

Rule 36 (3) na chuan "Emergency-ah chuan Governor in Session a tul hun apiangah a kohtir thei ang" tih a ni a. Chuvangin thil tul thutah chuan hetiang dan hmang hian (a chhiar a) min tihtir thei a. Sub-rule (2) nain a phal baskah hian hun tul bikah ci can Chairman-in Session a ko thei ang tih a ni a. Sorkar lam atangin thil tul that lo awm ta sela, a tih thei ang tihna a ni a. Hemi subrule (2) naah hian ni 30 hmain hmat lawktur tur tih a ni a.

Nimahsela, tun ang hunahte chuan ni 30 hma lamin hriattir ta ila, a harsa zawkin an nunna atan pawh a blathawm thei a. Chuvangin hemi hi heti hian thlak ta ila (a chhiar chhuak a) kan ti a ni. Hei hian Governor power a titlem chuang lo va. Rule 36 (5) na lo en ila, Governor chuan a duh hun hunah Session a ko thei tho dawn a.

A hun taka kan inkoh chuk chuk theih nan hemi dan amendment (a chhiar chhuak leh a) hi kan rawn siam a ni.

CHAIRMAN: C. E. M. sawi ang khan tunlai thilah member-te koh a harsa a. Governor rawn zetin koh chu a harsa a, Chief Executive Member nena inrawnitianga koh theih a lo nih chuan keiniho tan pawh a zangkhaiin a awlsam zawk dawn a. Chutianga kan theih ve tawhna tur dia a lo ni dawn a. Tuna an tih ang hian dan thar chu siam ni mai sela, kan tana thil awlsamma leh thatna a ni ang a. Sawi duh nei in awm chuan han sawi ula (Member te an ngawi a).

Awle, sawi duh nei in awm tawh lo a nih chuan he thil hi thil tul leh tha tak a ni a. Kan hotute'n ngun tak leh chik zawka kan memberte leh kan ram tante pawh tha zawk nia an lo ngaiantuah tawh a ni a. Kan remti tlang em? (Member te: Aw) Chuti chu he amendment hi remti a nih chu.

CHAIRMAN: Tunah Amendment Jhumming Regulation. 1966 an ti leh ang a.

Chuvangin, hetah hian sawi dun nei in awm chuan han sawi leh ula, a tha ang.

PU H. K. BAWICHHUAKA : C. E. M. Pu Chairman, hemi Regulation Amendment bi a lo rei tawh avangin Bill ni lo vin dan emaw ka ti reng nghe nehe a, mahse, bill a lo la ni reng a. So kar lam chuan hetiang hian a lo remti tawzaw a. (A chniar a.)

Kan District hian buh-bul lam hi kan kum tin tlakchhamoa a ni a, chuvangin, thlawhhma lam hi sem sawm dan ngaiantuah a ni a, "Lushai Hills (Forest) Act, 1953" tin hi la thlak loh a ni a, Mizo District (Fores:) Act, 1955 tiha thlak tur tihna a ni a. Hei hi a lam dia tur a ni e, tihna mai a ni. Section 4-(1) hi en ila (a chhiar a) Executive Committee emaw Officer a ruatten emaw lo theh thua buaina a awm chuan ram an thehsak thei ang tihna a ni a. Village Cauncil ram theh buai a awm chuan Executive Committee-in emaw Officer ruatin emaw ram an thehsak hlaul tihna a ni a. Note-a (a chhiar a)

a) "Any Land" tih khan ram dang Village Council theh chhung ni lo a tihna a ni lo va. Village Council ram theh chlurg chath tlo a sawi a ni. Tin, II (a&b) hi (a chhia leh a) Village Council ram pakhat hi a khaw thenawm hnenah "Executive Committee-in-emaw Officer-a ruatin emaw a thehsak thei ang" tihna a ni leh a. Chung a thehsak theihna dan chu (a&b)-na (a chhia leh a) khaw pakhatin kar kawng-te lo enkawl tha duh lo sela emaw Executive Committee-in tul a tih hrim brim vang pawhin, a thehsak thei arg tihna a ni leh a. Mahse, helai a reasonable grounds tih kha zuk tehnna a awm chuang lo va, Tehna zu awm chhun ber chu Village Council-in kar-kawng emaw a khaw ram chhung kawng dang reng reng emaw pawh lo enkawl tha duh lo sela, tihna a ni. Kawng dang chhaa tha zawk pawh a awm ang a, kar-kawng enkawl that duh loh vanga ramte kan thehsak thei a ni chuan a chhan dang pawh a awm thei zel ang tih tiblunna mai a ni.

rinawm a.

**Khaw pakhatin a thenawm khaw tan an ram a phal loh tlat chuan an buai chu a ni mai a. Chuvangin a ram ngah zawk lamah chuan pem maj sel a, khaw thenkhatte chuan Executive Committee-in ram a pe thei alawm tiin an thenawm ram kha an hnik an hnik mai dawn a. Chuvangin Village Council hian anmahnin ram bikin nei tawp mai sel a, chu chu tha berin ka hfia.**

**PU HRANGAIA, E. M:** Pi Chairman, Pu-C.
