#### OFFICIAL RESOLUTION : "ELECTION OF DISTRICT COUNCIL".

**PUH.K. BAWICHHUAKA,C.E.M:**

Pu Chairman, he kan resolution :-

"Whereas the life of the existing District Council expired on 23rd. June, 1967, but whereas the Mizo District is declared disturbed area; and whereas free and fair election would not be possible, and in view of the risk to be involved, the District Council is of the opinion that it is not expedient to hold the District Council election at present" tih a ni a.

District Council inhlanna chu rawn siam ta ang selay inhlanna chu bial hrang zelah Polling Centre pakhat emaw an dah thei chauh dawn a lo pi ang a, 'Fair Election' a ni thei lo reng reng ang. Tun, M.L.A. leh M.P. thlannaah pawh khan Circle X-ah te, Circle VIII-ah te leh Circle VI-ah te chuan Polling Station an siam thei lo reng reng a. Chuvangin, District Council Election hi thiltihtheih leh awm thei niin a lang lo a ni.

Aw le, tunah kan Budget 1967-68 C.E.M.-in a rawn present kha kan lo ngaihtuah tawh ang a, "Chief Executive"

Member-in a sawi tawh ang khan Receipt lam chu beisei a ni ringawt mai a. Kun-hmuu theih dawn leh dawn loh tuman kan sawi chiang thei lo vang a. Expenditure lam pang hi chu a tlem thei ber tur anga buatsaih, hmanral loh theih loh anga ngaih a ni dawn a. Kan Receipt chu cheng maktaduai laiin a tla hniam dawn a lo ni lehngthal a. Chuvangin, sorkar nghenchhanin he kan Budget 1967-68 hi buatsaih a ni chauh mai a.

Tin, kan hriat theuh angin tun tum kan Session hi Budget Session a ni ber a. Beisei loh taka Member-te Aijal-a in lo kal avangin he Budget Session hi hmanhmawh taka tih a ni a. Works lama kan tih tumte kan en pawhin sorkar hi an ngilnei em thin a, ni pe leh mai mahna tih kan beisei a

ni ringawt mai a,

Heng kan Council in cheimawinate pawh hi min pe mial mibna kan ti a ni ber mai. Beisei sang deuh phei chu ni ila, District Council in te pawh hi tha deuh khek-khawk leh mawi-hnai deuh piwha sak kan duh a. Chuvangin, engkim mai hi ka beisei a ni ringawt mai a, kan sawiho tul em em tul pawh kan hre mang lo.

**CHAIRMAN :** A ni e, hetiang thil hi kan sawi tawh angin kan bei ngam lo ya. Tunah hian kan Budget chu han discuss mah ila, thil beiseina maia Budget siam a ni a. Tun tum inkawm pawh hi hmanhmawh taka Special deuh-a koh a ni ngawt a, Nimin Lamah pawh khan kan sawiho tawh kha. Chuvangin kan Budget 1967-68 hi a mil te te vote loin a pumpui thu hian kan vote mai thei lawm ni, thil harsa a ni lem em ni ka ti deuh a.

**PU HRANGAIA : E.M.** Pu Chairman, a chhan hriatfiah duh thuhlaah zawhtur ka nei a. He kan Budget hi kum dinglam tak kan lo tawh tak avangin thil danglam tak a lo awm ve a. Tunhma kha chuan Council term a laklwh dawn chuan tun anga kan budget hi chu a puma kum khat chhung atana-siam a

lo ni ta hi engnge ni a chhan ?

**PU H. K. BAWICHHUAKA :** C. E. M. Pu Chairman, Council Session hi eng hunah nge kan neih leh theih dawn tih pawh hi briat a harsain ngaituah tham fe awmin ka hria a. Kan District Council hi eng anginng a kal zel dawn pawh hriat a ni lo va, Engpawhnise ka sawi tawh angin he Budget hi "Beiseina Budget" a ni ringawt mai a. Memberte hi lo danglamin tupawh lo thu se, he kan Budget siam hi Beiseina ringawt a nih avangin a tlem thei ang bera siam a ni a, nakina siam chawp leh ai chuan kum khat huapa kan siam chu an awlsam phab dawn a: Hun tha leh thiltihtheih a awm hiauh chuan Supplementary Budget pawh a siam leh theih zawk avangin kum khat huap nghalin kan siam mai a ni e.

**PU HENMANGA :** Pu Chairman, he kan budget kan pass hmain han sawi ve hlek duh ka nei a. Kan thu sawi nen a inchawih lo viau pawh a ni thei a. He laiah kan lo kal khawm a, mahni harsatna avang pawh a ni mai thei a. Inkhwannate kan nei thei leh zel a, a lawmawm hle a.

Member te hi kan inang lo em em a. Kan dihomunte hi kan thiante hian an ngaimawh em em a, bang tur hian

min duh reng a, ban te phei chu kan hnial pawh a ni lo va. Hei kan han tñi leh ang a. Thingtlang lama mite chu lei lamah Convoy ah hawn a lo tul leh ang a, lei lama kalte hi a hlauhawm hle mai si a. Ka lo kal lamah pawh ni 15 lai kalkawngah ka rawn thang a. Helicopter te han ti ve ila, kan lang tham ve si lova, kawng tinrengah hian kan him tawk lo hle hian a lang a. Session te pawh a lo tul leh thei a, Helicopter te bi kal reng a nih si chuan loh theih lova seat min reserved sak vete hi a tul hle lawm ni ?

Tin kan hotute hian thingtlang lama member te hi engangin nge mi ngaisksak ve dan tur hi ka bre duh a. Lungleh lamho tan chuan lei lama kal lovin chung lama kal ve theih ngei hi ni ve se ka ti a ni.

Kei ka awmna atangte phei chuan Sipai an bla si a. M.N.F. Volunteers lamte ka be tha ringawt mai a, a chang chuan an hotute pawh kan ni lek lek thin a ni. Chuvangin, keini thingtlang lama memberte leh Lungleh lam ho te hi min ngaihtuah deub ula kan hawng ang a, kan muang lo leh em em mai dawn a. Chuvangin hei hi tul hle in ka hria a ni.

**PU C. PAHLIRA, E.M:** Pu Chairman, kan Budget cnungchangah hian sorkar lamah pawn sawi duh ka nei a. Tunah khan kan C.E.M. khan keinna kan Budget siam hi "Beiseina Budget" mai anta rawn ti a. Kumina kan Budget buatsaih ang zat zat chu sorkar bian min pe ngei tur a ni.

Nikum lama kan budget siamte min pe tha duh lo pawh hi mak ka ti em em a. Hetiang anga kan ramin harsatna a lo tawh takah chuan sorkar hian kan mamawh chu a rawn phuhruk ngei tur a ni a. Hetiang anga min ngaihsak na an nei tha duh lo leh harsa taka nawr an ngii hi min ngaihtuah vang a a ni lo thei lo va. M.N.F. te ang bawkin he kan ram buaina chungchangah pawh hian mawphurtu an nih chu khawvel pawhin an hria a. He kan rama buaina avanga hian harsatna tam tak mipuin kan nei a. Tunah pawh hian eitur nei lo leh in leh lo nei lova buaipui tu tur nei lo Ajal ah manganga lo tlan lut pawh tam tak an awin tawh tih kan hria a. He Ajal hmunte hi India hmun lai h ni? mipui mangangte chhawmdawl nan Relief Work tam zawk siamin an pe ngei ngei ang tih chu rinhlelh rual a ni lo.

Test Relief Work ang deutan Ajil kawng siam that nñ kan hmang rih a. Chutiang anga kan hman avang chuan nei lo zualte inturidin ve theihua an lo neih piah tiein a.

Nikum kan Budget-sh khan Assam sorkar chuan Staff te pay te chu tih loh theih loh angan an ngai chauh a. Amaherawchu, Works lama kan hmanteghi an ngaihiam duh lo lui tlat pawh hi mak ka ti ve a ni.

Kuminah pawh hian kan Budget estimate ah Lian kan inthlaturung em em a. Chuvangin, a tlem thei ang berin loh theih loh thil atan kan buatsaih chhin chauh a ni a. Hun thawl tha phei chu nise sawi ngai lovin a tlém lutuk daih zawk ang a. Chuvangin he kan Budget a tlem thei ang bera kan siam kha expenditure tura ruahman li chu min pe ngei tur a ni. Min hmang ih nise tun

aia tam hi min pe zawk ngei ngei tur a ni a. Kan harsatnate an hriat that duh thin loh avang in Budget hi a tlem thei angin buatsaib a ni a. Chuvangin, kan member-te leh mipuite pawhin chiang taka in hriat hi ka duh em em a ni.

**CHAIRMAN:** Kan thil han ngaihtuah hi sawi bleih theih loh sawi loh theih loh a ni a. Kan sawi tawh angin inkhawmnate kan han nei leh thei hrām a, a lawm awm hle a ni. Sawi tur dang nei in awm chuan han sawi zel ula.

**PUH.K. BAWICHHUAKA, C.E.M:** Pu Chairman, he laia ṭanpui kan ṭulzia kan sawi hian sorkar beng a thleng tawk lo a ni ang. Election thute theihtawpa kan hotuten an sawi pawh sawrkar chuan a ngai pawimawh duh chuang lova. Hetab hian M.N.F. aiin sorkar kan dem zawk a ni lova. M.N.F. ten buaina tawp khawk an rawn siam takah chuan sorkar chuan kan manganna leh harsatnate chu min ngaihtuah thuai tur a ni a. Mahse, hetiang anga buaina leh harsat-

naah pawh sorkar chuan min la ngaihtuah tawk loh avangin sorkar pawh hi kan dem lo thei lova.

Tuna Pu Henmanga sawi ang khan buaina leh harsatna sawi tur pawhin zin velna tur pawh min ngaihtuah sak tha duh lova. Kan M.D.C. te tan chauhete chuan Helicopter te chu phalsak ve awm tak, chutih a hnekin kan M.D.C. zahawm pui puite pawh hi min hre tha duh lova. Hetiang anga min hre tha duh lo hi kan ram hi tib bengvar pawh tum lo leh, anmahni pawhin bengvar tumna nei hlek lova kan ram hi thenfai tum anga ngaih loh theih pawh a ni lo va.

Tin, keini M.D.C. te pawh hi kan awmna hmun theuhah kan inlan a, kan inhriattir luh pawh a ngai a. Kan ramah chuan kan biek phakte hnenah chuan suggestion tepawh siamin a tha tur anga kan rinte chu kan sawi ve pawh a ngai a. Vahvel hi a harsa em em mai a. Sorkar laipui hnenah pawh kan sawi fo tawh thin a. Delhi te Helicopter thu thleng pawha sawi a lo ngai a. A sawi pawh kan sawi thin a. Min awptu Assam sorkar hi a tet em avangin heng te neuh neuh thleng hian sawi a ngaiin Delhi ah pawh kan thlen lo thei lo a ni. Delhi lam chuan kan harsatnate min briathiam pui viau va. Kan ram buaina hi Chaliha vang kan ti ve lo thei lova. Chaliha hi kan dem lo thei lo a ni. Chaliha

sorkar hian min ngaihtuahna an nei lo kan ti lo thei lo bawk a. Chuvangin Delhi lama kal tur pawh hian Chaliha so kar dem tur kan nih avang hian Helicopter pawh min pe tha duh lo niah kan ngai a.

Anyone contravening this order shall be prosecuted under section 188 of the Indian Penal Code.
