PU H.K. BAWICHHUAKA, C.E.M: Pu Chairman, kan Forest Dan Section 13-na hi ka han chhiar ang a, (a chhiar a) Section 12-na ah Village Forest Reserve a tih chu Class hnihil then a ni a. Khaw bik emaw khaw awm-khawm ten an hlawpui theih tur angin Executive Committee in Village Forest Reserve a siam a. Chungte chu (1) Safety Reserve (2) Supply Reserve an ni.

Chu chu a tawk ta lo va. Entirnan: Khilai Champhai leh a chhehvel a khaw hrang hrang tan Common Reserve lo siam dawn ta ila, dan kan la nei lo va. Tun hmaa luipui dung kan reserve te pawh dān mumal tanchhan tur a awm chiah lo va. Hmun hrang hrangah Thenzawl leh a chheh vēl leh ram dang dangah te pawh Common Forest Reserve kan la siam a ngai mai thei a, Chuvangin he Protected Forest Reserve Dān hi kan neih a ngai a ni. BILL FOR AMENDMENT TO THE MIZO DISTRICT (ADMINISTRATION OF JUSTICE RULES).

PU H. K. BAWICHHUAKA C. E. M. Pu Chairman, sawinawn theibna min pe a, ka sawi atang chuan a Principle in a zir ber dawn a pass theih mai pawh a tha a.
