CHAIRMAN : Member-ten hemi appropriation account thilah hian sawi duh in nei em ?

Actually, however only, 139 bundles and 11 sheets of Aluminium Corrugated Sheets were received by the Council. This resulted in an excess payment of Rs 15,020/- to the firm. Report regarding recovery of Rs.15,020/- from the firm is awaited. (November 1966)” tib a awm a.

**PU MRLAI HLYCHHO:** Pu Chairman, kan Resolution min lo pawm sak avāngin ka lawm a, ka Resolution chu hei hi a ni ,

"Mizoram pumpui thlirin Lakher (Mara) naupangte chuan zirna lam kawngah hma sawn thei lo ber an ni a. Primary leh Middle Schools ah naupang zirlai an tlem em em a. Hēng an hnufualna chhan ber nia briat chu tun hwas an mahni ṭawnga sikul lekhka an zir thim kha Mizo ṭawnga thlak a nih tāk vāng a ni.

Khing an harsatna tibkian sak tūn tūn achinah Lakher naupangte chuan Primary leh Middle School ah anmāhñi ṭawng (Lakher) hi medium of instruction atān hman ni tawh rawh se. District Council-in a ti".

in an zir a, an thiam ve zēl a. Imphal ah pawh vawihnhai lai ka kal tawh a. Lāam dang te awm dānte pawh ka hria a, tawng tuallēng an thiam tam ting mai a ni Chuvāngin saw laiah pawh sawn tawng tuallēngah Lushei tawng hi hmang ve se la, ka dub a ni.

Engpawh ni se, hman laiin Babel in sāng an lo sa a, an sak puitlin hlaevin Pathianin an tawng a lo ti hrang ta miau mai a. Chuvāngin tawngte hi inhriat sak lobi kan duh mai mai nijin a lang a. Hmar te, Paihte te pawh hian Lusei tawng hi an thiam vek a, thiam awmin an awm duh lo va. Kei pawh Tuipāngā ka kalin Lakher naupang chu ka han bia a, ka tawng chu an hre thei viau mai a, an tawng erawh chu ka hre thei lo va. An zirtirtute phei chu Pu Mylai-a aia Mizo tawng thiam deuh blir an ni nghe nghe a.

Tawng hriat zau hi a pawimawh ém ém a. India ramte hi han fang ila, sap tawng te, vai tawng te kan thiam a tūl a. Tawng kan thiam na na na chuan khawiah rawh a tlangnēl theih a, tawng kan tbiam lohnaah chuan kan mikhual tlat zēl a ni. Chaliha pawh chuan a lo tī mai pawh a, hēngte hi a ti thei dāwn emaw rawn en rawh ke. 6th. Schedule te hi zuk amend sela, anmahni Council-in lo enkawl ve sela a ni ang chu.

Mi tīn hian anmahni tawnga vir an duh chuan kan hnial thei lo. Kan purview chhūngā mi a nih a, kan resolved tlat chuan kan tih tūr a ni dāwn a, Chaliha tih tūr a ni lo va, anmahni Lakher mipuite tih tūr a ni lo va, keimahni tih tur a ni ang.

Assam Sorkar pawhin lo ti thei dāwn pawh ni se, inbiak tlānnā a awm hmaa lo tih ngawt ai chuan kan member pawh hian a ngaihtiam ka ring a, Pu Chairman, a resolution hi lakir leh mai se, a lawmawm hlein ka hria.

CHAIRMAN : Tuna kan C.E.M. in a sawi dan chuan hetianga kan tih chuan harsatna tam tak kan tawk dāwn a. Chief Minister pawhin 'kan la ngaihtuah ang chu 'a ti bawk a. Chuvāngin withdraw mai se, a ti a nih chu.

P.L Region-ah anmahni tawng an phalna a rei tawh em em a, mahse tûn thlengin engmah a ni chuang lo.

Amaherawhchu CEM-in Council harsatna dân tûr te a sawi a, sorkar lam nêna inbiak hmasak a tûl a tih dâute a sawi bawk a, chung avang chuan min ngen-na anga he mi ka resolution withdraw leh chu ka hnial lo ve.

A resolution chiu a withdraw a nih chu.
