Daily-a a theih² loh pawhin Weekly talin Aizawl population zat hi a la tur niin ka hria. Chuti a nib loh chuan mi singhat dawa lai lo hmaih ringawt maite hi, heng zingah han misual tam tak pawh lo tel se, a hre biek lo tibna a ni a, a zabthlak hlein ka hria. Tunah hian mut hmu lovin a bud tawh pawh a ni aug, mahse a chet a titlai lutuk tawh a ni. Hemi thuah hian enquiry pawh High Court Judge hiau emaw siam ni sela, a tha ang. Mipui vantlang iahin tuteemaw huat blauh avangin engmiah an phunnawi ngam tawh lo, Donah chuan mi pakhat thah chu hrem theih a ni a. Mihring singhat dawa lai chaw ei tur lo chhut hmaih a, mipui heti zozai ril³ama thi mai thei tura min dah hi a fel lo blein ka hria.

Tin, Fair Price Shop pawh hi a tlem lutuk a, hmun thenkhatah phei chuan Card 1,000 te an kawi a, a buaithlak em em a. Chuvangin Vengtinah emaw, Card 300 lek lek emaw zelin awm thei sela thani ka hria. Fair Price Shop te pawh ka be nual a, a hlawkna a awm mang si lo va, a buaithlak e, an ti a. Hlawkna an duh ich ban⁴ mai sela, mi dang ti ter pawh an tam ang a. Hmanni ah pawh Fair Price Shop dealer pakhat chu ka zawt a, "A hlawk si lo va, ban mai a ni ka duh," a ti a. "A nib leh bang la, i ai ka awh ang e," ka ti a, a phat bawk si lo va. Chuvangin a hlawk bawk tih chu a hriat a ni. Chuvangin a tam thei angin tih ni sela, D.C. pawh nawr ni sela, thain ka hria.

Prime Minister pawh SOS Council in thawn mai sela, phai ramah phei chuan hetiang hi an ching ble. Kan ram chu buaina ram a ni, nimabsela,

kan ram buai avanga buaina siamtu te ni lo, India mi nih duhte hnenah pawh mi a ngaihtuah lo a nih chuan a dik lo nasa ang. Food Minister te pawh an tan lo kal a barsa lo va, a hmurah min rawn hmu ngei sela, ka duh a ni. An tan chuan helicopter te pawbin kal a barsa si lo.

Tin, convoy thuah bian sipa' thu thbu niawma sawinate a awm a. Kawng that lai pawhin Silchar leh Aizawl inkaran rei lutuk thangte a ni fo mai a. Heng thuah te pawh bian Joint Committee te hi awm thei sela, kan Chairman hian lo ngaihtuah se la, jml melhriatra leh inkawmneihna zawk pawh a ni ang a.

Ka hmaa sawituten kawng that tawk loh thu leh sorkarin min ngaihsak loh thu an sawi kha a dik em em a, Kawng chu barsa lo se, heti em em lutuk chu kan nih loh a beiseiawm.

Engzatnge thi? Ka hriat dan a dik chuan tun Inrinni khan Aizawl velah mi 10 tam vang in an thi a ni. Chaw neih loh vanga an thih chuan tunge mawh phur? Supply Department, supply hotu Head of District a ni.

Phai ram tuikianah chuan ni hnih/khat lek chhung pawhin kea an kal pejh loh pawhin helicopter talin an kan a. Tunah bian kan Commissioner pawh a lo kal niin kan hria a. Ka hmaa member sawi angin kan Chairman-in kawmna siam se, mi dinhmun a hriat theih nan, in benhatte pawh tiawh lawr se.

Tin, convoy te hi kal zing deuhvin, tih mu-mal deuh theih ni se. Vawiinah ngei pawh hian Alzawlah hian chi kg 1 Rs. 1/- a lei tur zawnngi i chhuak teh ang u, kan hmu loveng. Supply phurh nan chuan an in daih lo a nih pawhin Central-ah pawh motor tam zawk ngen mai rawh se; heti reng renga kumkhua ai chuan.

Pu Chairman, tuna hemi official resolution kan sawi lai hi nasa takin ka pui a, "Sawi hle h theih loh, khawpa chaw a harsat avangin a theih ang anga, sorkarin a rang thei ang a rawn ti turn District Councilin a ti," tih hi ka pui a.

Tun anga tam hi a la awm ngar lo a ni. 1960 man tam tam kha chu sorkarin a ngaihtuah avangin chuti takin kan tuar lo va. Tunah hi chuan kan ram buai avangin a harsa zual a, tunah hian mi tam tak in leh lo nei lo leh, eitur nei lo an tam tawh a. Chuvangin kan buaina hi a kal zel si chuan a mang-an thlak hle dawn a ni. Khawvel hmun dangah hetiang buhfai man tona hi a awm lo vang. Mi tam tak tan buhfate chu awm reng mahse, mirethei tam tak kan awm a, kan neihin a tlin lo va, Lam-khuangte, Anhnah nem te ria a lo ngai ta a; chumi tuar lo chuan, an sawi dān-in, mi sawm (10) vēl chu eitur nei lo va thi an awm tawh a ni.

Chanchin Bua kan hmuu dān-in Bawrh-sap chuan tunlai ei harsat avangin officer tam tak te nēn inkhawmna a ni.

neihpui a, chutah chuan nikum October thlaah mi 25,000 Aizawl awmin a sawi a, chumi hnuah 9,000 in belh lehin a sawi a. Mi an tam zel avangin Ration Card te pawh pēk belh zel niin a sawi a. Mahse supply stock lam erawh chu a tam chuang lo niin a lang. Chuvangin kan pung zel si a, kalkawngte pawh chhe lo mahse, supply lam a pun chuan si loh chuan kan tam tho tho dawn niin a lang.

Mahse, member te hnen atangin he mi, sawi hleib theih loh khhwpâ kan tlâkchham leh mangau thu hi an rawn nemnguet a, a hnjal lam pawh awm hauh lovin an rawn sawi a; pass ngei tur a ni tih kan hre bawk a, a lawmawm hle a Amaberawh chu memberte thu sawi tlangkawm pawh in tiem han sawi ve leh ka duh a.

Khawvelah hian kamding leh mipui kan inthen phawk a. Kamdingten an hna dik tak thawk se, mipui rawng an bawl tur a ni. Mahse, mipui rawng bawl aiin, 'Pu te' rawngbawl hi a awl niin ka hria. Hei, kan tam ta tak zet a ni ang, - chini thlengin kan tam. 26. 7. 68 vel Zirtawpni khan D. C in tam thuah meeting a ko va, thingpui hang kan in a. Ka thiante kha a thlum lo vek nge, ka no kha an lo tih hmaih palh nge ni, ka hre lo va, a thlum lo vin ka in a, cui ti takin ka in ve mai a.

Zirtawpniah office velab bian nawalh lei turin ka tir a, a awm lo va. Inrinni ah Bazarah bawm khat duliin kan bmu hram a, a to hle mai.

Kan memberten, "Thla'i te, theirah, lamkuuang, lakkhuithhei etc. te kan ring," an ti a. Chaw tha tak tak a ni a.
