Zoram chhiah chawi si lo, an blawh tam avanga professional tax pe chauh te, zoram: sunderwng, an sumdawn man chauh chawia Z.R.C. pe si lo te, enhish chavitirna tur a ni a. A Billah hian a pe awm leh awm lo te, a register dan te, a pe duh lo hrem dan te a chuang a.
