2. PU ZAIEMTHANGA, Minister LAMP & H to lay the following Rules on the Table of the House.
  - (a) The Mizoram Animal (Control and Taxation) Rules, 1982.
  - (b) Mizoram Town (Sanitation) Rules, 1980.
  - (c) Mizoram (Prevention and Control of Fire in the Village Ram) Rules, 1980.

RESOLUTION TO BE MOVED

4. PU H.RAMMAWI to move the following :-

"This Assembly is of the opinion that for the expeditious and more effective measures, the work of detection and deportation of the unauthorised foreigners from Mizoram which is now in the hands of the Army and BSF be entrusted to the Mizoram Police (MAPOMRP). Also, Mizoram Police Outposts be opened along the International Border at short intervals".

5. PU LAL THANHAWLA to move the following :-

"This Assembly resolves that new Division under the Public Works Department of Government of Mizoram be opened in Champhai Town within this financial year".

6. PU H.RAMMAWI to move the following :-

"This Assembly is of the opinion that Mizoram Board of Revenue be constituted with a view to formulating source of Revenue under the Government of Mizoram".

7. PU L ALNGHENGA to move the following :-

"This Assembly is of the opinion that it is high time to increase the remuneration and facilities of the Village Councils, and therefore resolves that -

- (1) Remuneration of the Village Council Members be enhanced.
- (2) Recurring grant be given to them in proportion to the size of the villages.

8. PU K.LALSANGA to move the following :-

"This Assembly resolve that a new Hall to be constructed by Government of Mizoram at Lunglei Venglei be named as 'SAIKUTI HALL'".

9. PU H.RAMMAWI to move the following :-

"This Assembly is of the opinion that the Government should constitute Foreigners Tribunal in each District detection of foreigners".

10. PU LAL THANHAWLA to move the following :-

"This Assembly resolves that construction of Champhai - Mibung Road be started by the P.W.D. of the Government of Mizoram during this financial year".

11. PU JOE NGURDAWLA to move the following :-
