Pu C. LALRINSANGA, MINISTER : Pu Speaker, member zahawm tak Dr. Vanlalthlana zawhna kha NLUP Implementing Board (NIB)-a thawk mekte hi an chungchang ngaihtuah kal zel a ni a. Tunah hian NIB exit protocol hi kalpui mek a ni a, eng emaw chen chu kan zo tawh a, planning sector lamah phei chuan kan zo titih tawh a. Amaherawhchu, behbawm eng eng emaw la awm/kaihhnawih la awm te hi kan la chhui kual mek a. Tuna zawhna bikah hian a hnathawkte hi, a sawi ang khan MIP atanga la chhawnun kal zel te pawh kha an awm hlawm a. Amaherawhchu, exit protocol hi a fulfillment, a tawp kharna awm phawt sela, chumi hnuah chuan a chhawr chhunzawm dan tur hi sorkarin ngaihtuahna uluk takin kan la hmang turah ngai ila, chumi ang chuan kan kalpui ang chu tih kha ka chhanna ni sela.

Dr. VANLALTHLANA : Pu Speaker, ka lawm e. 'Rights of Persons with Disabilities Act' hnuiah hian 3% hnaah reservation siam a ni a. Act hman a nih atang hian engzatnge advertise a nih tawh a, chumi atang chuan engzatnge hna pek a nih tawh tih Minister zahawm takin min chhan theih chuan.

SPEAKER : Zawhna neitu member zahawm tak Pu C.Lalsawivunga.

Pu C.LALSAWIVUNGA : Pu Speaker, ka hmaa zawhna nen khan a inang deuh thuak mai a. Mahse ka zawt tho ang a. Sorkar department hrang hrangah pianphunga rualbanlote tan seat engzat percent nge reserve sak an nih tih leh tun kum 3 chhung hian mi engzatnge sorkar a hna hmu tawh awm tih ka zawhbelhna a ni e.

Dr. K.BEICHHUA, MINISTER: Pu Speaker, member zahawm tak Pu Lalrinsanga Ralte zawhna kha Social Welfare hnuai, POSHAN Abhiyaan hnuiah hian District Co-ordinator 3 leh Project Assistant leh Block Co-ordinator leh Block Project Assistant te 1st January-ah khan advertisement chhuah a ni a.

Chu advertisement-ah chuan 'mandatorily from local candidates' tih a ni. Chutihlai chuan result hi 9th February-ah tihchhuah a ni a. Chuta tihchhuah chu common merit list anga tihchhuah a ni. Tin, Pu Speaker, he hna lak tur chungchang hi Minister hian ka hriatpui lova. Ka hriatloha thil kal a ni a. Chutah chuan common merit list-a mi 50 an tlanchhuah te kha Department

lamin an han enhian chuan central guideline-in mandatorily from local candidate tih a nih lai kha a tel tawh si lo a.

Chu chu ka hriatloh bawkin mandatorily from local candidates tih takah chuan a local candidate exam appear ho kha, kha merit list 54 zinga tello kha siamthat tumin hma lak a ni. Chu chu kei pawhin social media atangin ka hre chauh a. Ka hriat hnuah Department lam ka ko a, ‘Hei hi eng nge ni thil awmzia? Advertisement in chhuah dan leh in lak dan hi thil inmil lo a ni a. Tin, he thil hi hetianga a kal chuan thil diklo a ni. Ka hriat loha thil tih hrim hrim hi a dik tawh lova. A piah lamah kan tihsual tawh hnuah a vawi hnighna kan tihthat leh pawh hian mi in hriattir lova. Engpawh ni se interview hi cancel ni rawh se, Minister ka nihna angin he mawhphurhna hi ka mawhphurhna a ni dawn tlat a. Chuvang chuan kan tihsual lai hi a mawh ka lak tur a ni. Hei hi kan inbihchianna ni se a pawimawh hlein ka hria a. Tin, kha result chungchangah khan candidates te, written lo exam te leh interview tura kan koh te zawng zawng chungah he House kaltlang hian thupha ka chawi ni se.

Pu C.LALSAWIVUNGA : Pu Speaker, ka lawm e. SSA teacher tia kan sawi mai thin zirtirtute hlawh hi sorkar hian bat a nei em? A nei a nih chuan enge a chhan, thla engzatnge a bat, pek thuai tumna a awm em?

SPEAKER : Midang an la awm em? Chhang turin Minister zahawm tak sawm ang.

Pu LALCHHANDAMA RALTE, MINISTER : Pu Speaker, member zahawm tak Serlui bialtu Pu Lalrinsanga Ralte zawhna chhanna chu sorkar thar hian sorkar tantirh atangin heng Hindi teachers ban tak mi 1305 te rawih an nih leh theihna turin theihtawpin hma a la mek zel a, Hindi zirtirtu neilo school tam takah hian sorkar bul tantirh atangin theihtawpin hma kan la a. Kan House Leader zahawm tak kan Chief Minister Delhi feh chhuah tumin Union Home Minister-te a sawipui a. A sawipui nachhan ber pawh Home Minister Pu Rajnath Singh, Mizoram a lo kal khan he harsatna hi sorkar khan a thlen a, amah pawhin Delhi tlangah lo enzui a, theihtawpa hma lak a nih tur thu commitment a pek avangin kan House Leader hian theihpatawp chhuahin a umzui a.

Tin, Higher & Technical Education Minister Dr.R. Lalhangliana pawhin Delhi-ah kal hian HRD Minister-te sawipuiin theihtawpin Hindi Teachers rawih nawn a nih theihna turin hmalakna a kalpui a. Tin, kan officials te, kan Commissioner leh a thawhpuite pawhin theihpatawp document pawimawh tur leh an zawhna awm tur zawng zawnge thehthlain theihpatawp a zuk chhuah a, keipawh a changtu ka nih ang ngeiin N. Delhi-ah ka zuk kalin Ministry-ah rawih nawn an nih leh theihna turin theihpatawp ka chhuah a, officials te ka sawipui a. Amaherawhchu, HRD Minister hmu tura kan dar intiamah khan hmannya Pakistan leh India harsatna awm avanga emergency cabinet an neih tak avangin HRD Minister nen kan sawi dun theih tak loh avangin kan hawn hnuah, thlen veleh D.O. letter siamin HRD Minister hnenah pawh kan harsatna hi ka thlen a. Chutiang chuan theihpatawp sorkar hian Hindi zirtirtu ban takte lak an nih leh theihna turin hma kan la a ni tih ka sawi duh a.

chu 1305 ban takte kha kum 1 zet zawt an lo ni tawh a. An zingah khan a then lo boral tawhte leh eizawnna dang lo zawh ta te pawh kha an awm a. Tin, April ni 1 atang hian RTE Act kan hman chhoh turah zirtirtu class room lut tur reng renge hi trained an ni tur a ni tih a nih tawh tak avangin 1305 te kha la dawn ngawt ila, untrained an tam avangin a dik ngawt thei lova, Dan anga lak tur kan hmu a nih pawhin qualified te an luh theihna turin sorkar-in hma a la ang tih kha ka chhanna a ni.

Tin, member zahawm tak Aizawl South I bialtu Pu C. Lalsawivunga zawhna chhanna SSA teachers hlawh bat kan nei em? Bat ni ta se engzat nge? Engtikah nge pek theih a ni ang tih kha, helai hi kan sorkar achievement ve ah pawh kan sawi a ni a. Kan House Leader zahawm tak hova bul kan tan tirh atanga ni 4/5-naah khan sorkar hmasain thla 3 chhung hlawh a lo bat kha he sorkar thar hian a pe nghal a ni.

Tin, chumi bakah chuan tunah pawh hian SSA zirtirtu hlawh bat kan neih loh piah lamah March thla hlawh tur thleng hian kan nei lawk vek a, kan House Leader hian hnathawktute hian hlawh an hmu ngei tur a ni tih principle-a min kalpui avangin central lam atanga hlawh tur min pek hma pawh hian state sum atangin kan lo hmang puk lawk a, hlawh ba kan nei lo ve.

SPEAKER : A chiang hle mai. Starred Question No. 21-na zawt turin member zahawm tak Dr. Vanlaltanpuia i lo sawm ang.

Dr. VANLALTANPUIA : Pu Speaker, ka lawm e. PWD changtu Chief Minister zahawm tak chhan atan ka zawhna chu:

Pu ZORAMTHANGA, CHIEF MINISTER : Pu Speaker, member zahawm tak Dr. Vanlaltanpuia chhanna chu:

SPEAKER : Pu Lawmawma Tochhawng i lo sawm ang.

Pu LAWMAWMA TOCHHAWNG : Pu Speaker, ka zawhbelhna chu hei hi a ni. Lunglei bypass road siam tumna hi a awm em? Awm se engtika tan tur nge? Aizawl-Lunglei kawngpui repair mek hi engtika zawh tura ruahman nge a nih? Pawisa cheng engzatnge ruahman a nih?

SPEAKER : Pu Biakzaua i ko ang.

Pu H. BIAKZAU : Pu Speaker, ka lawm e. BRTF road to Lungtian hi GSR ventures Hyderabad amiten an thawk a, cell filled concrete-a tih a ni a. Mahse vanduaithlak takin nikum hmasa khan an bansan tlat mai a, an deposit-te pawh an chan a ni awm e. Hei hi engtik hunah nge re-tender a nih leh theih ang tih ka zawhna 1-na a ni a. Tin, hemi kawng vekah hian Lungtian to Mamte road-ah hian Kolodyne river a cross avangin marboat hman ngai a ni a, PWD-in a neih loh avangin harsatna tam tak a awm thin a, tunhma atangin marboat awmlo hrim hrim a ni a. Motor kawng sorkarin a lai a, MNF sorkar hmasak laia resolution siama an lo passed a laih tawh kha a ni a, marboat dah theih a ni ang em tih ka zawh belh a. Tin, a pathumna ah chuan Hrangchalkawn to Lawngtlai kawng hi a chhe khawp mai a, hei hi repair tumna a awm em tih a ni e. Ka lawm e.

SPEAKER : A tawp nan zawhna neutu kan sawm ang a, a chhan chu No. 23-na hi a awm tho a, Pu Duha leh Pu L. Thangmawia kha tahkhan lo inring teh u. Dan kan siam angin kal phawt ang.

(*Speaker : I zawhnaah khan lut deuh zel ula*) Pu Speaker, helai hi tawi tein sawi ka duh a. Ka zawhna lai kawng hi Mizoram mapah hian a lai taka awm a ni a, Zote leh Chhipphir inkar hi. Tin, Mizo history-ah hian Sailo lal te lo in base-na hmunpui a lo ni a. Chhipphir khua hi a bik takin kum 200 lawm tawh khua an ni a. Tin, Mary Winchester la chhuaktu Bengkhuai te ho zawng zawng thlahtute lo awmna hmun a ni a. Amaherawhchu khilai kawng khi hlamchhiah a ni viau a, a thlang lamah highway, state highway ATL road-te a kal tawh avangin khilai kawng khi vawikhatmah leilung piantirh ata black topping a la ni

lova. Tin, khi kawng khi rin aiin siam chhung a rei ta riau mai a, tuna kan target of completion kha chu a changtu in a rawn sawi tak ang khan 5.12.2019 a ni a. Khilaiah khian contractor a thawktu nikumah a thih avangin tunah khian Pu Lalzawna'n 31st Jan, 2019 atangin a thawk a.

Amaherawhchu, he kawng hi kuminah hian peih hman a ni dawn loin a lang a. Sawi angin hemi hun chhungah hian kan peih hman dawn tlat lo niin a lang a. Chuvang chuan Pu Speaker, hei hi khawngaih takin engtin emaw, mi tam zawk ten emaw sorkar atanga hmanraw tha zawkte nen emaw rang deuha min tihsak theih chuan tih hi vawiina ka zawh duh a nia, chu chu min tihsak thei ang em tih a ni a. Tin, a dawt lehah chuan Pu Speaker, ATL road hi Mizoram kawngah hian Lunglei via Thenzawl road hi Mizoram kawnga a pawimawh ber zing ami a ni a. Chhim leh hmar kan inkalpawhna te; tin, district hrang hrang Siaha District te, Lawngtlai District te leh khawthlang lam zawng zawngin kan rin kawng a ni a.

Amaherawhchu, sorkar liam ta kum 10 chhung khan resurfacing mumal tih a ni lova. Tin, a bik takin nikum March thla vel kha chuan Lunglei thalaite leh sorkarte pawh an inepna kha helai ATL Road-ah hian a ni a. Tlawng atanga Pukpui inkar te phei chu bottleneck angin siam a ni a, a laiah a ring rekin buaithlak takin, kal hleihtheih lohvin a awm a. Chutiang chuan concrete kawngte kha kan siam a, mahse vawiinah chuan a khi chhe leh deuh vek tawh a. Chief Minister zahawm tak khan pawisa chu min pe teuh a, amaherawhchu, tunah hian hot mix plant kan tih te, paver tha te a awm lova. Pu ZORAMTHANGA, CHIEF MINISTER : Pu Speaker, member zahawm takte zawhbelhna kha :
