**Dr. ZR. THIAMSANGA :** Pu Speaker, ka lawm e. Minister zahawm tak AH & Vety Department changtu chhan atan ka zawhna chu:

Champhai Milk Processing Plant function tawh lo hi tihnun leh tumna a awm em tih a ni.

**SPEAKER :** Chhang turin a changtu Minister zahawm tak Dr. K. Beichhua i lo sawm ang.

**Dr. K. BEICHHUA, MINISTER :** Starred Question No. 38-na Dr. ZR. Thiamsanga zawhna chhanna chu hei hi a ni :

“Champhai Milk Processing Plant function tawh lo hi a kalphung tidanglam hreta tihnun leh tuma hma lak mek a ni. Tin, he kalphung tihdanglam dan tur hi ka han hrilh nghal mai ang a, Pu Speaker, i remtihna in. National Programme on Dairy Development hnuiah Champhai Dairy Plant siamthatna turin DPR hi ni 26.2.2019 khan Ministry of Agriculture & Farmers Welfare, Department of AH & Vety-a thehluh a ni a, tihhawhtlin a nih theih nan theihtawpin kan bawhzui bawk a. Hei hi a hlawhtlin theih chuan Champhai ah khian bawngnute hi process emaw pasteurise emaw a ni tawh lo ang a, Chilling Plant din kan tum a ni. Chu Chilling Plant chu kan din hlawhtlin theih chuan Champhai a bawngnute kan neih ang ang te khi Champhai atangin Aizawl-ah kan rawn phur thla ang, a chilled in; chu chu helaiah MULCO atangin kan lo process ang a, a tul angin Champhai leh hmun dang ei turin kan sem chhuak leh dawn a ni tih kha ka chhanna a ni e.

**SPEAKER :** Zawhbelhna, member zahawm tak Pu C. Lalmuanpuia.

**Pu C. LALMUANPUIA :** Pu Speaker, ka lawm e. Bawngnute nena inkaihhnawih deuh tho Aizawl khawpui chhung thil zawhbelh tur ka nei a. Slaughter House chungchangah-Mualpuia kan Slaughter House

khu a lun hle a, an indaihlo hle mai a. Helai chungchangah hian Aizawl New Market bik tan te emaw Slaughter House hi siam belh tumna a awm em tih kha Pu Speaker, ka zawhbelh a ni e.

**SPEAKER :** Zawhbelhna, Pu H. Biakzaua.

**Pu H. BIAKZAUA :** Pu Speaker, ka lawm e. Ka zawhbelhna chu hei hi a ni - "Mampui Vety Farm-a vawk awm te'n PRRS an vei vek nia sawi hi a dik em ? Dik ni se engtia hmalak tur nge?

Tin, ar note keuna tur ruahmanna siam niin hriat a ni a, ar note keutir a ni tawh em tih ka zawhbelh e.

**SPEAKER :** Zawhna neitu kha a phar em ? Aw, Dr. ZR Thiamsanga.

**Dr. ZR. THIAMSANGA :** "Pu Speaker, ka lawm e. Champhai Milk Processing Plant khi kum 2007-2008 chhung khan ₹ 280 lakhs chuang zeta ruahmanna siam kha a ni a. Tichuan, kum hnih khat kha chu tha takin an kal chho a, amaherawhchu, kum hnih khat an kal khan a khawlte kha a chhiat tak avang khan chhunzawm theih a ni ta lova. Tichuan, a production milk erawh chu duh aia tam hrалh chhuah tur, process tur kha an dawng a ni. Amaherawhchu, chutih rual chuan electric bill-te, tui bill-te a lo tam a, an duh aia tam hrалh chhuah tur an hmuh avang khan an kalpui thei ta lo a ni. Chuvang chuan, khitiang khian mi tam takin eizawn nana an hman kha tunah khian a lo chhe ta a. Amaherawhchu, kan sorkarin mumal taka process that lehna tura ruahmanna an siam kha a lawmawm khawpin ka hria a ni. Ka zawhbelh duh chu - (Champhai khi a bik takin) Mizote hi sa ngaina tak mai kan ni a, kan sa ei duh ber chu vawksa a ni a. Champhai atang khian vawksa leh vawk note pawh tam tak kan lakna hmun a ni a. Tichuan, PRRS natna ang chi venna tur ang chi-ah hian hmalakna a awm em tih ka zawt tel duh a. Tin, chu lovah chuan sa thianghlimlo, kan ei tur laka invenna atan hian kan sorkarin ruahmannate a siam em tih ka zawt duh bawk a. Chu baka ka zawh duh chu bawngnute kan lo process a nih pawhin a thau tam lutuk 'fats' kan tih, cholesterol tam lutuk hi mihring tan a tha lo va.

Chu mai ni lovin lung lam natna te pawh zawi zavia rawn thlen thei a nih avangin ram dangin a thau an paih vei theihna ang chi 'Skimmed

Milk' ang te pawh hian tih theih dan a awm ang em? Tuna kan MULCO-te pawh hi kan hmang tangkaia a that rual rualin fats hi a la tam niin a lang a. Chuvang chuan hetiang ruahmannu hi kan sorkar chak tak hian a rawn ruahman thei ang em tih kha ka zawt belh duh bawk a ni. Ka lawm e, Pu Speaker.

**SPEAKER :** Champhai atangin Aizawl, Lawnglai; a inkarkik khawp mai. A chhan theih ang ang chhang turin a changtu Minister zahawm tak Dr. K. Beichhua i lo sawm ang.

**Dr. K. BEICHHUA, MINISTER :** "Pu Speaker, an zawnate kha a tha viau a, chhan hram hram ka tum ang a.

Member zahawm tak Pu Muanpuia zawnate - Aizawl New Market Slaughter House nei tur hian tul kan ti hle a, tuna Mualpui kan neih khu kan indaihlo viau a ni. Chuvang chuan sorkar lam atang pawh hian tul kan ti a, hmalak kan tum chho dawn nia tiin chhang ila a tha awm e.

Tin, member zahawm tak Pu Biakzaua zawnate kha – Mampui hi keimah ngei a hmunah ka va kal a, tuna vawk kan neih ang ang saw chu PRRS kai vek tawh an ni. Chuvang chuan a no neihtir leh tur chuan an fit lova, sawngho saw dispose vek kan tum a ni. Tin, dispose an nih hnuah sawlaia a hmun saw sterilize vek a, natna a awm tawh lo tih kan prove hnuah a danga thlak sorkarin a tum a ni.

Tin, ar note keuna tur tuna kan neih saw hman theih a ni a, kan incubator pawh saw tlema repair hleka hman theih tur a ni tih kha ka chhanna ni se.

Member zahawm tak Dr. Thiamsanga zawnate - PRRS hi kan hre theuh a. Kan ramah vawk natna chhim tawp/hmar tawp tlengin a leng a, hei hi kan buaipui viau a ni. A chhan ber chu vawk mass movement a awm a, dry season-ah hian he natna hi nasa takin a leng thin a ni. Chuvangin, sorkar hian January thla tir lam atang khan ram pawn atanga vawk lakluh kha kan khap ta a, tunah hian kan phak ang tawk chuan kan bawhzui zel a. Chutiang chuan PRRS hi tun dinhmun ah hi chuan a leng tih report kan la dawng lo va.

Chumi piah lamah Champhai Ruantlang-ah khian tunah hian a thara hma lak mek a ni a. Ran kan lak luh a thianghlim leh thianghlim loh lo test vek turin tunah khian hmalakna kan tan mek bawk a ni tih kha ka chhanna ni se. Chu lo ah chuan tuna bawngtnute a bikin MULCO-a fat tam lutuk a rawn tih kha, ni e, tuna MULCO-a bawngtnute kan sawngbawl ang chi te te ho hi FFAI an ti a, chumi hnuaiah chuan fat hi chi thumin an then ta a. Not less than 3% kan tih ang chi a siam tur te. Tin, TNF an ti a, Solid Not Fat tih a ni a. Chutah chuan not less than 8.5% tih a ni. Chumi piahlamah a fun sen te hi chu 1.5% lek fat a awm a ni. Chung avang chuan thisen sang nei an ni emaw, blood cholesterol nei sang deuh te kan nih chuan tuna MULCO a kan bawngtnute neih, a funna sen te hi lei theuh ila tih kan in chhanna ni se. Pu Speaker, an zawhna kha ka chhang fel em aw?

**SPEAKER :** Starred Question No. 39-na zawt turin member zahawm tak Pu Vanlalhlana i lo sawm ang.

**Pu VANLALHLANA :** Pu Speaker, Starred Question 39-na Agriculture changtu Minister chhan atan a ka zawhna chu: NLUP dawng tur thlan tawh chhungkua pawisa la dawng lo engzat nge awm? Pek an ni dawn em?

**SPEAKER :** Chhang turin a changtu Minister zahawm tak Pu C. Lalrinsanga i lo sawm ang.

**Pu C. LALRINSANGA, MINISTER :** Pu Speaker, ka lawm e. Member zahawm tak Pu Vanlalhlana, Aizawl North-I zawhna chhanna chu: NLUP dawng tur thlan tawh chhungkua pawisa la dawng lo zat chu chhungkua 2794 an ni. Hei hi Department hrang hrang 10 chuangte lak khawm kha an ni a. Tichuan, heng chhungkua 2794 te hi NLUP tanpuina pek an nih dawn leh dawn loh ngaihtuah mek a ni.

**SPEAKER :** Member zahawm tak Pu Zodintluanga zawhbelhna zawt turin i lo sawm ang.

**Pu ZODINTLUANGA RALTE :** Pu Speaker, zawhbelhna :

NLUP dawng tawh account-a pawisa lut, sorkarin an tihtawp a, an lak let leh tir, an pek let tir kha eng tikah nge pek leh an nih ang tih a ni a. Pahnihna ah chuan SEDP hnuiah khan NLUP dawng tawh te pawh nuai thum theuh dawng tura Zoram mipuiah khan sawi a ni a. Vawiinah NLUP pawisa dawng tawhte pawh lak let a nih chuan nuai thum hi Zoram mipuite hian kan dawng lo mai dawn em ni tih hi ka zaghna a ni e.

**SPEAKER :** Zaghna neitu Pu Vanlalhlana.

**Pu VANLALHLANA :** NLUP dawng lo hi 2794 an awm a, a dawng tawh hi engzat nge tih kha kan zaghna pakhat chu a ni a. Tin, a dawt leh ah chuan khang a dawng tawhte pawh khan first instalment a tlangpuiin ₹ 50,000/- an dawng a. Second instalment hi dawng leh tura ngaih an ni a. Kan lo hriat danin NLUP Policy hi tihtawp a ni tawh bawk si a, an sem chhunzawm dawn em, second instalment te kha? Tin, a la dawng lo 2974 te hi an dawn theih dan ngaihtuah theih a ni em?

**SPEAKER :** Theih ang ang chhang turin Minister zahawm tak i lo sawm ang.

**Pu C. LALRINSANGA, MINISTER :** Pu Speaker, member zahawm tak Pu Zodintluanga zaghna account-a thun luh tawh hote hi eng angin nge tih lai kha account-a thun luh eng emaw zat chu awm awm a ni a.

Engpawnise, khang ho kha inthlan puan a nih chhoh tawh avang leh a dawng tur ho pawh kha account-a thun luh tura account neite enfelsak hun leh account neilo ho, khangte nena enchain sakna hun eng emaw chen hman a nih avangin heng ho ruahmannha hi inthlan puan kha a nih chhoh tak mai bawk si avangin model code of conduct khan a bar tak si avangin ngaihtuah chhunzawm theih a ni ta lova. Engpawnise, khang ho kha sorkar thar a ni a, (Pu ZODINTLUANGA : Pawisa dawng tawh a ni kan rawn sawi chu, khang ho kha an account-a lut tawh ho tuna sorkar thar in an lo tihtawp hi engtikah nge pek an nih dawn tih kha a ni). A lut tawh ho kha chu tuna ka sawi ang khan sorkar tharah

SEDP anga kal chhoh pui tum a ni tawh a. Chuvangin, SEDP Apex Body lo la awm turin a la ngaihtuah chhunzawm ang.

Tin, zawhna neitu Pu Vanlalhlana zawhna dawng tawh zat hi chuti maiin ka lo chhut lova, ka hrilh mai thei lova. Amaherawhchu, kha kha chu inhrilh leh harsa lo turah ngai ta ila. Tin, sem chhunzawm tur a ni em tih kha chu tuna kan sawi ang deuh khan exit protocol process kalpui chhoh a ni a. Ni 13 khan eng emaw a behbawm te te la ngaihtuah fel loh te ngaihtuah turin Chief Secretary hoin that khawm lehna neih a ni a. Chungah chuan uluk takin ruahmanna te pawh an nei chho a.

A leh lamah chuan tuna member zahawm takten an zawh hi NLUP, NEDP convergent bik a nih avangin a tlangpuiin heng dawng tura select te hi mi thar, a hnukhawi la dawng lote an ni tlangpui a. A lehlam takah chuan SEDP hi han kalpui ta ila anni ho hi a tlar hmasaa kan dah turte tho kha niin a lang a. Engpawhnise, helai hi chu SEDP Apex Body la piang chho tur hian uluk taka thlir dan a neih thiam beisei ta ila a tha ang e. Kha kha Pu Speaker, ka chhan theih dan chin chu a ni mai a.

Member zahawm tak Pu Zodintluanga rawn zawh belh lehna nuai thum chungchang kha chu tuna ka sawi ang khan SEDP Apex Body te a lo piang chho ang a, heng ruahmanna lo kal tawhte ang hi chu a tul angin hruaitu tharin a la en chho mai ang chu.

**SPEAKER :** House Leader-in sawifiah ngai i ti em? Sawifiah tur a awm chuan rawn sawi se.

**Pu ZORAMTHANGA, CHIEF MINISTER :** Pu Speaker, NLUP process hi kan hre hlawm a, a dawn pawh kan dawng tam a, la dawng lo pawh kan awm a. Amaherawhchu, a system hi tha kan ti lova. Pawisa sem ngawtah a kal a, project nen a in connect na hi kan duhthu a sam lova. Chuvangin, project connected SEDP kalpui kan tum avangin tun ami hi chu a dawng tawh chu dawng tawh an ni mai a. A bak hi chu NLUP ang chuan kalpui kan tum tawh lova, chumi aiah exit protocol kan ti zawk a, SEDP angin kalpui kan tum zawk a ni.

**Pu ZODINTLUANGA RALTE** : ‘A dawng tawh chu a dawng tawh an ni’ tih lai kha a dawng tawhho account-a lut tawh kha a rin tlang nghal mai theih tihna em ni, tuna a statement kha?

**SPEAKER** : Minister-in a sawi chiang tawh khawp, khalai kha chu.

**Pu ZORAMTHANGA, CHIEF MINISTER** : An account-a a luh tawh na na na chuan kan chhuhsak lo ang, an nei ang.

**SPEAKER** : A lawmawm e. Starred Question No. 40-naah kan kal ang a, member zahawm tak Pu Vanlaltanpuia zawt turin i lo sawm ang.

**Dr. VANLALTANPUIA** : Pu Speaker, ka lawm e. Land Resources, Soil & Water Conservation Department changtu Miniter zahawm tak ka zawhna chu: Lunglei North Constituecy huam chhunga Haulawng-a Soil & Water Conservation Department office leh a hmunhma rauhsan vek a ni hi eng vang nge? tih a ni.

**SPEAKER** : Chhang turin a changtu Minister zahawm tak Pu R.Lalzirliana i lo sawm ang.

**Pu R.LALZIRLIANA, MINISTER** : Pu Speaker, member zahawm tak Pu Vanlaltanpuia zawhna chhanna chu : ‘Haulawng-a Soil & Water Conservation Department office leh hmunhma hi rauhsan a ni lova, building pawh tha takin a la dingin luah mek a ni.

**SPEAKER** : Zawhna neitu Pu Vanlaltanpuia.

**Dr. VANLALTANPUIA** : Pu Speaker, ka lawm e. Ka zawhbelhna chu He office leh a hmunhma hi kan han tlawh thuak thuak a, rauhsan ang maiin a awm a. Tunah hian building pathum vel niin ka hria a. Sorkar hian establishment to tak takin kan siam a; tin, sorkar hnathawkte pawh mipui leh ram tana thawk turin kan inbuatsaih a. Amaherawhchu, hlawh atan tam tak kan hmang a, he office hi mumala run a ni loin ka hria a, pawi ka ti hle a. Hei hi mumal deuhin hma min lak chhunzawm sak thei ang em tih ka zawt e.

**Pu C.LALSAWIVUNGA** : Pu Speaker, ka lawm e.

**Pu LALRINTLUANGA SAILO :** Pu Speaker, ka lawm e. Land Resources, Soil & Water Conservation Department, Aizawl Republic venga an building leh godown chhe lutuk, khawpui hmel tibaltu khu cheibawl that tumna a awm em tih ka zawt e.

**SPEAKER :** A theih ang ang chhang turin Minister zahawm tak Pu R.Lalzirliana i lo sawm ang.

**Pu R.LALZIRLIANA, MINISTER :** Pu Speaker, Pu C. Lalsawivunga zaghna kha chu ka subject a ni lo mai awm mang e aw ka ti a, Minor Irrigation lam nge ni Agriculture lam, keimahni lam a nih pawhin ka chhang thei lo kha kha chu; kan subject a ang lo deuhin ka hria.

Pu Lalrintluanga Sailo zaghna Republic Venga an building leh godown chhe lutuk chei that tumna a awm em tih kha, kan hotute'n pawisa min pek dan a zirin hei chu en theih a ni ang a. Tin, zaghna neitu zagh kha rauhsan ang mai tih leh rauhsan tih kha chu a dang deuhin ka hria a. Kan Department hi thenkhat chuan 'Dying Department' thi mek tiin ministry hmasa zawkah kha chuan an sawi a. Amaherawhchu tun ministry-ah hian kan Chief Minister zahawm tak hian Land Resources, Soil & Water Conservation hi a pawimawh zia a rawn hmuchhuak hlein ka hria a. Chuvangin theihtawpa (engineer pawh hi pakhat chiah kan nei a) hma la tak tak tur chuan eng emaw heng kan indaihlohnate hi hnawh khah vek a ngai dawn a. Chutiang a nih loh chuan sawlai Haulawng ami chauh pawh ni lo, hetiang deuh hi tam tak a awm a ni. Chuvang chuan a zawttu rawn zaghna kha a dikna chen a awm thoin ka

**Pu K.LALRINLIANA, MINISTER :** Pu Speaker, ka lawm e. Member zahawm tak Pu Vanlalthlana zaghna chhanna chu :

- a) Sorkarin a hriatpui lo tih a ni a. Amaherawhchu anmahni inkarah inremsiamna chu an lo nei deuh mai thei a ni. Chutiang bawr vel chu thil kalphung a awm a ni, veng Local Council-te leh distributor te inkarah.
- b) Sorkarin a hriatpui lo tih kha a hmasaa kan chhanna nen khan a inang deuh mai turah min ngaihsak mai ula.

- c) Sorkar-in mipui tana awlsam zawk leh remchang zawk ni a a ngaih avangin tuna gas sem dan, Common Delivery Point hi distributor ten an kalpui a ni. Hei hi ka han chhan theihna a ni a. Home delivery hi hmun thenkhat tan chuan a harsa em em mai a, chuvang chuan Minister han chan hnuah pawh kan han sawiho a, ‘Enge kan theih loh chhan?’ ka ti a.

**SPEAKER :** Opposition Group Leader i sawm tawh ang aw, Pu Lalduhoma.

**Pu LALDUHOMA :** Pu Speaker, foreigner issue hi hnam anga thlir chuan kan problem lian ber pakhatna ti ta ila a tih theihin ka ring a. Eng vang nge he harsatna hi kan tawh kan tih chuan District Council hun atang tawh khan kan politician-te vang a ni. Dan leh hraia chiang em em; chumi palzut chuan an vote itna vang leh lamtanga siam duhna avangin District Council hun atang khan politician te ngeiin foreigner ni ngawih
