Chuvangin, High Court rawn lo chuan engemaw thil dangahte hian Sorkarin kan ti tawh lo reng reng a ni a, Sorkar hian thil tha leh pawimawh hi chu a tul chuan kan hmachhawn a, kan titawp mai zel a ni a.
