

11. Administrative reforms, good governance, development of IT infrastructure for e-governance, development of citizen charters, financial reforms will continue to receive our attention. In order to maintain the cost of governance within sustainable limits, stringent economy measures will continue till pressures on State's finance are over. In the meantime, my Government will continue to improve the administration of finances of the State. The State will also try its best to obtain a favourable recommendation from the 12th Finance Commission.

I am confident that your collective endeavour and collective wisdom will continue to provide not only a strong and befitting initiative, but also unflinching guidance to the endeavours of my Government towards achievement of lasting peace and prosperity for all sections of people of Mizoram. On this occasion, I also earnestly appeal to you to work hand in hand with unity and goodwill in our march forward for the development of Mizoram.
13. In conclusion, I convey my heartiest felicitations to you and to the people of Mizoram. May your deliberations in this august House be fruitful and far-reaching.
