PU R. LALZIRLIANA

Mr. Speaker Sir, thank you. Will the hon'ble Minister incharge Agriculture Department be pleased to state -

- (a) Whether there is proposal to make Mizoram into an 'Organic State'.
- (b) If so, when.

- (c) If so, is there proposal to stop the purchase of fertilizer, pesticides insecticides and weedicides?
- (d) If so, has that intention been reflected in the Budget?

SPEAKER

Pu H. Rammawi.

PU H. RAMMAWI MINISTER Mr. Speaker Sir, the answer to Starred Question no. 1 are as below -

- (a) The Government intends to make Mizoram into an 'Organic State'.
- (b) Rapid steps have been taken to make Mizoram into an Organic State and it is expected to be declared soon.
- (c) There are certain fertilizers, pesticides, insecticides and weedecides that can be used for organic farming. The department will continue to purchase these types.
- (d) As that is the case, it has not been reflected in the Budget.

PU R. LALZIRLIANA

Mr. Speaker Sir, recently, the agriculture society at Champhai were instructed by the Agriculture Department to stop selling fertilizers like MOP and DAP

that are used in WRC. The farmers became dismay for without the use of these fertilizers the quantity of production would decrease. In this case, I would like to challenge the department whether a substitute for these fertilizers could be supplied to the farmers.

Secondly, on June 22, fertilizers was issued to some farmers from Sihphir. It has been said that this is for the celebration of the victory of the concerned MLA in the Election. But, fertilizers was given only to MNF members. How is the Minister reacted to this?

It is a matter of appreciation that the hon'ble Chief Minister aims to achieve self - sufficiency in the production of foodgrains. However, can we achieve this aim if only the MNF families which consist of only 30% of the total population become self - sufficienct?

PU LALHMINGTHANGA: Mr. Speaker Sir, I appreciate that the government

intends to declare Mizoram into an organic state. However, I would like to ask the Minister what policy does the government have in regards to the manufacture of organic fertilizer.

PU H. LIANSAILOVA

Mr. Speaker Sir, I would like to ask the measure taken by the government for the successful implementation of this programme. I would further like to ask which state's have already adopted organic farming.

PU SAIKAPTHIANGA

Mr. Speaker Sir, the Agriculture Department has been distributing paddy seeds to WRC farmers. Is this distribution meant only for farmers? If the list of

beneficiaries with the quantity received is produced, can the Minister concerned take action?

PU ANDREW LALHERLIANA: Mr. Speaker Sir, as written by the Experts, declaring the whole state for organic farming will appar ently fail. With this view, I would like to ask whether experts are consulted before taking up this matter?

PU H. RAMMAWI MINISTER

Mr. Speaker Sir, I will start answering from the question raised by Pu R. Lalzirliana. Agriculture Department has stopped procuring fertilizers but it has been learnt that the farmers association of Champhai had pro-

cured DAP on its own. Prohibition order has not yet been made though our intention is already publicised. We are observing public reaction. It is the policy of the government to start organic farming an area wise through certifying agency. Anyhow, the department instructs the society to use DAP on WRC alone and not for other cultivations.

As regards to Sihphir, we received reaction from the people of that area as they preferred DAP for their squash plantation. If the use of DAP is stopped, their plantation would certainly suffer as the department cannot provide suitable alternative for now. Therefore, squash planters are strictly instructed to use the fertilizers issued only to them. The matter was discussed with the association from Sihphir and fertilizers was also issued to the association and not as party members.

Regarding the question raised by Pu Lalhmingthanga, the government plans to entertain private enterprise for organic fertilizing plant.

In the case of the question raised by Pu Liansailova, the government plans to start organic farming area wise through certifying agency.

As for the case mentioned by Pu Saikapthianga, it would be appreciated if the list could be handed over to me so that I can check the matter.

Thoughout the States of India, chemical fertilizers has been widely used unlike Mizoram. In an organic farming, fertilizer will not be totally ignored but the main object in an organic farming is to remove the use of chemical. There are chemicals in fertilizers like DAP, UREA and MOP while there are harmless fertilizers

like organic manure, green manure and bio-fertilizer. According to experts, 40% of plantation area in the world is destroyed by chemical fertilizer.

There are several alternatives for chemical fertilizers. The Government of India has made National programme for organic production programme for organic production programme and a handbook for organic farming is also made. It is our intention to show other Indian States that there are good alternative for chemical fertilizers. China has followed organic farming and the production per hectare becomes 50 quintals whereas in India it is only 20 quintals. This has apparently shows that there are better alternatives.

Lastly, to show my appreciation to Pu Lalzirliana for his awareness which makes opportunity to discuss organic farming, I would like to present him a handbook called 'National Programme for organic production'.

PU SAIKAPTHIANGA :

Mr. Speaker Sir, if the list is produced can the

hon'ble Minister take action?

PU LALHMINGTHANGA:

Mr. Speaker Sir, I ask Starred Question No. 2 -

- (a) Is Village Development Committee set up in each village?
- (b) What are the required qualification for VDC Member?
- (c) Is Block Development Committee set up in each Block?

SPEAKER

Let us now call upon Pu Aichhinga Minister of Rural

Development.

PU AICHHINGA MINISTER Mr. Speaker Sir, order has been issued to set up Village Development Committee in each village. However,

the report has not been received so far.

- (a) As per government notification No. (b)11016/30/90 IRD dt. 16.6.2004 the Deputy Commissioners set up VDC in each district in consultation with the SDO.
- (b) And the BDO concerned shall constitute VDC. The qualifications required for VDC Member are (i) 1 Member from Village Council (ii) 1 Member from each recognised Political Party (iii) 1 Member each from NGOs like YMA, MHIP and MUP (iv) 3 prominent citizens. The Chairman, Treasure and Secretary shall be appointed by the Deputy Commissioner.
- (c) Block Development Committee has not been set up in each Block though order has already been issued for the same.

PU H. ROHLUNA

•

Mr. Speaker Sir, regarding the appointment of the Chairman of the VDC, why doesn't the government accept the Village Council President as the Chairman of the VDC?

I would further like to ask if the concerned MLAs are spontaneously became member of the Block Development Committee of their constituency.

PU LALHMINGTHANGA:

Mr. Speaker Sir, a supplementary question please. First, I would like to request the hon'ble Minister to provide the copy of the government notification order to the members.

Secondly, what is the main function of the VDC? Is there an intention to make the VDC as an implementation agency for the development programmes to be undertaken in rural areas.

Regarding the composition of the members of the VDC, the Deputy Commissioner is entrusted to appoint Chairman, Secretary and Treasurer. But, there could be political control. Hence, it may be suggested that the appointed member elect the Chairman, Secretary and Treasurer among themselves.

As mentioned by Pu H. Rohluna, if the concerned MLAs are not directly the members of the VDC, it may be requested that they be included in the Committee.

I would further like to ask the hon'ble Minister to provide the formation order of the VDC to the members so that we may have better look into the composition of the Committee.

PU S. HIATO

Mr. Speaker Sir, formerly, VDC has already been formed in various areas. Why is this being renewed? I, too agree with the suggestion raised by Pu Lalhmingthanga that the Chairman of the Committee should be elected by the members of the Committee among themselves so as to avoid ministry influence.

To make this Committee effective, the ministry should give priority to the recommendation and project brought forward by the Committee.

PU R. LALZIRLIANA

:

:

Mr. Speaker Sir, thank you. In regard to Champhai constituency, the decision of Village Development Committee is often superseded at the Project Director

level. Inspite of being the Chief Minister's Constituency, the administration has become dispicable. Even the meeting of the DRDA Governing Board has not yet been called till today. Hence, I request the concern Minister to take fruitful step in this regard.

PU AICHHINGA MINISTER

Mr. Speaker Sir, I will start with the question raised by Pu H. Rohluna which is in regards to the appointment of the President of the VDC. Formerly

the Village Council were regarded as a development

agency by the Rural Development Department, whereas there are dedicated members in the agency, there are some members who take political advantage. In view of this, awareness has been risen to set up Village Development Committee which is designed to be independent from Village Council which is formed from political platform. Therefore, the Deputy Commissioner, SDO and BDO concerned are entrusted to appoint prominent and dedicated citizen as the Chairman, Secretary and Treasurer of the VDC.

There is also a question of the membership of the concerned MLA in the VDC. In this case, the existing order has not been altered and the MLAs have directly become the member of the Block Development Committee in their respective constituencies. If any MLA has not been summoned for BDC meeting it must be the mistake of the concerned BDO or the Chairman and they will be informed of the matter.

Pu Lalhmingthanga asked for the copy of the appointment order of member of the VDC. The members will be provided with the copy during recess.

As for the question of whether the programmes set by the Committee would be acknowledged in the higher level, I would like to inform the House that the development plan made by the VDC would be entertained and it will be taken as priority as far as practicable.

The member, Pu Lalzirliana has mentioned the problem at Champhai. I am not aware of that problem before. But, the matter would be checked and looked into.

S P E A K E R : Starred Question no. 3 to be asked by Pu Saikapthianga.

PU SAIKAPTHIANGA: Mr. Speaker Sir, I ask Starred Question No. 3, will the hon'ble Minister i/c Home Department be pleased to state -

- (a) Whether the government has apprehended the persons responsible for the abduction of candidates for Suangpuilawn Constituency during the MLA Election of November, 2003.
- (b) If so, who are the culprits?
- (c) If not, why?

This kind of incidents have never been encountered since the first Mizoram election of 1952. I have re-raised this question as it affects the National political foundation.

PU TAWNLUIA : Mr. Speaker Sir, the answers to Starred Question MINISTER No. 3 are as below -

- (a) & (b) The matter has been under investigation.
- (c) The Investigating Officer has been taken up the case.

The matter has been registered under P/S Case No. 74/03 of 19.11.2003. The case Investigating Officer (IO) has not completed the investigation and hence the matter cannot be concluded for now.

SPEAKER: Starred Question No. 4 to be asked by Pu Sainghaka.

PU SAINGHAKA: Mr. Speaker Sir, I ask Starred Question No. 4, will the hon'ble Minister i/c Home Department be pleased to state -

(a) To how many Myanmarese have permission to enter Mizoram been issued since 15.3.2004 till date.

- (b) The revenue collected from this-
 - (i) Entry permit.
 - (ii) Temporary stay permit.
 - (iii) Application form for temporary stay permit.
 - (iv) Renewal of temporary stay permit for every renewal.

PU TAWNLUIA MINISTER Mr. Speaker Sir, entry permit has already been issued to 496 Myanmarese.

SPEAKER

Starred Question No. 5 to be ask by Pu Andrew Lalherliana.

PU ANDREW LALHERLIANA: Mr. Speaker Sir, I ask Starred Question No. 5 - will the hon'ble Minister i/c AH & Vety Department be pleased to state -

- (a) Whether Kawlkulh Pig Farm has been completed as planned.
- (b) If not, what are the remaining works to be done?
- (c) Whether the government considers the project successful.
- (d) If not, how is the government intend to maintain the project?

PU LALRINCHHANA MINISTER Mr. Speaker Sir, the answers to Starred Question No. 5 are as follows -

MINISTER No. 5 are as follows

- (a) Kawlkulh Pig Farm has not been completed according to the initial scheme.
- (b) An amount of Rs. 39,60,000/- has recently been transferred to Public Works Department for water supply and another Rs. 14,26,842/- has also been deposited to Power Department for the supply of power.
- (c) Though the Centre has approved the original estimate of Rs. 19.52 crores, the fund actually sanctioned was only 5.7 crores. Hence, the project cannot be managed according to the scheme.
- (d) As this is the case, the government has been taking various steps to support the farmers through bank loan and other means.

PU ANDREW LALHERLIANA: Mr. Speaker Sir, it is pleasing to hear from the hon'ble Minister that steps have been taken for the support of pig farmers. At the same time though, there are two basic needs for the beneficiaries. These are pigs to be reared and fodder. If these two basic needs are not there, the scheme will certainly fail. Therefore, fund for these needs should be reflected in the budget.

PU LALHMINGTHANGA:

Mr. Speaker Sir, as we have seen in the local telivision channel, the pigs reared at Kawlkulh Pig Farm are not properly fed. It has been said that the pigs

breed imported are not fed with the fodder specially made. And so, the pigs breed cannot grow well with the local ordinary feed. Is the government aware of this

problem?

Secondly, this farm has been run for the last four years but, it still fails to function as a piggery village. I don't think this project would bear fruitful result even after 10 years. Therefore, it would be more beneficial if the project is closed.

PU R. LALZIRLIANA

Mr. Speaker Sir, my first question is the number of pigs already sold from Kawlkulh Piggery Farm.

Secondly, I would like to ask whether Kawlkulh II Piggery Farm located at Sairang is successful. How many pig rearing families have taken settlement in the village.

SPEAKER

Though question hour is over we will invite the hon'ble Minister to furnish his replies to the questions raised by the members.

PU LALRINCHHANA MINISTER

Mr. Speaker Sir, in response to the question raised by Pu Andrew Lalherliana, as I have stated earlier, the Centre has no sanctioned fund according to the original estimate, the State Government has met shortage

of fund for the maintenance of the pig farm. The fund sanctioned by the Centre can cover only infrastructure development and the supply of a number of pigs. As this is the case, the farmers were informed of the conditions and by their own option, they took up pig farming. However, the government has been taking every possible steps to provide assistance to them.

In regards to the fodder of the pigs reared at the farm, the farmers are not in a condition to provide fodder specially made for the pigs breed imported from outside the state. Therefore, pigs reared at the village have been suffering from various diseases. Our doctors have been tending to these diseases. As the Centre did not provide enough fund for the project, the farm is solely taken over by the farmers. They are provided only the settlement and piglets but the maintenance are to be taken up by themselves. The profit if any, should also goes to them. Therefore, I cannot inform the House, how far the piggery farming at Kawlkulh has benefitted the people.

The project of Kawlkulh II Piggery village at Sairang has also been taken up smoothly. Presently, building infrastructure is on the verge of completion. Another 60 families are also being selected for this project at Lunglei District. From now onwards, the government plans to take up the project in accordance with the scheme.

SPEAKER

Question hour is over, we will proceed to the next business which is Laying of Papers. Before that, I would like to announce that Pu Lalhmingthanga has begged leave of the House to avail Zero Hour. After considering his application, he is permitted to avail Zero Hour and he is alloted 10 minutes for the same.

PU LALHMINGTHANGA:

Mr. Speaker Sir, thank you. Sport Council's resolution has been an important issue as it affects not only the youths but the elder citizens as well. Since

the creation of Sports Council, the relentless zeal of the sportspersons have yielded rich dividends and several medals have been won in the National and International levels. In the meantime, it is most regretting that the government has dissolved the Sports Council. If I am not mistaken, an executive order was made in 1983 by the PC Ministry for the creation of Sports Council. Since then, the Council has been going on under government departments without possessing an autonomy. Without having a separate autonomy, there could be political involvement in the Council which was against the will of the sports interested groups. With pressure from various NGOs to create an autonomous Sport Council, a Bill for the same was introduced and passed in 8th July, 2002. Though the Bill was found to be unsatisfactory, it was adopted as it was the need of the country. The Bill contains provision for the desolution of the Council which is found on Section 26, 27 and 28. However, there are no provisions for the reconstitution of the Council once dissolved. Inspite of the points of imperfectness found on the Bill, it was passed, for, amendment could be made any time. It also hoped that the Rules would contain provision for this matter. And now, on the basis of Section 28, the Sports Council was dissolved in June 16th and the Act does not provide for reconstitution of the Council once dissolved. The reason for the desolution of the Council was claimed to be that it has not been able to carry out its objectives to its satisfaction. The Council considers its body as failing to carry out its objects. If new Act has not been made, there is no way the Council can be reconstituted. As demanded by the Act, if the Council is dissolved, all the assets should be handed over to the government and the employees should also be repatriated to their parent departments. The Minister of Sports who was also the Chairman and Ex-Officio President should also leave the office. The order, recently made for the appointment of full Secretary was also of wrong application. The Act does not make provision for the appointment of a full Secretary. The government has made wrong application by issuing new order for the function of this body. Therefore, this is a serious matter. As we have known, the Center has sanctioned fund for the construction of Sports Complex, but, the Sports Council which is to execute the project has been dissolved as the Council has regarded itself as failing to carry out its objectives to its satisfaction. As this is the case, the best option for the government seems to be to revoke the dessolution order so that the Sports Council could resume the term. I would further like to request the government to revoke its order on behalf of the youths of Mizoram.

The copy may be distributed. The Business Advisory Committee has made programme for this Session and I have now presented this report. The copy is already circulated to the members. Can you approve the report?

PU LIANSUAMA

Mr. Speaker Sir, various Budget Committees are supposed to set after having General Discussion of the Budget. The House did not have General Discussion during

the Budget Session held on March. If the House is not going to have a general discussion during this session it would be futile to have sitting for various committees. Therefore, I suggest that a general discussion be held so that the functions of the Committees would become effective.

SPEAKER

As the plan size can not be finalised for the time being, it is not appropriate to have a General Discussion. However, after the plan size is finalised, held for at least two days. I would also like to
