preparation of Detailed Project Report from the additional central assistance (ACA) of Rs.25.00 lakhs provided by the Planning Commission, Government of India for capacity building under National e-Governance Plan (NEGP). The Central Government has approved the project proposal for financial support to carry out feasibility study for establishing Mizoram State Wide Area Network (MSWAN) Project and we are in the process of preparing tender decument for its implementation. The Departments of Information Technology, government of India has sanctioned the project for establishment of video conference centre and internet backbone connectivity in the office chamber of Chief Minister and all the Deputy Commissioners. The entire set up of video conference centre in all the district headquarters and Chief Minister's office is expected to be completed during the next year. The sub-divisional network project is to be carried out in all the sub-divisions level and three autonomous district council level in the State by extending the internet connectivity through NICNET services. This project is to be funded by Department of Information Technology, Government of India and is also to be implemented during the next financial year.

In conclusion, I take this apportunity to re-affirm the deep commitments of my Government towards fulfilment of all our objectives through various programmes and policy initiatives. With your unflinching support and with the blessings of the Almighty, I am confident that we shall continue to march ahead towards achievement of our ultimate objective. I trust that your deliberations during this Session will bear eloquent testimony to these commitments.

I wish you deliberations all success.
