Here, the contract work is taken up by Bagaththa for which 16 crores rupees is given in advance before even doing appropriate work. Besides, there is a complaint that the quality of boulder stone used here is very poor and hence to verify. I personally visited the spot and found the allegation to be true. I am further informed that only 2 trippers and one JCB is deployed here in the work. Apparently, the work will not be completed before the coming rainy season.

Knowing the situation, students union put pressure on the concern authority for immediate completion by making road block. In doing so, one student is being beaten brutally by the police. Mr Speaker Sir, if the police have to act like this, the Government will not get the support of any NGO's. The Government have to pay attention to the grievances of those students. Moreover, contractor or Public Works Department should execute the work keeping in mind the importance of people Act.

Mr Speaker Sir, this matter is of a recent incident and I have no knowledge of this incident in detail. Yet, let me give few points of what we have to know in this regard.

As already pointed out, the saud contract work is given to Baligatha Company. Since, the work is funded by World Bank, it is not appropriate for Public Works Department to get involved in the monitoring work. Due to poor performance, a replacement was made and then it was given to three companies. The first position is given to Valechan Engineer Ltd. Presently, surveying work of 6 Kms long is being completed. There is a Project Manager for this contract work with Field-staff, Chief Engineer, 40 Staff and 66 labourers Black Topping work will be started from Ngaizel Quarry.

The second portion from Falkawn to Sialsuk is given to Raitany Construction. Here 4500 cubic stone has already been in store. This company is working with 40 machineries, and not less 70 labourers and the work is being executed with their best effort.

On the other hand, students activity in this connection may be taken for granted but the people in this areas are facing various problems due to blockade of the main road. It is deeply

regretted that one student is seriously hurt in the incident, yet I have not received any information in that regard.

At the same time, 3 Mobile Clinic Vans have also been purchased at the rate of Rs. 125 lakhs the total of which is amounting to Rs. 375 lakhs. For purchase of the said toilet vans and mobile clinic vans Rs. 501 lakhs is utilised from the fund coming from PMGY for Rural Health Service. Mr Speaker Sir, utilisation of fund for such equipments is much regretted as it causes various problems in the maintenance of our hospitals.

Relating to this matter, I want to point out the need to acquire more Mosque Vans as only two hardly serve our purposes. It is unfortunate that we are not in the condition to produce utilisation certificate for purchase of mobile clinic vans and toilet vans.

Pu Speaker, coming to Social Welfare Department, I would like to thank for the increase in fund allocation for nutrition supply and the over all increase in fund allocation for the department.

Demand No. 11, S.A.D. - Pu Speaker, I request the Hon'ble Minister to visit, the Secretariat, Directorates and District Offices, in order to improve the cleanliness and Sanitation conditions.

Demand No. 6 Land Revenue and Reform - I would like to request the authorities to cut down the Revenue tax.

Demand No.8 Taxation Department I would like to request the government to fill up the post of commissioner of Taxation. Also, to reduce the tax rate of various taxes imposed by the department.

Demand No. 7 Excise - I would like to thank for the increase in the budget allocation for the department.

Pu Speaker, I would like to thank for the increase in the budget allocation in various departments like, Higher and Technical Education, Art and Culture, State Excise and Fishery.

Demand No. 24 - Pu Speaker, it is disheartening to mention that, the government is able to divert fund from Rural Health Service. The government should give priority to Rural Health Service, as it is the priority of the central government.

discuss the flat rate per square meter. It is the official who pronounced the flat rate. Pu Speaker, it is regretting to note that we members did not have the apportunity to discuss the flat rate. Further, Pu Speaker, it is regretting to note that, the government does not abide by its own rules, like the Revenue Assessment Rules 2005, Chapter-III Rules 5-14. There are many such cases, I may not be able to name all. Pu Speaker, we acquired land not for compensation/loan, but for residence. Therefore, I do not deny that we advocate to the people not to pay the extra high rate of tax. There was a big relief after the Hon'ble Chief Minister stated that they will review the flat rate. However, till date, no step has been taken so far. The government is quick to react to whatever matters it gives priority, but in regard to tax, why are they taking so long to review. I would therefore, request the government to withdraw the present rules, and follow the old rules.

Demand - 24 I agree with what the hon'ble member from Kawnpui, but what I would like to state is that Aizawl Civil Hospital is still the best for the poorer section of the people. I visited Civil Hospitals of our neighbouring states, and the condition of their hospitals is far unhygienic and dirty. Therefore, our hospital serves the poorer people much better. Our Doctors and Nurses are graceful. Pu Speaker, with whatever little fund allocation received, I feel the hospital is well looked after. I give thanks to the Hon'ble Minister.

#### **PU ANDREW LALHERLIANA**

Mr Speaker Sir, thank you. First of all I would like to start with Revenue and Reform and Taxation. Pu Speaker, looking from the

way the Revenue Department has raised various taxes recently, it seems that, the government does not seek the opinion of various political parties including the ruling M.N.F. Party, because some of my friends from M.N.F Party agreed that, the various tax rates introduced is far too high. As per the previous provision, Rs. 83/- is paid for Aizawl City Grade-I standard size, but as of now, it has been raised to Rs. 4460.90. Rs. 78 was paid for grade-II, but now according to the new rate it is Rs. 3345, Grade-III is Rs. 61, and the new rate is Rs. 1672. Pu Speaker, if we look at the rural areas, revenue tax has also gone up tremendeously, like in Champhai District, Rs. 50.18 was paid for Grade-I, but now in the new rate, it has gone up to Rs. 1672.86 likewise from Rs. 44.60 to Rs. 697 in Grade-II percentage wise, it has gone up by 1000%. Pu Speaker, I will not further mention the rates. I request the hon'ble Minister, to review the rates as he has mentioned earlier. The rural people are facing great difficulties. I recieved a phone call this morning from Khawzawl in this regard.. Pu Speaker the Minister should give priority. As we are aware, being a citizen, it is our duty to pay tax. But what we are expressing here is the extreme high rate. I would further like to suggest that in future, the government should not raise from the existing rate, but from the government's plan. The government has Revenue earning units like Bamboo processing, Animal feed, and various corporations. If there units are developed, and up-graded it will moblise revenue for the government.

Coming to Taxation, I would like to suggest that tax may be exempted from locally produced items from poultry and vigetables as it could be an incentive to the local farmers. At the same time, items coming from outside the state should be made taxable.

Another, point I would like to emphasize is Article on schedule II 'B'. Here, the list of goods taxable at 1% are gold, precious stone, silver and platinum. There articles are mostly possessed by the rich people. Under VAT, only 1% is to be collected from these articles. Therefore, fixation of tax to be collected under VAT should be adjusted in accordance with the state's economy. Thank you.

ing & Stationery department. In the last budget session, the hon'ble Minister begged all department to buy their requirements through Printing & Stationery department. We, the MLA'S also supported his request. But, today we know from the answer to questios that there have been 10 departments which never approach Printing & Stationery department in buying office materials. Among such 10 departments taxation department is also included. It is surprising to know that, the said two departments are under the same Minister. While the requests other department to approach Printing & Stationery, he himself ignores his request.

Coming to demand No. 8 It is said that the rate of central sales tax would be reduced years by year after VAT. is introduced. Now, one financial year had already been completed. However, the rate of C.S.T. is still the same. The traders in Mizoram pay double taxes. The government's sole purpose is to collect tax from all possible sources. Inspite of this, tax clearance certificate is never insisted by Health department form its suppliers.

Regarding land Revenue and settlement department Pu Speaker, as per the answer given to the question I made, the department stated that, the hand-book was not printed in the Press, however. I would like to point out that, it is not possible to be printed in the department's Office. Further, It can not be drafted by the officials, the wording were aggresive, the hon'ble Minister should accept that, it is drafted by himself.

#### PU S. HIATO

Mr Deputy Speaker Sir, let me speak about demand No. 36. Fisheries department is working hard and giving

aids to fish farmers. Rs. 100 lakhs has been invested to supply fish seeds. However, the department has only 12 fish farms out of which five are enactive. It is desirable that fisheries department, take further step to produce more fish seeds. During the year 2002-2003, 41 lakh fish seeds was released in 18 different riverines, bud the number of fish in such rivers has not increased. During this year Rs. 115 lakhs is allotted for fisheries from BAFFACOS. If the said fund is utilised to develop irrigation system, more fish ponds could be made.

Regarding demand no. 29, I would like to request the Government the demand simpler process for giving out assistance to handicapped persons. The long and detail process become trouble some for those who come from rural areas.

In Saiha town, Social Welfare Department Constructed office building. Still, private building is rented by the department. I have mentioned this for the notice of the Authority. The department is also urged to give more attention forwards improvement of de-addiction Centres.

A resolution has recently been passed by the House that medical centres as the same standard of district headquarter should be set up in Mamit, Lawngtlai and Kolasib. At the sametime, the government is reminded not to neglect other District Headquarters such as Saiha. Serchhip and Champhai, so that various health programmes launched could be more effective

Mr Speaker, if PHC. and SHC (Subsidiary Health Centre) are not well-equipped, the health policy in Mizoram cannot be carried out.

:

It is pleasing that BPL families are allocated fund under BAFFACOS for medical re-imbursement. But, as soon as they are admitted to hospitals they need money to buy Medicines and injections. Therefore, fund may be provided for purchase of medicine.

Coming to Higher & Technical, due to shortage of lecturere, certain departments are still left unopened. At Saiha College, 5 lecturers posts are lying vacant. And the building also needs reconstruction. I request the hon'ble Minister to note this and take positive action.

## PU K. LALRINLIANA

Thank you, Mr, Speaker I will start with demand no. 35; Fisheries. It is important to boost up fish production

us the demand is increasing in the State. Realising this, the Government privided assistance to fish farmers through BAFFACOS and Fish farmers Development Agency. Priority should be given to the potential areas like Mamit and Kolasib districts. At the same time, I would like to remind the hon'ble Minister to open District Fisheries office at Kolasib.

Coming to Taxation Department, shortage of staff at Kolasib District hampered office works especially tax collection. The hon'ble Minister is requested to note this.

Under demand no. 24, the Government has made continued efforts towards improvement of healthcare. More member of Doctors, nurses and Health workers are being employed in order to provide better health care facilities to the people of the State. It is a great acheivement that bio-medical waste Management at Kolasib and Saiha has been taken up. I express my appreciation to the Government on behalf of my Constituency.

Another great step taken by the Government which I appreciate is the Construction of Accident and Trauma centres at Serchhip and Kolasib under the funding of NEC. The introduction of Mobile Clinic Van has been highly appreciated as it serves the purpose well for rural people where there are no good doctor.

I agree with the hon'ble member from Saitual that the States Civil Hospitals are superior compared to other States hospitals in terms of hygiene, cleanliness and dedication of doctors and nurses.

Next, I would like to commend on the performance made by Social Welfare Department. With the objective of providing a wider scope of rehabilitation in the State, the existing De-addiction - cum - Rehabilitation Centre at Sethawn has been converted into a full-fledge 'After - care Centre'. I am proud to say that different trades have been started in the centre in order to provide skills to the recovering addicts. Mention may also be made that the department Anganwadi Centres are being set up and ICDS scheme and Special Nutrition Programme are also implemented. In this way, this department is committed dto provide assistance to the needy.

Regarding Higher & Technical Education, We can see that the hon'ble Minister has taken vigorous steps for improvement. In response to our request for reconstruction of College buildings in different places, schemes are made to the DONER. It is learnt that we are about to receive positive outcome from DONER. We are very grateful to the Minister for his efforts. It is also a matter of pride that this department is able to sent a number fo students to outside the State to undergo training in Engineer and Medical fields. Coming to Art & Culture Department, I come to know that District Library building is proposed to be constructed at Kolasib. I would like to say that the people of the District are happy with this and it is hoped that the District Library would serve its purpose well.

I would like to mention one point concerning Health & Family Welfare. The PHE building at Bairabi has become old and even unfit for human accommodation. The building is in need of reconstruction. Therefore the authority is requested to take this into priority.

Regarding Health Sub-Center, there is no health Center and anganwadi Center at \_\_\_\_\_\_ Meidum Village. It would be appreciated if the hon'ble Miister can earmark this when the next budget is prepared.

#### PU VANLALTHALIANA

Thank you, Mr Deputy Speaker Sir. at the outset, I would like to say matter concerning Higher & Technical

Education. It is remarkably good to see the various steps taken by the Government for the development and upgradation of over Colleges. It is also pleasing that IGFAI university is passed by the Government. Not only this I am proud to have a Government that can set up State quality Assurance Cell-We also heard that several Schools and Colleges have been provincialised. This is indeed an achievement.

Under demand no - 23 there is Art & Culture Literacy rate has increased in the State. To provide reading facilities to rural people the Government has set up District Libraries in many places. It is anticipoted that District Libraries would also be opened in the newly declared District headquarters.

The role played by Social Welfare department, as the name implies, is very important. This department concerns the welfare of infant to the aged. Hence, the Government should give more interest to this department.

We have heard from the members that Anganwadi Centres have been opened in most of the Villages. It is necessary for the Government to have Anganwadi Centres in all the Villages within Mizoram.

Emphasizing on the State's Revenue system. I appreciate the decision taken by the Governmen in regard to collection of land revenue. However, there is one point that I would like to bring to the notice of the hon'ble Minister. As stated earlier the people are not simply hesitating to pay land revenue according to the existing rate. But, if the rate is to be fixed on square, metre basis, it will be too heavy for the public. Even for the member of this House who earns Rs. 24,500/- a month, it is beyond one affords. So, the rate of land revenue should be fixed according to our economic condition.

Coming to Fisheries department as a result of the efforts rendered by the hon'ble Minister and the concern authorities, this department has now played a significant role in the economic life of the people of Mizoram Many families have taken fish farming as their occupation. The installation of cold storage unit has also became an encouragement to the farmers. I advise the Government to keep up the good work.

I will conclude my speech with Health & Family Welfare department. Compare to other State's Hospital, the Civil Hospital in Mizoram is superior in terms of doctors and nurses. But our hospital lacks good medical equipments. The needs for different kinds of equipments will be increasing. Therefore, the Government. Should give concentration towards procurement of medical equipments.

During the previous Ministry a number of Health Sub Centres was constructed but not yet made functional. I request the hon'ble to note this for fast action. And I support the passing of this demand.

Mr Deputy Speaker Sir, I will start with demand under excise department. During the month of January, number of vehicle accident

between Phunchawng and Aizawl was 14. The cause of accident were mainly due to drunken driving and not engine failure. As this is the case, I would like to urge Excise department to make greater effort for successful implementation of prohibition law.

:

Coming to Fisheries, I would like to emphesize that it is casier to become self sufficient in fish farming than jhuming cultivation. There is one thing I would like to suggest in regard to the supply of fish seeds. The department has distributed fish seeds to fish farmers. These fish seeds are purchased from outside the State. It is learnt that during 2003. an amount of Rs. 120 lakhs was spent for procurement of fish seeds from outside. In order to save fund, the existing seeds may be multiplied in a particular fish farm. So that the farmers can get fish seeds from that particular farm. If this policy is taken up, the Government would save lot of money.

I have certain points to highlight in regard to Health and Family Welfare. The effort given by the hon'ble Health Minister for the Welfare of Homoeopathic doctors for their regular appointment is highly appreciated.

With an objective of providing better health care to the people of Mizoram emphasis has been laid on development of health sector infrastructures. One of the achievements made is the installation of radiation center for Cancer patients within the State. But, due to poor condition of the building where the machine was installed, the instrument is unfit for radiation. Another problem which I would like to bring to the notice of the hon'ble Minister is the approached road to Radiotherapy Centre for cancer patients. The approached road is bumpy and steep and can be tiresome for cancer patients. Therefore, the hon'ble Minister is requested to note this and see that the problems faced by cancer patients are solve. I would further like to suggest that a recovery room which can accommodate 20/30 patients may also be constructed nearby.

It is also important to follow a proper policy for the selection of post graduate training at RIIMS. (Imphal).

I would like to say a few words for the welfare of people with HIV. positive. These patients have approached me with their problem. According to them, they are beginning to find it difficult to afford their Medicine. Therefore, the hon'ble Minister is requested to consider the remedy of their proplem.

It is a matter of appreciation that Land Revenue and Settlement department receive generous amount of revenue. It seems that this is the only department that can manage itself in regard to revenue. It performs tremendously well in regard to revenue collection. However, there is one thing that needs reconsideration. The new rate of land revenue is found to be rather high  $\pm$ for the masses. This brought quite a burden to the people. Those who affect the most are the under, privileged group as they have to surrender their land as they could not afford to pay the revenue. And those without property could not afford to buy new land either. Therefore, the new rate of revenue is too repressive for the people though the Act itself is acceptable. It will be appreciated if the hon'ble Minister reconsider the matter.

## **PU SAIKAPTHIANGA**

Mr Deputy Speaker Sir, today we are taking demands of three Minister under discussion. I will highlight only a few. First on Social

ı."

Welfare department Despite the progress it has made, this department has some improvement to be made particularly relating to old age. Old age pension has been given to a number of old age persons. But, the number of recipients has not been increased for some time due to the limited fund received from the Central. Hence, I want to suggest that the State Government contribute some portion.

:

I would like to emphasize the need for better health Centre within my constituency. It is pleasing to note that there is proposal to set up District hospital within my Constituency. Meanwhile, there are hospitals in my area where there are no doctor. The patients had to go to Mamit hospitals which is also without proper Medical facilities. If doctor can be posted even at Kawrtethawveng the people would be most delighted.

Several new posts have been sanctioned recently. But, the Government decided to select only local people for the respective post. If this is so, it would be a complicated thing. Therefore, I request the hon'ble Minister to review this decision.

Coming to Demand No. 35, Fisheries Department. This Department now seemed to be a tiny Department. But it will become one of the most important Departments in future, as it provides early matured livelihood to the people. Inspite of this, its budget is quite meagre. I, therefore, request more fund for this Department in the Revised Estimates. Meanwhile, I am sorry for there is no proper place in the markets for those who sell local fish. Better method of fish farming and its marketing is very important step to be taken by the Government.

In regard to Tourism Department, we listened that we have more tourists than we expected. The Central Government also seemed to be interested in this sphere. I, therefore, request the Government to pay more attention to this Department. Much more fund would also be given to develop this Department.

Lastly, I would like to mention about Excise Department. As we know, we work very hard to prevent liquor and abusive drugs. However, It is now found out that much liquor can

easily enter into Mizoram from Tripura. Meanwhile, there is not any Excise post in the whole district of Mamit. Therefore, I request the Government to think about this and also to take positive action for eradication of liquor and abusive drugs in the said area.

#### PU H. ROHLUNA

Thank you, Mr Deputy Speaker Sir, Let me speak about various taxes first. The increasing taxes becomes

now the talk of the town. It becomes a great burden for the people. We have listened here in this House the assurance that the rate of various taxes would be revised. In this regard. I would like to mention that the concerned Department have to follow The Mizoram (Land, Building and Assessment of Revenue) Act, 2004 in the collection of various taxes.

:

If the rate of taxes is reduced, will the Government reimburse the excess amount to those who have paid taxes as pre-revised rates? Besides, if the rate is to be revised I would like to request the Government to suspend the on-going collection of taxes. It would be good to collect various taxes after afixing the new rates. In regard to C.S.T. (Central sales Tax) the hon'ble Minister had said last year that C.S.T. at the rate of 4 % would be reduced to 2 % after introducing VAT (Value Added Tax) for one year and which would further be reduced to zero after two years. However, C.S.T. is still 4 %. Therefore, I request the Government to reduce the rate of VAT untill CST. is reduced. So that we can relieve the people from heavy burden.

Coming to Social Welfare Department, I would like to express my thanks to this Department for working very hard. However, I suggest that we work harder in selecting the beneficiaries of old age pension. In the matter of prevention of Alcoholic drinks and abusive drugs, I opine that much more fund would be allotted to assist NGO'S.

In regard to Demand No. 24. I would like to raise the Report of CAG. The Audit Report pages 27-44 contain Health Department. I therefore, wish this Department to read the said pages carefully. Meanwhile, I suggest more fund under the head of State Illness fund which is very useful for the poor people. I also want to express my gratitute to the staff of Health Department for rendering good services.

In the matter of Higher & Technical Education Department I would like to request the Government to take steps to help those who want to take Educational Loan for higher studies. Thank you.

## PU F. LAL THANZUALA

Mr Deputy Speaker Sir, I would like to mention first about Health Department. There are many points in appreciation of steps taken

by this Department. Health Department is, in short, very improved now a day. From the speech of the hon'ble Minister on the day of General Discussion, we know that our hospitals are greatly improved in facilities and equipments as well as in man power Various hospitals in rural areas would also be equiped to be able to carry out minor surgery, so that refer case from rural villages to Aizawl on medical ground would be lesson. Meanwhile, we seemed to neglect awareness campaign on health. As we know, cancer case has been increasing in Mizoram. I opine that we need to carry out research to find out the reason for prevalence of Cancer. If we give education

to the public, we can prevent Cancer disease to some extent. I, therefore, suggest proper Education to the people to improve our health condition, Besides, I would like to point out about smoking inside the Hospital campus. We need to enforce rules and regulations in this matter.

In regard to Higher & Technical Education Department. I would like to express my thanks to the hon'ble Minister for working very hard to make improvement in the said Department. ICFAI University is introduced in Mizoram to import business education to the students and many colleges have now been provincialised. In this regard, I would like to mention that every College needs to put more emphasis on English.

In regard to taxation Department, we have heard about complaint on the rate of various taxes. However, I opine that, the rate of our taxes are not too high. Nowaday, our economic condition becomes good, almost every family has a television set. Therefore, the new rate of taxes as assessed by the Department is not unaffordable for most families. The rate of taxes in other developed countries are very high. We have to remember that all taxes would be used to develop our state. Comparing to the past years in the sphere of buying power, the rate of taxes today are not too much. So, let us motivate the people to be iterested in paying taxes regularly.

## **PU LIANSUAMA**

Mr Deputy Speaker Sir, of all the demands for today Health Department would be the most important. As I had stated on the day

when I moved resolution. I appreciate the services rendered by the staff of Government Hospitals and various PHC's (Primary Health Centres). Among the hospitals owned by the Government, I found no hospitals in other states better than Mizoram Hospitals. Inspite of this the budget allocated for Health Department seems to be quite meagre than how much I desire. Therefore, it will be good to give more fund in the Revised Estimates. I appreciate mobile clinic in various rural areas. If we can equipe this Department to be able to undergo mobile clinics more frequently as well as to cover more and more Villages I hope we would be able to relieve the burden of the people on the ground of health.

:

Coming to Social Welfare Department, various NGO's and even we, the MLA's depend on this Department to some extent. Therefore, I want more budget to allocate for this Department. At the sametime. I would like to point out that nutrition and other sanctions from the Department are said to be tampered very often which is very prevalent especially in my constituency. I am sorry for such practice.

In regard to taxation, let me take up Demand No. 6 and 8 together. We are not interested in paying taxes since a very long time. But, we need to collect taxes to run the Government. Therefore, it is very difficult to make good reputation for the concerned Minister and the staff of this Department. Their position is really pityful. We, therefore need to solve their problem on shortage of staff. Taxation Department have no a full fledged Commissioner.

It is important to strengthen Fisheries Department also. It renders direct services to the people. Therefore, I want much more money than today's demand for this Department as it can give permanent occupation to the people. If we can utilise all potential areas in Mizoram there will be great improvement in our economy. •

Now, coming to Health Department, there is Purchasing Board under this Department. While we need Homeopathic medicines, the Department bought Ayurvedic Medicines. There is no demand for such medicines. Why do we buy such useless medicines. other than the needed medicines?

Whereas Homoeopathic doctor is needed as nodal officer, doctor is appointed. Allopathic. This mistake has to be corrected so that Homoepathic doctor could be appointed as nodal officer.

Another undesirable thing that happend in Mizoram is the supply of sub-standard medicines from unreputed firms. We have spent lots of money on medicine but to no avail because sub-standard medicine is prevalent in the market. We need laboratory to check the quality of medicine. Laboratory should be taken as top priority when preparing the budget.

I would like to enquire the intention of the Government in regard to the new hospital charges.

Inadequacy of morgue Van has often been mentioned in the House. In stead of Purchasing mobile toilet, morgue van is more important. I suggest that at least 10 morgue Vans should be purchased.

The revenue tax has tremendously been increased. So, a total badh was even organised to press the Government. The Government then reviewed the revenue rate but was still • lather high. Presently, we are awaiting the final decision of the Cabinet.

In regard to Fisheries, if we really have the policy to become self sufficient in fish, a separate place for selling local fish should be made.

On Excise department I have the opinion that NGO's should be given a kind of authority to search or seize liquor & abusive drugs. A promosion should be made for this. So that their efforts could be more effective.

Under Social Welfare, I request the authority ti arrange for disbursement of old age pension within their respective villages.

Lastly, what is the reaction of the Government to the petition of East Phaileng MUP to provide fund for Construction of "Phing Pa leh Phing nu in" as a Historical muniment?

#### **PU LALTHLENGLIANA**

Thank you, Mr Deputy Speaker, Most of the members have negatively mentioned the introduction of VAT and the new rate of land

revenue. The Hon'ble House Leader has admitted that certain portions of the new rate of tax was rather high. And we were assured that it would be reviewed. Hence, it may not be the most appropriate to form a critical opinion on the House regarding taxes. I would like to inform the members that the hon'ble Chief Minister is always open to reduce the rate of tax if found extremely high.

:

In the matter of Printing and Stationery Department. I am sorry for hearing that many Departments use private firms other than Government Printing press. If we use it to print various Government documents including schools text books, this Department can earn more revenue.

Next, I would like to appreciate various steps taken by the hon'ble Minister for Higher & Technical Education Department. We now have ICFAI University to impart business education to the students. Besides, it is important to search for ways to send as much students as possible to get management and technical education. I also join hands with my fellow Members, in the matter of Excise Department and Art & Culture Department, let us strengthen them with better facilities and equipments.

Lastly, I would like to mention about SAD. It is an important Department as it controls every Departments. However, I request its staff to keep up regularity and punctuality better than today. Otherwise, the staff of Directorate office and District office will copy them.

#### **PU LALDUHOMA**

Mr Deputy Speaker Sir, Let me start from Taxation Department. When we discussed about the Mizoram VAT Act some years

back, we were frightened that prices would be increased. But the then Minister for Taxation Department gave assurance that prices would not be risen. He stated that it would rather be lowered after introducing VAT in Mizoram. Inspite of this all the people of Mizoram are now the victims of price rising. I am sorry for telling the people a lie. VAT might not affect prices of commodities in other states. But in Mizoram there are no huge factories and all our requierements are imported from other states, introduction of VAT greatly affects price of commodities since our businessmen cannot claim ITC against the Government. Their taxes cannot be refunded. The Main victims are the poor people. To solve this problem we have two options (1) reduction of the rate of VAT and (2) Permission to refund ITC (Input tax credit). If we agree to refund ITC, there will be great loss from Government's side. I, therefore suggest lowering of rate of VAT to be affordable for all.

I further suggest modification of Presumptive Tax as we have no production in our state. All the Merchants in Mizoram are dealing with commodities imported from other states. If we can modify the said tax we will do great works for the small businessmen and also for the people. Besides, I would like to Mention that corruption can easily involve under the Mizoram VAT Act. Therefore, we need to check its enforcement strictly.

In Section 25 of the said Act it is written that Tax Clearance Certificate would be insisted on every contract and Supply works. But, Many Department do not follow this provision. They give contract works to many non-Mizo Contractors and Suppliers without insistig on Tax clearance Certificate to be obtained from Commissioner of Taxes. I would like to request the  $z_i$  hon'ble Minister to enquire this.

Again VAT is also imposed on Medicines. In the past years before VAT is introduced, Sales Tax was not imposed in Medicines. Imposition of tax on Medicines is the burden of the poor people and poor patients. Is it not good to abolish tax on medicinal items?

Next, I would like to comment on the department of Printing & Stationery which has received the highest revenue income amongst all the Departments. Despite the Government's order there are Departments that do not purchase office stationeries from Printing & Stationeries Department. These departments have even negotiated with private firms for printing of official matters instead of sending the materials to Printing & Stationery Department. Despite all these, the department could exceed the targetted revenue income.

Coming to demand no. 35 to achieve self-sufficiency, by the State, fish farming played an important role. Even the fish produces from Mamit, Zawlnuam and Kawrthah is enough to cater the need of the whole population. Regarding fish seeds, there is a private farmer who takes up artificial insimination without the intervention of the Government with this method, this farmer has produced fish seeds. The fish farmers in the area preferred this seeds to that supplied by the Government Meanwhile it is a pleasing matter that financial assistance for making fish farm has been available through BAFFACOS.

Under demand no. 21 there is Higher & Technical Education. Till recently, the Government terminated all deficit States at Middle and High School levels. But, the Colleges of Lawngtlai, Hnahthial and Mamit are still under a deficit status. Since, there is o extra fianancial involvement, the Government is advised to upgreade the said College to a provinciallised States.

I am happy to repeat that the Government made a decision to upgrade the CHC of Mamit, Lawngtlai and Kolasib to District Hospital. It is a great progress to have due anticipation in regard to health care.

#### PU D. THANGLIANA

: Thank you, Mr Deputy Speaker. I am glad that we could have an opportunity to discuss the demands of the hon'ble Minister. For being the ble Speaker to allot an extra time for me.

seniormost in age. I request the hon'ble Speaker to allot an extra time for me.

I will start with Revenue department found under demand no. 6. This department earned lots of debate of late. We cannot deny, the fact that Revenue department is one of the most important departments. This department has carried out summary survey of lands and also keep up all land records. The task undertaken by this department in regard to revenue collection is also remarkable. Despite shortage of staff, the department has made progress in many ways. Mizoram has also seen progress in giving tax to the Government. The people have now acknowledged that it is their duty and responsibility to pay taxes. However, it is regretable that there are some politicians who tried to impart in the minds of the people that they should not give tax to the Government.

The department of Taxation has rarely been commended. However, it is only due to the dedication and hard work of the officers and staff of this department that the Government could run smoothly to some extend. It is our duty to appreciate the achievement made by the department.

As we are all aware, the department of Social Welfare has been a parent department for the aged, persons with disability and the under-privileged people. I am proud to see the various works and services rendered by the department for the welfare of the people. The focus of this department has been on programmes relating to the rehabilitation of the needy.

The Government has also acknowledged the performance of this department and these by increased the budget provision by 250 lakhs.

In regard to Higher & Technical education adequate emphasis is laid on development of academic excellence and high level of technical and professional literacy. It is a pleasing matter to see the relentless efforts made by the hon'ble Minister. It is great that ICFAI Bill has been passed by the House which is expected to serve the educational needs of the up coming youths of the State.

Under demand no. 35, Fisheries, Mizoram has not yet achieved self-sufficiency in the production of fish. Due to the recentless efforts rendered by the hon'ble Minister and the department steps have been taken for the construction of fish ponds and renovation of the existing ones under BAFFACOS. It is learnt that fish farming is more profitable than ordinary farming. Realising this, the Government has assigned priority to fisheries. We are fortunate to have a Government that concerns over the rural cultivators. I would further like to advise the Government to supply only standard quality of fish seeds to farmers.

Despite the many points I want to say in regard to Health & Family Welfare. I will state only a few due to shortage of time. All the innumerable steps taken by the Department for rural healthcare and the emphasis laid on development of health sector infrastructures have been praiseworthy and commendable. We should therefore continue to appreciate all the good works performed by the Government through Health & Family Welfare Department.

It is im[portant to appreciate the performance of Art & Culture department for the development of the rich culture and traditions of Mizoram. Therefore, Mr Deputy Speaker, 1 request this House to pass the demands of the three Ministers.

## PU LAL THANHAWLA

Thank you, Mr Deputy Speaker At the outset, I request the hon'ble Deputy Speaker, to allot longer duration of time for me.

I will strt with Fisheries, which the members have mentioned many points on the subject. If we read the report of the C & AG, we find wordings such as unnecessary expenditure and 'incorrect tender'. It is pleasing to hear from the members that self-sufficiency could be achieved through fisheries. If we relly want to pursue the task of self-sefficiency. honesty is the key. It is shameful for the Government that the C & AG Report has highlighted the dishonesty and

pertiality of the authority. The hon'ble Minister may not be involved, but it is his responsibility to check such undesirable matters.

Coming to Printing and Stationery. This department is supposed to cater the needs of other departments. But, number of items are not necessity items. Hence, adjustments has to be made in this regard. As stated by the members, some department donot procure stationeries from the department of Printing and Stationery. The hon'ble Minister is requested to enquere into this. In regard to Social Welfare Department the Union Finance Minister is generous towards the progress of ICDS. The Central has taken up a policy for strengthening of the existing Anganwadis and solving the problem of mal nutrition amongst children. There is also scheme for providing mid day meal to Primary School Children. However, the CAG Report mentioned misappropriation of the department in regard to the selection of supplier for midday meal. It is learnt from the Report that the lowest bidder declined for no specific reason and the third lowest bidder of the tender was selected. Due to this, the children seemed to have recieved less nutritions food. It is clear from the CAG report that the concerned department needs to reform itself.

As done in the Central government, the old age pension may also be increased in the State as well.

Coming to Higher & Technical Education, it is pleasing to have an University. Due to the inefficiency of the first Vice-Chancellor, the University is below up to the mark. Presently, a new Vice-Chancellor is being searched. Here, I would like to urge the government to involve and fight that the post is occupied by a Mizo

I would like to suggest to the hon'ble Minister, to take up rapid step to promote technical Education. Further, I would like to suggest that, the government should be careful in dealing with ICFAI. In India, we have heard of private universities booming at the start, but gradually comes to a silent end. Therefore, if we are not careful at the beginning it may not be up to our expectation.

Regarding National Rural Health mission, if we look at C&AG Report, the toilet Van is regarded as wasteful expenditure. Therefore, we should take careful step not to repeat such an act. As we are aware, the central government is specific in Rural Health Mission. This year the fund allocation has gone from 8420 crore to 10,420 crore. It is pleasing to note that the hon'ble Health Minister is taking step from the grassroot level in rural areas. However, there are still space for development, and certain acts which needs rectification in the future.

As for tax, Deputy Speaker, we have never advocate the people to stop paying taxes Instead, what we are stating is that the present proposal of the government is a kind of extortion. Therefore we are requesting the government to withdraw the present proposal.

As for tax, Pu Deputy Speaker, we have never advocate the people to stop payig tax. Instead, what we are stating is, the present proposal of the government is a kind of extortion and that, the percentage of the jump is too high. It is 500 % to 300 %. Therefore, we submitted a Memorandum to the ho'ble Chief Minister, received our delegates, he suggested to the delegates to submit a specific suggestion there by which a committee was constituted, headed by a Rtd Revenue Director. Pu Deputy Speaker, we have submitted the suggestion. We request for rectification of the rate. It is unlikely that, the government will act against it own rules and regulation. But as of now it is regretting to state that the government inspite of rectification there is a notification that, if a person refuses to pay tax, the tax amount will be doubled and L.S.C. cancelled. Pu Speaker, therefore, we cannot stay and help in passing this Revenue demand.

## PU B. LALTHLENGLIANA MINISTER

Pu Deputy Speaker, first of all I would like to start with Printing & Stationery department. This Department was once an extensive de-

partment, but fade away gradually, therefore, we are reviving the department. In the year 2005-2006. the fund allocation for the department was Rs. 50 lakhs, and Rs. 30 lakhs in R.E. However, it was not enough to meet the demand of all the department. Therefore, the government is taking step as far as possible to solve the problem.

The hon'ble members mentioned that, all the department does not acquire their requirements from Printing & Stationery. Pu Deputy Speaker it is true, the main reason is the quality of the materials and the distant of the depot Pu Deputy Speaker, Knowing this, we have given notification to suppliers to supply papers and other materials as per prescription, therefore the quality of the papers has improved. Pu Deputy Speaker, we have opened sales out-let below controller's office for the convience of other department.

The Revenue target in Printing & stationery for the year 2005-2006 is, Rs 55 lakhs, and 60 lakhs in revised estimate. Pu Deputy Speaker, we have callected Rs. 55 lakhs plus and there is liabilities in 4 department. Once we receive there liabilities. we will cross the target. The hon'ble opposition leader mentioned about the items. Pu Deputy Speaker, we have decentralised 52 items. However, we have not given notification since, we have not cleared the stock from our depot. Once these items are cleared, it will be decentralised. Then, regarding the law revenue in Printing, it is mainly due to the fact that printing is given to private press by various departments. But with the Co-operation of Finance department, we have requested these departments to stop this practise, except for some exceptional case. This has resulted to the climb in revenue. Pu Deputy Speaker, if the government could make an arrangement for us to print, the MBSE text book from class I to IV, it could make a great difference in the revenue income.

In the previous financial year, we acquired image setter colour seperator, through craficom technologies Kolakata, to support the image setter, the department requires four colour of set machine. Now, there is fund allocation of Rs.80 lakhs for the machines, we are very grateful. Once this machine is procured we will be able to print the colour Mizoram Calendear, and we expect to be a sound revenue earning department. This is all I want to speak about Printing & Stationery.

Coming to Fishery department, 11 Members have spoken about Fishery department. Pu Deputy Speaker, there is a saying that, an acre of water pays more than an acre of land. It present we have 5000 fish farmers, there are several families having WRC who wished toconvert into fish farming. In Mizoram, we have the potential, but we are still not sufficient and fishes are import from Andra Pradesh. In order to develop fishery, there is still a long way to go. Under BAFFACOS, we have distributed aids for new ponds to 100 persons, and 29 persons. are given aids for renovation and repair. these aids are given under spicific criteria and norms. Instructions are given to complete the work before the rainy season.

During the year 2004-2005 we received Rs. 92.54 lakhs from NEC. From this fund we distributed 393.38 lakhs fish seeds, and 55 metric ton of fish feed. Pu Deputy Speaker,

we also received 37.5 lakhs from fish farmer Development Agency scheme, Government of India. From this fund, 764 persons are given aid for renovation. The rate per person is 22,500/- per hectare. We further received Rs. 50 lakhs Ist instalment from central government, from which the matching share is Rs. 16,70,000/-. The fund will be utilised for repair/renovation of ponds, we are expecting to cover 266.8 hectare. The list of beneficeries is yet to be selected. Pu Speaker, from non-lapsable central Pool of Resources fund, fish seed farm has been set-up. However, since there is no maintenance fund, we are intending to privatised the fish seed farms except for Laldenga fish seed farms, Zobawk and Tamdil fish seed farm. In this manner, Pu Deputy Speaker, we are taking steps in every possible way to acquire better quality of seeds from Kolkata and Tripura. with the collaboration of central Land Fisheries Education we are carefully studying the proceeding. therefore, very soon we are trying to be self-sufficiency in fish. As for the market, talk is held with Trade & Commerce department, to allocate seat in the new market buildings for fish farmers. Ice-plant has been constructed at Bilkhawthlir and Kolasib. And, cold storage at Aizawl -Bawngkawn road for those farmers who aims Aizawl Market and their fishes are being stored at cold storage Bawngkawn. There is a plan to make cold storage and Ice Plant available in every potential areas.

In replay to the complain about non-coverage of some areas by BAFFACOS, I have to state that priority is given to a potential area and will then be extended to other places as necessary.

Coming now to taxation, let me point out that VAT is introduced in Mizoram from the I<sup>st</sup> April 2005. and a number of complaint is being received to that effect. However, the government insists on doing with a view of the need to bring Mizoram towards progress. The concern Official or the Minister may not be mastered with this subject, yet the knowledge can be acquired from day-to-day experiences with the official works, since introduction of VAT, the department is making certain achievements. Collection of VAT is done from June and up till this January, the total collection as far is amounting to Rs. 42,44,005,694/-. The total collection within a year is amounting to Rs. 12,14,97,999/- Where as percentage of increase rate happened to be 40.11 % Since introduction of VAT, member of collecting centre are opened by the department such as Melbuk border trade, Lengpui Airport, Kanhmun, Tlabung by recruiting member of workers, as per instruction from the Central to Maintain uniformity.

## **PU SAILOTHANGA SAILO**

Mr Speaker Sir, whether the government put any pressure on the Central government for reduction of tax atleast by 8%.

Secondly, since there is an instruction to fix uniform rate from the Central, it will be pleasing if our government implore the central government to reduce certain taxes so as to keep up uniformity.

## PU B. LALTHLENGLIANA MINISTER

Mr Speaker Sir, it is to be noted that our problem in this connection has been forwarded to empowered committee on a regular

interval but no final decision has yet been made till date. The main reason for introduction of uniform rate is to evade problem of enter-state trade relation and on the basis of it the government will take necessary action. Regarding recruitment of employees, it has to be done with the approval of GAD

Keeping in mind the importance of having a full-fledged Director for Taxation department, a demand for it is now being moved and will soon be discussed in the cabinet meeting.

In regard to introduction of VAT in Mizoram, there are opinions against it as it has not yet been introduced in most of the states for which I have to state that there is nothing wrong in taking the lead as it is what we have to do sooner or later. Furthermore, we have the decision of empowered committee that the rate fixed at 4% will be reduce to 3% from Ist April this year and at 2% by the following year, and is expected to drop down at 0 by 2009.

As VAT is introduced in Mizoram, it is necessary to computerise every work for which central government provides Hardware and software at free of cost supply of the said materials is done by TATA consultancy Service Ltd. and network construction too is now being completed.

Regarding requirement of vehicle for the work, though the government introduced privatisation of Government Motor vehicle, it is to be noted that if taxatio department is accepted as one of the Enforcement departments in our state the needs for motor vehicle of the department has to be given a special consideration

Mr Speaker sir, it is further to be noted that even in the absence of trading regulation in Mizoram, we have appropriate system of registration under VAT.

Regarding the question of 'D' Form of CST Act, Rules for collection of revenue and restriction and penalty for evasion of tax is being prescribed. It is meant to give way for the department to be able to purchase the requirements at suitable rate.

## PU SAILOTHANGA SAILO

Mr Speaker Sir, it is to be noted that the absence of Trading Regulation is of a great loss for the state government as it gives illegal

traders free movement within Mizoram as the statement "Failure to register 29 "dealers led to evasion of tax of 60.93 Lakhs" indicates existence of illegal traders. It may, therefore be important for the government to give priority to introduction of Trading Regulation in Mizoram, otherwise illegal traders will increase at fast pace.

It is grateful that the government is giving priority to collection of revenue yet, we are having 60.93 lakhs of loss and is expecting to rise still unless Trading regulation is not made available with immediate effect.

Mr Speaker Sir, re-selling of any supply Contract order is strictly prohibited and this rule gives opportunity for local suppliers. Is

there any way to change the system so that local suppliers get favour from the concern authority?

## PU B. LALTHLENGLIANA MINISTER

Mr Speaker Sir, it is against the rule if 'D' form is used for purchase of non-other than

Departmental purchase and are liable for penalty under section 10 of CST 1956 which is of 6 years imprisonment. The department may need some sost of understandings of the concern people as we are now having problem due to a lack of enough staff.

Lastly, I want to express my appreciation to the constructive speeches made by 10 members. Matter that concern collection of revenue always causes a heated debate here in the House and it indicates our there concern for the welfare of the people and of the department our government too will determine each of the suggestion so that the best possible outcome is achieved. In parsuance of initiative taken during congress Ministry, building tax is slightly raised.

There is one good achievement which our opposition members do not mention. It is mutation. If the land is inherited from father to son for example, we fix a flat rate of Rs100/- whereas 5% of land value was taken earlier.

Hon'ble member Pu Zodintluanga alleged that list of tax rate shown may have been initiated from party office. It was only after three sittings that the draf was printed. But, as the rate was shown with comparative statement the book was so thick that we have it reprint without comparative statement. When various rates were fixed and considered, no political party gets involved. It was done so under my guidance.

Mr Deputy Speaker sir, the Minister is also, in charge of Printing & Stationery. But, I regret to say that he is not aware of the

## PU R. TLANGHMINGTHANGA MINISTER

Mr Deputy speaker, let me start with SAD. SAD is operate with five Major Heads such as Council of Minister, secretariat General

Service, Secretariat social service, secretariat Economic service and other social services. From the

 $\sim$ 

said major Heads. Pay of IV Grade upto Chief Ministers, TA/DA and vehicle Maintenance of officers and staff, Bill of electric, Phone and stationery is given Secretariat comprises of 194-Group-A Officers, 225-Group-B, 385 Group C, 338 Group D and 429 Muster Roll employees. Under SAD, there are 72 LMV and 7 Two-wheelers with quarterly Expenditure of POL amounting to 12.82 lakhs and almost the same amount for their maintenances. Since privatisation of Govenment Motor vehicle, our problem is being supplemented as neither driver nor fund is being improved.

Regarding maintenance of Telephone under SAD, there are 246 connections with the total bill for 2 months generally amounting to Rs. 400,000. In order to stop writing-off of telephone Connection due to delay of payment of Bill. I have approached officials of Telecom department to stop this practice and is now being considered. Besides, in order to reduce one consumption on telephone bill. We proposed to use EPABX to cannect all telephone users when the New secretariat Complex is made functional, Financial Authority also agreed with the proposal.

All pay bills of Government servants is submitted to Aizawl 'S' Treasury before 5 days of last working dray each month. Pay is usually drawn late, which is out of the authority of SAD. Some departments stay out of SAD complex as the complex could not confine all. The SAD does its best to keep cleanliness of the complex. The secretariat usually has office expenses for maintenance of the Secretariat complex as the concerned financial department could not take up such responsibility on ground of non-availability of fund for maintenance of the complex.

Demand no 29. Social Welfare Department, hon'ble Members had spoken about it. The purview of the Department is so wide that the State Government transplants Sethawn De-Addiction Centre into Referal Centre. Various training courses are conducted from time to time so that those healed may have profession to have self-sufficiency on this own. Instructors for various trades are required. A large scale project is now submitted to the Central Government for these purposes. If this project is granted by the central Government, Government's land at Thingdawl will be prepared for rehabilitation and training centre.

We will not be able to cover all steps taken by the Social Welfare Department. As this Department is connected with the Central Government, the state budget for it, was reduced for some years but now, it is raised up to Rs. 17 lakhs. I think we will know that we are inferior to Congress Ministry in the budget provision. Rs. 20 lakhs of budget provision is reduced to Rs. 5 lakhs. This causes difficulty to the Members in distribution of various articles from Social welfare Department.

And there is one scheme for socia-economic programme especially for poor and deprived women. Under this programme, such deprived woman are aided in cash or in kind. The Department also gives training on knitting and tailoring to such women. Such trainies are given Knitting or scroing machine after completion of their course. If the Department has enough fund Knitting and Sewing Machines can be provided to such poor women. Social Welfare department also has swamsida? Project for establishing women. The project is being started at Lunglei, Serchhip and Thenzawl Block. 601 self Help group have also been set up who engage in silk farming, gardening etc. State level steering committee has been established to quide such groups and women commission had been established since 1996-1997. And Women Commission Bill, 2004 has also been passed last year in the moth of November.

Various steps are also taken for the welfare of children especially among the Pre-Primary School who have no one to take care of them. Assistance is given to 28 motherles baby Homes and 8 branch YMA is also given assistance for those who have books for reading of the children Adoption Cell of this Department.

Different kinds of handicapped are given assistance. Not only that, but vocational training is also given to the handicapped person like Tailoring, knitting and shoe repairing. Training Centre for such skill is opened in Aizawl and Lunglei District. 863 students of handicapped is given assistance and 200 handicapped children are given pension. Unemployed allownce of Rs. 100 each is given per month to the registered handicapped children if they are not employed after two or three years. Resource Centre is set up from 2001 State Referal Centre and District Centre also had been set up. Through such centres study is conducted on various kinds of handicapped.

Welfare of old age and Destitute persons are also observed at old aged home at Luangmual. The work is carried on till date. Fine old aged is confined and looked after by the Department. And old aged pension of Rs. 100/- each is given to 10525 olaged. The amount of pension is proposed to be raised at Rs. 200/- by the Central Government.

Under National family benefit scheme, when a bread earnes of a family died, Rs. 10,000/- is given to the deceased family. 757 families are given such assistance during 2004-2006.

Remand Home is also set for the deliquent youths. The Home could cater 300 persons. It is specially prepared for under 18 years old. Various De-Addiction Centres are given Financial Assistance. Demand is now made to the Central Governent for such assistance Poultry farming, Piggery, electronic and motor mechanic training is given to them for After Care Centre.

Under Integrated Child Development scheme we, now, have 23 ICDS Project in the State. We also have 1592 Anganwadi now. The Central Building of Anganwadi are now improved. The Central Government wondered the quality of Anganwadi Centres. Good Nutrition is also given to children under 6 years and 1,65,122 pregnant women.

Under Tribal Welfare as per article 275 (1) of the constitution of India, various works have been completed in the State.

Hon'ble Speaker Sir, when I begin to look after Health Department. I informed Doctors and Nurses that we are not to neglect our duty as any other Department. I also informed them that they should inform me what the patients as well as the Hospital needed as I will not know what their requirements are as I am not a technician, and that they should use me as a tool for such thing. The Hon'ble Chief Minister and the Central Government too give importance to Health Department. I also informed them that it is needed to improve Aizawl Civil Hospital as the Referal Hospital has not yet functioned properly. Seventy nine (79) items have been purchased within the last two years that we are so proud of. But we need more improvement in different ways.

Regarding Public Health - State Government is responsible. The Department takes step earnestly for prevention and curing of the patients. The position of health care in Mizoram is the best of all in India. Now, we have 351 sub-centres. The criteria of Sub-Centre and PHC is 3000 population in the rural area and 7210 in the urban area. But in Mizoram, we have one sub-Centre per 2532 population. The criteria of PHC. is also 44,511 population but 15,589 population have a PHC. It is very pleasing to know such result.

The main problem of this Department is Building and Quarter. The Central Government informed us to make Project urgently for building and quarter knowing our problem. We also have 12 CHC. Some of them will be promoted to District Hospital. Then we will have 9 CHC. four Specialists Doctor each is proposed to be posted to each CHC. of which one specialist will be Anensthesian Doctor. Knowing the problem of PHC, 26 doctors are newly employed a few days ago

We want to make posting of doctors to PHC, but we could not do so now. Inedequacy of doctors and staff nurse is so high in the State as no post is created for seven years Knowing the problem of the Department, the Ho'ble Chief Minister requested me to make proposal as early as possible.

And 214 persons are newly recruited today. Out of which 28 are employed on regular basis and 136 on contract basis, Preference is given to the concerned Village people but not to doctors and nurses.

We know inedequacy of Medicine supply we expect that it will be improved this year as Rs. 3 crores is provided in the budget this year.

Regarding Baffacos, the Department is taking initative that can break out due to the increase in rat population on ground of bamboo flowering. The Documentary Film is prepared in detail to teach people.

Under Malaria Control Programme, the Department takes various steps to control Malaria and step is taken for spraying DDT in time. The department also distributes DDT soaked Mosquito net to the poor. Besides this, tablets for treating malaria is freely distributed to each District. The concerned officers will give the pills to the trustees person for further distribution.

Under T.B. Control programme, Twenty Seven Microscopic Centre is set up and medicine for T.B. is also freely given to the patients.

And Village Health Committee is also to be set up at each Sub-Centre under the Chairmanship of VCP. Health worker will be the Secretary and Treasurer of the Committee. Rs. 10,000/- will be given to the Committee every year.

And Rs. 20 lakhs is given to each of 9 CHC. By means of this fund tools and medicine will be improved.

I also want to inform the members that Rs. 52 crores is proposed for construction and repairing of quarters and office building. The Project Report has been submitted to the National Rural health Mission Bairabi Hospital will be re-constructed by means of this fund as desired by Pu Rintea.

Now, we are waiting sanction amouting to Rs. 135 lakhs for construction of four CHC. and Rs. 35 lakhs for construction of 12 PHC. 130 Sub-Centre Cum Quarters will be constructed at an estimate cost of Rs. 7.2 lakhs each

Proposal for upgradation of Health Worker Training School at Kulikawn, Aizawl is now under processed. Rs. 8.46 Crore is estimated for this proposal Hospital building and staff

quarters are proposed to be upgraded and the internal road will also be repaired. We expect approval of the said proposal from the Central Government shortly. There is another proposal for construction of State ware House, which will be used to presurve Medicines and equipments in which loading, unloading and packing facilities and cold storage will be there. Rs. 4.46 crore is estimated for this proposal. Detailed Project Report has also been submitted now.

Under NRHM (National Rural Health Mission) there are various schemes for BPL families. According to which Rs. 500/- will be given to a mother who gives birth to young ones pupto two children, besides this, additional Rs. 250/- can be given if Maternity is undergone in the Government Hospital. The said assistance can also be given to a mother upto third pregnancy if she is willing to be sterilised after giving birth to a baby. Another sanction of Rs. 1500/- is also there for those who norne a child through surgery. The following amount of financial assistance will also be given to a member from BPL Family.

Health Camp is also organised in various rural villages. Rs. 20,000/- is estimated for each Health Camp. Rs. 200/- can be sanctioned for referral Transport if a patient is referred from Health Camp to PHC. or bigger Hospital.

For implementation of national Cancer Control Programme, we now have oncology wing in the Civil Hospital Aizawl. We have bought new equipment for manography (breast Cancer). Cancer therapy unit will also be commissioned shortly. Rs 75 lakh had also been received from central to constitute Regional Cancer Society. We have submitted many new proposals to the Central Government relating to Cancer Control policy.

Steps for constitution of Accident and Trauma Centre is now going on at Serchhip and Kolasib Sanction had already arrived here. Telemedicine centre is also inaugurated by the hon'ble Chief Minister on 7<sup>th</sup> October, 2005, proposal for instalation of such centre at Lunglei, Saiha and Champhai is going on. In regard to Referral Hospital, the Ministry of DONOR have released 35.39 Crore out of 40 crore. We are now waiting for the last instalment only. In this regard, 96% of the physical work had been completed.

Upgradation of Civil Hospital. Lunglei upto two hundred bedded Hospital and Civil Hospital Saiha upto 100 bedded. Hospital is under processed.

Mr Deputy Speaker Sir, I have noted various points raised by the members in the matter of nutritions and I will enquire them. Today. I beg leave of the House to pass my demands :

# PU R. TLANGHMINGTHANGA:Thank you, Mr Deputy Speaker Sir.MINISTER:Now, we will call upon Dr. Lalzama, hon'ble<br/>Minister to wind up his demands and let him<br/>beg leave of the House to pass them.DR LALZAMA:Mr Deputy Speaker Sir, I would like to exp-

ress my thanks to Members who speak about my demands. First of all let me speak

about Higher & Technical Education Department The budget allocated for this Department is greatly increased due to the efforts of the hon'ble Chief Minister. I, therefore, hope that many problems due to lack of money will be solved. As we know that we have passed ICFAI university Bill to introduce various technical and job oriented educations in Mizoram. As I have said on the day when we discussed the said Bill, precautious Measures would be taken in this regard. In regarto filling up of Vice Chancellor's post of Mizoram University we try our level best for early filling up of this post. We have made recommendation of Mizo professor to occupy this important post.

MINISTER

In regard to quality Education, we have constituted State level Quality Assurance Co-ordination Committee for the whole state. Besides this, we have Quality Assurance cell within the Directorate office and Internal Quality Assurance cell in various colleges. We have approached the National Assessment and Accreditation Council at Bangalore to make assessment of various Colleges in Mizoram According to which, Government Aizawl College, Government Champhai College and Aizawl West College had become Accredited Colleges. We are proud of them. Assessment is expected for other Colleges also.In regard to permanent affiliation, all Govrnment colleges have had affiliation and step is still being taken for other 12 deficit colleges also. Permanent affiliation and is very important to be able to get aid from U.G.C.

Scholarship is given to students. During the year 2005-2006 Rs. 876 lakh is sanctioned to 21277 students Rs. 130 lakh is now awaited. We hope that sanction would be made in the month of April this year. Besides this, there is Post Matric Merit Scholarship, during this year Rs 8.8 lakh is spent for Merit Scholarship. Incentive cash award of Rs. 5000/- each is given to those who get through Preliminary examination of Central Civil services. During this current year, Rs. 3 lakh has been spent for this purpose. Hindi Training College is also shifted to Durtlang Vengthar at its own building. Additional grant to complete the building has now been released by the Central Government

In regard to Technical Education we have Technical cell in the Directorate office which conducted entrance test to join various techical causes every year. We heard about the condition of college building at Saiha, Steps are taken now to contruct new building. We have submitted proposal to the central Government and now sanction is still awaited. In Serchhip College and Kolasib College Bachelor of Computer Application (BCA) course is introduced from this year and approval has also been received from the University for this purpose. The said course will be funded by N.E.C.

Now, coming to Excise Department, according to Section 55 of MLTP. Act, verybody has right to arrest drunkards, Liquor sellers and those who involve in abusive drugs. The Departmet works very hard to enforce Total Prohibition Act, inspite of this we ask for help and coordination from various NGO'S and Churches. Such good coordination greatly help the Government to enforce the said MLTP Act better than before. This Department has no a building of its own, private building has been rented for many years. But, now, construction of building for Excise Department is going on quickly. It will have a separate building of its own shortly. Recently we received aid from the central Government to strengthen Excise Department, such as 3 Gypsy King vehicles, 5 Motorcycles, 5 Radio repeator sets and 5 Motorola handsets. All these new equipments greatly help us to work better.

Next, coming to Art & Culture Department, various steps are taken to preserve our culture. Cultural Meet have been organised at various places. Chapchar Kut is also organised every year to revive our culture. Rs. 7,89,215/- has been given during last year to 23 writers through the Mizoram Publication Board. A Mizo Pavillion is also created at shilpagram in Guwahati to display and sell Mizo handicraft products, which is inaugurated by the hon'ble Prime Minister on 17.1.2006. Besides the above, Seminar had also been organised many times, Hollow Guiter, P.A. Set, Gong Set, Vakiria, Traditional Dress set, etc. are also subsidesed for various NGO'S and Cultural organisations. Rs. 1,01,500/- is spent to preserve historical sites.

During last year, Chief Minister Running Trophy Cultural Dance competition was organised in which Rs. 1,45,000/- was spent. To promote Mizo youths in the sphere of Drama and for promotion of National integration, Drama clubs and Cultural Troops were sent out to other states which were totally funded by the Central Government through NEZCC. When the President of India visited Mizoram last year, Cultural Programme was organised. He was very pleased and he sent Rs. 50,000/- to us.

Our ongoing project is construction of cultural complex at Berawtlang funded by the Cultural Ministry of the Central Government. 98% of the construction work has been completed now. We are given a site for State Library at new Capital complex, we have received a sanction of Rs. 1.25 crore from Rajaram Moha Roy Library foundation. Construction of Library building will be started shortly. Besides, construction of a building for State Museum at Berawtlang will also be started during this coming financial year.

Under R.R.L.F. (Rajaram Mohan Roy Library Foundation) 425 Libraries in Mizoram are provided furnitures at the cost of Rs. 2,50,000/- Such Libraries are mostly ran by various Y.M.A. Branches. Our state Museum is also greatly enriched by the Indian Museum, Kolkata. Gandhi Memorial Higher Secondary School Museum at Champhai will also be equipped by the Indian Museum, Kolkata. The work has now been started. During last year, the same agency had developed Museum Gallery at Saikuti Hall, Lunglei to become District Museum. This Museum will be inaugurated shortly.
