PU NIHAR KANTI CHAKMA :

Pu Speaker, ka lawm e. I am happy to participate in the General Discussion on the Budget for the year 2006-2007 presented by the Hon'ble Chief Minister on 14<sup>th</sup> March, 2006.

Since, it is the General Discussion Pu Speaker, I'll take the advantage to speak some of the problem faced by our people due to International Border Fencing. Pu Speaker, as you know that Border fencing is under construction. As you know Sir Mizoram shares near about 318 kms International Border with Bangladesh. And this 318 km will be fenced by 2007. What I would like to inform is that people in general were not opposed to the fencing but the problem is that this fencing destroyed vast tracts of cultivable land including agricultural lands houses were destroyed and even garden were destroyed. So, the people in the western belt of Mizoram who are residing particularly the Chakmak along the western border will be affected. As per the instruction of the Home Ministry fencing would be constructed one fifty yard inside the actual boundary then, our people are living enact within the range of this one fifty yard. So Pu Speaker, here is one question, one thing we must remember is we have to resettle this people and how to resettle them even the Govt. also does not know anything about the fencing. I spoke to the Chief Minister regarding the compensation and I have requested the Hon'ble Chief Minister and Revenue Minister also to send the Revenue Officer for assessing the damage carried by the fencing. As per the report available to me, the Home Ministry Govt. of India has allotted this fencing work to 4 different companies. No 1 ie. Engineering Project India Ltd (40kms) Demagiri to Mauzam and 2) National project construction corporation NPCC under water resource Ministry from Tlabung to Jamulsuri (55kms) and the third is the Border Road organisation (70 km) from Jamulsuri to Parva. The rate is allotted to NBCC. Pu Speaker, the fencing is already under construction what I mean to say is the people are in panic because their cultivable land were destroyed. Yesterday I received a message from Marpara NBCC destroy the House while constructing the fencing.

Therefore, it also damages to the vast tracts of cultivable land due to which one has to lose its livelihood. I would like to say here that many villages even within my area will remain outside the fencing e.g. the Villages like Nunsury Tablabagh, Kalapani, Likhisuri, some part of all these villages will remain outside the fencing, now what will be condition of those villages after the construction of Fencing. Even in the Buarpu Constituency, Tarabonia Village will remain outside the fencing. Now the Govt. should take the initiative. And 2 request that Govt. of Mizoram to send the team of legislators to assesses the villagers and how to re-settle them inside the Boundary. As we know that Karnapuli is the main source of River and we are using the River Karnafully as a cheapest means of Transport, also for drinking, for bathing, if fencing all these facilities. Therefore, Govt. should come forward before fencing is completed. All these Govt. facilities should be made available. So that they can happily settle in their respective places.

Pu Speaker, the Govt. should take the appropriate action regarding this. It is a sad things in the Governor Address, the Governor did not mention anything about the Fencing. And the matter is very serious and urgent intervention of the Govt. is required Pu Speaker !

Since yesterday, I've been hearing Ruling and the opposition were charging against each other regarding conduct of V.C election the ruling Party must bear that money involvement in this election is very high. The more you spent the money, the more correct you become ! eg. If the Candidate spent more than his capacity after winning the election he will try to recover all those money so it use the corrupt practices we are enjoying the fruit of Democracy, if we enjoy the Democracy in a corrupt way we can never be devoted! Pu Speaker, Lastly before the presentation of the Budget as the representative of people we expect that some development activities considering our constituencies. But when budget is presented we see nothing the budget has given importance the collection of taxes like collection of tools roads & bridges in the form of water less in Minor Irrigation, this surely will effect the common people Pu Speaker, in a simple language in the Rural Area the people differentiate Budget, good Budget and bad Budget. If money reaches to the common poor people it is considered a good budget. The sums money does not reach to the Rural people, this budget is a bad budget in a simple term, Pu Speaker, but the Rural people has got some relief after passing the National Rural employment granted scheme by the Hon'ble Prime Minister Dr. Manmohan Singh under the guidance of Mrs Sonia Gandhi. I Congratulate them it will gratefully help the rural people at least they will be getting some employment for about 100 days. With these few lines Pu Speaker, I conclude my discussion thank you.
