Kan remtih tlan kha chu a bi tuk bawk a kal leh kha a ni. I kal tawh lo mai ang u. Naktukah hum kannei tho a, tihna a bi (SPEAKER : I sawi turah lut tawh rawh)

Pu Speaker kan ngaihdan a lo in ang lova, a pawi hle a. Hei Mizoram State puitling Governor in a thusawi sawi ho na a dimg leh thei tura Pathian in hlawhlinna min pek avang te Tin, chu Pathian duhsakna mipui te atanga rawn lang chhuak a ni a. Tichuan Pathian hnemah te, min thlangtu mipui hnemah te, tin, thusawina hun min po tu Speaker zahawm tak hnemah a hmasa in lawmthu ka sawi ani.

Kan duhzaung sawi dawn ila a tam viau dawn a, tin, tawng-kam thiam loh nen, hun neih loh nen, ka thu rawn sawi tur hi a bul viau ang tih ka hlaw hle a, chu ehu a ngaithla tu ten min ngaihna thiam ka dil hmasa eni.

Governor thusawi hi a tlangpuiin a lawmawm a, ka zuk lawm em em na chhan chu tunhma hun rei lo te chhunga Sorkar na lo chelh tu ten a bik takin Congress Ministry Pu Lalthan-hawla hruai thil lo tih tawh te kha 1986 a L.G. in a sawi tak rawn sawiinawn lehna tam tak aum hian kha Sorkar kal ta kha duh thudam nilo mahse, mipui te duhzawng zawng zawng ti thei kher lo mahse, a thil tih tawh hun rei lo te a mi kha pawm tlak a niin sawi chhawn leh tlak a ni tih a ti lang chiang niin ka hria a, min ti lawm-tak zet a.

1986 a L.G. thusawi phek 11 na leh tuna Governor thusawi phek 17 na kha han en in Police chungchang te kha thil pakhat ani. Tunhma a a lo sawi tawh te kha a rawn sawi nawn lsh tih na a ni a. Chu chu engatinge a sawi nawn ka tihna a ni awzawng lo, sawi nawn leh tlak a thil an lo tih ve kha a rawn sawi nawn leh avangin a lawmawm ka tihna a ni a. Tin, tunhma pawh a lang ngai zen zen lo, Mizoram Minority te ngaihsak an nih bik tur zia te, District Councilin a pawisa a tawk an naih tur thu te a rawn sawi lang a. Hetiang thusawina hi 1979 ah L.G. thusawi ah khan a tel tawh niin ka hria a, 'No stone will be late to develop the District Council Area' tih ni ta in ka hria a thu kha a tha em em mai a. Mahse, a thu a that ang hu khan khilam ngaihsakna kha a aum teh chiam lo niin hum kal ta ah khan ka hria a. Khatiang helai a in ziak tha em em si, a tak tak a tih lem lohna hun kan lo kal pelh tawh avangin khatiang dinhmun a kan din leh loh nan tuna Sorkar hian tuna a in ziak ang ngei hian hnam te inau zawk te chawikan tumna leh ngaihven bikna te neih zel tura an in tiamna ang hian a tak tak in an kal ang tih ka ring tlat a. Chung te chuan min ti lawm em em a.

Tin, chubakah chuanpawisa hman dik loh hlauhna te Naupang chem te hriam ken tir a hlauh-aum ang a pawisa tam zawk te, District Council kuta dah hi hlauhawmna/hlauh thawnna te a aum thei a, chu chu kan House leh Sorkar hian hria se ka tih em em mai a ni. Khi mi tlem te an hmandan te han ngaihtuah khian State Sorkar leh U.T. Sorkar te kal phoung ai hian a hlaulk ani. An zavai chuan an tha vek io a ni mai thei, an tam zawkah chuan an ti tha zawk a ni tih kan Sorkar hian hria se ka duh a. Pawisa tam zawk pek pawh in a hman dan dik tak in an hmang thei ang a. Tuna an pawisa tlem te a an kawnglaih te, an In sak te khi Mizoram Sorkar tih aiin a tha zawk emaw tih turin a pawisa tlam zia ngaihtuahin a aum ani. Chuvangin Khatiang hlauhthawnna kha kan Sorkar rilru ah hian aum lo hram se tih sawi ka duh a ni.

Tin, Governor Address ah hian ka rilru a ka vesi ve, keini ta ila lawmthu sawi nan ka hmang tur a, ka rin tel lo pahnih a aum a, lawmthu anih loh pawh a sawi tel ngei tur a ka hriat chu Saitual Incident hi a ni.

Saitual Incident hi a tunge dik a dik lo tih chu Court robelna kal mek in a rawn fish mai dawn a. Hetiang thil thæng ngai lo, lo thleng ta chu a pawi kan tih thu emaw, Governor hian a sawi tel tha in ka hria. Nining kan thusawi tawh te ngaihtuahin Saitual mipui te kha an dik zawk niin kan sawi thei a. A dik zawk anih chuan an tan loh dan ngeihtuah aum tek? An chhuah vek theih dan te a aum em? An dik zawk anih si chuan. Tin, chhuah vek thei lo kan nih rih pawhin an tan hi pawi kan tih zia te, a thi a te chhung kan tuerpuí thu te kan Governor hian engatinge a sawi tel Ich ka ti rilru a.

Tin, Cachar leh Mizoram in rina lai vel te khæan harsatna an tawk thin a, khú khu tunhma atanga kan buaipui nasa tawh a, kan hriat angin 1904, 1930, 1933 vela ramri Reservo Forest an rawn siam leh 1887 vol a an siam kha a in ang ta lova, a kum kha ka hriat sual palh chuan min lo ngaidam ula. Tuna Mizoram in Memorandum hial an thehluhna an tlawh chhan kha chu British rorelna hnuai Reservo Forest an rawn siam kha 1887/1897 kha mi tan chhan kha a ni a. Khami tan chhan kha a ni a, Khumi tuna Reserve Forest Area Mizoram leh Cachar in a tu ram bik mah nilo Resorce anga an paum khu Square Miles 509 vol ni ta in ka hria, tuna Cachar in a kan ram an rawn tih tak hmunah chuan Reserve chu SQ. Miles 217 awrh chauh a ni tawh a. Khatiang khan an rawn nek nasa tawh a. Khami mi in chuhna kha nasa tak a ni a, khu lai a mi te khu an mangang a ni. Chumi an mangan thu te chu an rawn thlen tawh a. Chung te chu ong ong a chin fel tur nge, M.N.F. leh India Sorkar in biakrem lai khan heng te hi rawn chingfel tak maw? An chinfel a tan tiin dahna te pawh a aum ani. Khang kha an mahni silai non emaw a in do tur an tih laia an in remlai khan an sawifel leh chuan midang tan chuan sawifel a har tawh a, thil kel rei tsuh mih vangin chutah chuan Mizo mipui te pawhin bescime nasa tak an lo nei a, mahse, chinfel hleihtheih lohin a lo aum ta a, harsatna an noih vangah ngai ila, baeng a pawh nise khulci misui chengte khuan harsatna an tawk tih chu hai rual a ni lo a ni. Chung te chu engomaw zawng tala Governor Speech oh hian rawn tel theih dan aum sela chy kan mipui te thlepheng hadin vo nañ tih theih tak tak nei rih lo mah ila, kan mipui te mangang thlepheng chu kan hauh a ngai eng a, chu chu engatinge a rawn telh loh tih ka ngaihtuah a, mahni mimal ngaih pauimewh zawng ka rawn sawi ve a.

Tin, chu loh vah chuan lawmthu sawi naah khan engatinge thu sawi na ah khan engatinge Mizo mipui te Governor hian tun a MNF Sorkar na siam thei tura thlang thei tu mipui te hma ah hian lawmthu kam khat tal a sawi tel ve loh? Kan hriat tur a chu Governor kan tih hian ama rilru kha rawn sawi chhuak ta maiah kan ngai palh ang tih ka hlae deuh a. Sorkar in a han duang chhin vek a, Sorkar in tha tawk ang a a hriat chu Governor hian sawi chhuak ta ah ngai ila, chu chu dan kal phung pangai a ni a. Chutiang anih si chuan engatinge kan Governor hian lawmthu mipui te hmcah hian a sawi loh? Heti zawng hian ka ngaihtuah a, Mizoram mipui tam zawk te hian tun a kan Chief Minister leh kan MNF President ni bawk Pu Laldenga ah hian rinna a nghat tak tak ani tih hi a chiang a.

Chumi ka zu sawi theihna chu tunhma khan Mizo hnam damna kha Independent ah zalenna a aum ang a an sawi lai khan an awih ani. Tunah hian khatiang kha a lo ni ta lova, hnam damna chu mipui te rilru ah zawk hian a ni a aum ni, ti a an rawn sawi hnu ah pawh hian anu tak maw an ti loh thei ta a. Khatiang khawpa thuawih thei amah ah rinna ngat thei mipui te hmaah khan kamkhat tal chuan lawmthu sawi tur ani. Governor hian engatinge a sawi loh? ka ti a.

Chumi laemthu sawi tel lohna leh thil pawimawh dang pahnih tel lo kha, keima mimal in ka ngaihmawh sawi tel hram a tan tha a ka hriat a ni.

Tin, a then in Pu Lalthanhawla hming sawi lan leh lan lovah in hnialna te a aum a. Khami a in ziakdan chiah ngaihtuah hian Pu Speaker, a hming zu sawi lan leh lan loh chungchang ah khan keipawh khan engatinge a sawi lan loh ka ti a. Mahse khami lawmthu Prime Minister leh Chief Minister hnena lawmthu a zu sawi na hi chu The Accord truly Answer the aspiration of the people of Mizoram tih lai tak hi an mahni pahnih hnena lawmthu sawina chhan kha niin a lang ta a, in biakremna kha nilovin in biakremna thu ah nise Pu Lalthanhawla hming hi enga-tinge a tel ve loh? tih kha a dik ka ti a. Mahse, Accord kha truly answer an i love, tih kha chukan rem ti tiang niin a lang a, truly answers anih lohna laiah kha chuan Pu Lalthanhawla tel lo chu a pawina a aum lem love, tin ka in hnem chawp a. Amaherawhchu sawi lan a lo nih tak ah chuan Pu Lalthanhawlan Chief Minister nihna a lo ken te hi ken tak tak a ni love, a hleh ve chauh an i ti te in sawi a ni a. Chutiang zawnga an sawi ka hriat chuan a dikna lai zawng a aum e, an ho tu te thu a awih avanga lo kian mai a ni, a pu thu a awih vang an i te an ti. Engpawh nise a kenna rilru zawk kha zuk ngaih pawimawh tur niin ka hre zawk a.

Ka ngaihtuah thin a, tunhma Desaia hun laia, tuna kan Chief Minister zahawm tak Pu Laldonga a tan tirk lai hun te ka zuk ngaihtuah a, khatia Desaia thikthu chhe lutuk tuman a biak pawh an biak ngam loh lai a a bail chhuah chungchang te ka ngaihtuah a. Tin, a Chief Minister nihna chu romna leh muanna a aum dawn chuan ka kian phal e, a ti a, a lo kian leh ta a. Deputy C.M. ah a tla thla ta a. Chu chu an ho tu te thu a awih vang a lawm maw le, ti tawk te kan la aum a, a enga pawh chu a chhan ni ta se, hotu te thu a awih vang emaw, engvang pawh lo ni ta sola a in pek phalna leh Remna leh Muanna avanga an lo beih hram hramna kha chu tha kan ti in lawm nachang kan hre tur niin ka hria. Chumi lawm nachang kan hriat loh na a, amah kha engmah lova kan zuk dah luat tukna hian in ka rilru ah kan fak hla sak thin 'Hmangaih Pathian a thunlung ah chuan eng angin na ang maw? ti ang deuh khan amah a tuartu rilru ah chuan a na viau niin ka ring thin a ni. 'A na lua e, lungmaul ksei ka tuar an ' kan ti zawk dawn nge?

Chuvengin hetiang zewng a insawi lova, mihrisg rilru a ni a, in fakder ve na to, in lawm der ve na te hi kan phut a ni. Chu chu ken beisein an beisei ani. Chutiang reng reng aum lova he tu te thunwi theih avanga kian ta mai ang a in sawi hi a dik la ani.

A dik takin a dinhmunrah hian Zuk in diftir ta ila, khatiang a MNF leh India Sorkar an in do vanglei a mipui kan harsat zia ngeaituahna an in biak remna apiang eh kan lungawi ang tiin ban a tul pawhin kan beng ang, nihna ken a tul pawhin kan kian ang a lo ti a. Chuvengin Pu Speaker, Kan Leader a aum leh avangin hun min pek belh in ka sawi zo law law ang e, minute 5 a sawi zauh ka tum ang.

Khatiang khawpa a lo in pek ve na kha, mimal duhsak thil ani lo. Mizoram mipui te hmangaihna leh Mizoram mipui te harsatna tih kian tumna rilru atanga hetiang thil hi lo aum a ni. Tawngkam tal a in fak leh in chawimawi hi chu a phu ve niin ka hria.

Tin, in pu, kan pu India Prime Minister khu tuma Pu bik a ni lova. India ram chhunga kan aum a, India ram hi kan ram ani tih kan paum si chuan India ram mipui te Pu a ni. Khu khu kan pawmitlan a, en duhsakna kan dawn hian Mizoramah hian kan tum kan hien dawn chauh a ni tih i hria ang u. Pu Speaker, a point ah ka lut ang a, ka point bera orawh chu hei hi a ni (SPEAKER : Ngati tawh rawh)

Pu Speaker, Ammendment ka dil a, i thil tih theihna in min phal a, kan dan bu 18na hi kan kou chnai ila, hei hian a phal em em mai a.
