The government urgently required the same for Consideration of the senior and selection grade post, the information should reach this Department on or before 15.11.1994 number of Group 'D' employees one who had rendered five years or less of service to who have rendered more than 5 years but below 11 years of service No 3 who have rendered more than 10 years but less than 16 years service. No 4 who have put more than 15 years of service. signed by under Secretary to the Government of Mizoram. Department of Personnel and Administrative Reforms. My point is when the initiative was already taken by the previous government what I wish is that the process must be completed, without further delay you may say that it was initiated by the previous government the present has abandoned so many projects like NLUP although we criticize. But what the government is doing is up thus.

On this point, particularly, I think that the process must be completed because this is regarding the Group D staffs who draw less pay than any other government servant, who do not have promotion scope, who do not enjoy much financial benefit. . . . Mr. Speaker, Sir, when the MNF had amended their salaries and allowances so many times in this House why not that we consider the demand of the Group D staff so that they can have more dignity and financial benefit with this view I fully support and wish all the legislators to come forward and support this resolution and I would like to request the government to complete the initiative taken by the previous government and fulfill the demand of the Group D staff.
