I would like to read in the chapter 6, levy of betterment Tax after the Bill prepared here under section 32(1) Where the Highway Authority is of the opinion that the value of land in the area in its charge is likely to increase as a result of the development of public expense of any area adjoining a highway, it may with the previous consent of the State Government, decide to levy a betterment tax in respect of such area. This particular programme, I think it may be very difficult to implement. That is my apprehension. Now you want to impose a betterment tax for the Highway constructed. Whether it is a district or state Highway. My point is that we have national Highway the breadth of the Mizoram state, till today, betterment tax has not been imposed but this will impose betterment tax along the roads constructed, whatever we declare a national highway. Now, for example, Aizawl-Thenzawl-Lunglei Road, those persons whose lands are along the road falling along the road, when the road is completed the department will say that we have improved the road now, your land has been increased who is the authority to determine the road, the value of the land. In Mizoram, the present practice is land revenue is determined the revenue department, classification an siam anga, Tax chu an impose dawn a ni, betterment tax kha pek a ngai ang.
