PU NIHAR KANTI CHAKMA : Pu Dy. Speaker, tlem ka lo sawi ve ang
e. Today, we are participating in a
General Discussion of the Budget
Presented by the Hon'ble Minister.

Pu Dy. Speaker, although this government has already completed more than four years if we analyse their achievement specially in my constituency it has completely failed. It fails to provide even the basic necessities like Health Care, Electricity, Education even in a Road Communication. In the field of Education Tlabung Constituency still remain backward. This government after completion of 4 years in office, it did not improved the education facilities. You'll be surprise to know Pu Dy. Speaker, that not a single school, High School or Middle School have been upgraded, even the Tlabung Govt. High School has not been upgraded into 10+2 system. Most of the Primary School in my constituency are run by single teacher, the condition is very worst because sometimes three single teachers are engaged in a census or election purposes. During that period, the school remained closed, who is the sufferer? student's is the sufferer most. Even I reported to the higher authorities many times but the concerned minister did not take any action. How will we develop, even the Govt. has failed to carry programme of Universalisation of education. If this is the condition, how will we develop the education. Although, in some villages, where there is no school some building construction is going on under the S.S.A but if the teacher is not appointment what is the use of constructing the school. We cannot develop education by constructing a school. I request the teacher should be appointed in those Primary School which is under construction.

Pu Dy. Speaker, let's come to the Food & Civil Supplies Department not to mention of this ensuring ability of food grains, supply deptt. has closed down the Godown at Malsuri Village which falls within in my constituency, the reason best known by the Deptt. itself. People are sufferer and lossers there is no stock of food grain at Tlabung Godown, rainy reason will start very soon; no arrangement has been done till now. As you know this Malsuri which is near about 60 KM from Tlabung. Godown has also been closed down and its building has been already auctioned. This is against the wishes of the locality of the people. I request the Hon'ble Minister who is sitting here today to reconsider his decision.

And I would like to say previously Metrological Department have been functioning at Tlabung with its inspector at its head but now the office has already been closed, only signboard is there. It is very unfortunate most of the retailer within my constituency does not distribute the foodgrain within the respective places. During the question hour I asked the Hon'ble Minister, How many BPL Family in my constituency? The second question is that here is the complain from the general public within my area, regarding the non-distribution of food grains to the BPL Family. What is the reason if I am not mistaken. The retailer has been given to the MNF Worker, and they sold it in the open market. What is the reason, so I request to the Hon'ble Minister to rectify.

There is one more grievance in my constituency and most of the people who are genuine Indian citizens. Even their name had been in the E/Roll. I made complain many times still it has not been issued Ration Card to the genuine indian citizens.

In regard to the Mizoram Intodelhna Project, two villages has been selected within my constituency, for getting my given beneficiery. Tlabung has already been received first instalment. But Tuichawng has not received till now.

And in regard to the Electricity. Electricity is very worse in my constituency. I spoke many times electricity is very irregular, when we need they don't give the electricity. Pu Dy. Speaker thil pakhat mak lutuk chu ka mamawh lain current hi a awm ngailo. Ka mamawh loh lain a awm leh flat thin. This is very serious. Entirman - Tlabungah thingtlang a ni a, chhunaah a hun loh lai chuan current a awm tha khawp mai. Mahse, zanaah dar 4 atangin dar 9 thlang a awm ngailo. Zanaah dar 9 atangin current chu a tha lutuk, mamawh loh lai a ni a. This, Hon'ble Chief Minister, who is in-charge of the electricity department may kindly note the problem. And in my villages transformers are lying useless without being repaired.

And in regard to health care facilities, health minister is not here. It would have been appropriate had he been here. In the health care facilities Tlabung is still far behind compared to other places in Mizoram. Previously there was SDM & HO, two medical officer, one dental surgeon, one X-ray technician and many other nurses. But after the MNF govt. came to power at present in the whole hospital there is only one medical officer. I request this SDMHO, Dental surgeon and X-ray technician to be transferred as early as possible. I also request for a health worker, my previous speaker has said that most of the health workers are not stationed at their respective places. And I do not know. I even raised the question in the Assembly that there is a Sub-centre at Puankhai but the health worker is not there. This is the condition of the health care facilities in my constituency. Pu Dy. Speaker, here I must convey my sincere thanks to the Durtlang Hospital authorities and doctor for organising eye-camp at Chawngte(L), Tlabung and many of them have been successfully operated.

Rural Development, I express my grievances many times here in this House. That is why I don't want to speak again and again. Most of the border area development programme schemes taken within my constituency are worse. Local people are not benefited I would like to comment some of this schemes as per government report I would like to mention here, the financial and physical performance within my constituency during the 1990-2000. No. I - construction of Jeepable Road from Chawngte(L) to Hmunthar. It is nearly about 12 Kms I personally went. Even jungle cutting also has not been done, who has done the work? And in this way, there are many schemes, which is not implemented properly. If we go and spending money in this way, Mizoram can never be developed, if we get crore of rupees also if we go and implementing in this way.

My areas can never be developed, and you'll be surprised to know construction of Truckable road from Tlabung to Chawilung. Which is given 8 lakhs and here on the paper, it is achieved. Construction of Jeepable road from Rualalung to Zehte, ten lakhs in the paper. So this is the way of the implementing the BADP Scheme, the matter should be investigated

Lastly, Pu Dy. Speaker, it is a well come news that EPIC Scheme is under progress. It is a welcome news that Electors Photo Identity Card Scheme is under progress. And hear I would like to express my deep dissatisfaction on behalf of the people of Tlabung that still many of the voters within my constituency has been illegally deleted in the recently concluded revision. This is the 2003 revision even from the draft rule near about 60 people has been deleted. This is against violation of the rules 21'A' of the peoples representative act 1960. I made even without any objection from many quarters. Thank you.
