Pu Deputy Speaker, today it really gives me immense pleasure to speak out and convey my sincere thanks to the Hon'ble Minister and the Official staff who had taken great pain in introducing the Mizoram Education Bill, 2003.

Pu Deputy Speaker, I want to get some clarification from the Hon'ble Minister, Chapter II No. 4 is recognition and affiliation of Educational institution for the purpose of public examination had been recognised educational institution shall be affiliated to the Board. In my constituency, some of the schools which follow the Bengali medium of instruction affiliated by the Board, they do not appear for the Board Examination like PSLC and Middle School Leaving Certificate. Most of the School combine together and conduct the exam by themselves. Some students are facing some difficulties

because passing most of School. I think that the certificate shall Bengali Medium Certificate has been issued by the respective Schools. So here, in case, a Board can some re-arrange for giving the certificate. Even though, date of conduct examination. So, I think if this Bill is passed, Bengali Medium School may face some problem. As ofspecially in my area, there are more than 21 single Teacher Primary School and even in the Middle School. Some of Middle School, there is no Headmaster. If this Village pass, I think it will bring some development in the field of education and also it will try to decrease the balance between rural area and urban area. Therefore, Pu Deputy Speaker, I vote hardly support the Bill and I also request the Hon,ble Members to discuss any more and let it be passed. Thank you.
