PU C. LALRINSANGA : Pu Speaker, Saitual bialtu MINISTER zahawm tak pu R.Lalzirliana zawhna (a) Eirawngbawlna cooking gas agent distributor hi Mizoram ah hian engzatnge kan neih, hengte hian sub-agent an nei leh chhawng vek em tih chhanna chu Zoramah gas cooking agent 19 an awm a. Heng agent te hian sub-agent an nei chhawng lo. Mahse extension point hmun hrang hrangah te

dahin chungah chuan gas hi pek an ni a. Sub-agent a dah hi Company in a remti lo a ni. Tin, (b) Aizawl khawpuiin cooking gas kan hmuh that ang hian hmun dangah an hmu tha ve em tih chhanna chu Mizoram hmun dangah pawh Aizawl ang bawkin gas an hmu tha in kan hria.

PU R. LALZIRLIANA : Pu Speaker, Sub-Agent awm thiango lo tih kha ka hresual anih loh chuan min chhanna a ni a. 1999-2000 chho velah khan gas agent tur 25 IOC khan minrawn phalsak a. Chumi minrawn phalsak ang chuan tih anih loh yang a niin ka hria a. I think it has been a continuous process, but why uptill now the claim has not been settled? This is the main issue. Here, the present government has to clarify to this house clearly, There are how many claim at present, settled and excepted by the government of Mizoram how many submitted claims to the Government of India for sanction.

Can I said that three types of claims, one claim is for house damaged another is land rent and the third category will be loss of life.

pu Speaker, let this house be cleared on all these points, the number of claims already excepted and not paid till today, we all know many claims have been settled by the previous governments, the privious MNF Government the previous Congress government and may be the present government also, but how many claims are yet to be settled, unless we go to the government of India with number and claims for their sanction, I think this issue will go on in future, this number of claim settle this year, another claim will come, that government of India will not except, Now, PAMRA case, let us take PAMRA case, as we know it has been brought to the notice of Govt. of India also that money has been given but there is lot of complain of non-receipt in full, I would like to demand from the government why, this kind of irregularities could not be proved, why the claim of non receipt could not be proved, I belived that government has instituted an inquiry but the inquiry could not settle the cases of non-receipt of money already paid. About the resolution whether I support or not, will tell you later on, let the government, the Minister concern clearly mention the numbers of cases pending at present and excepted by the government of Mizoram and submitted to the Government.

pu Speaker, the second point, the timing of the resolution Hon'ble Leader of Opposition has submitted this Resolution but the timing of the Resolution is a bit late for the government and for this House. Had this resolution submitted some time in 1999 or 2000, there would have been sufficient time to consider by this House to move jointly to the Government of Mizoram for the early solution of this problem. But, after 2/3 months we are going to the polls. If we pass today it will be in the hands of new Assembly. I think the timing of the Resolution is not correct. However, it is very welcome.

The Hon'ble Minister has mentioned that some Congress leader has complained space to think this allegation is baseless. The Congress has signed the Memorandum of Settlement with the MNF with sincere altitude. Here, he himself mention the provisions.

this kind of politicalisations of this cases will not bring any fruitful result. Don't blame any party, if we want to blame any political party or government it is the MNF government and MNF party. They were in the government last time. Now also we do not have a government in the Centre. Why does the Chief Minister all the time boast that he can bring money. Why this government cannot settle this memorandum of settlement within 5 years, they have not succeeded I think they themselves neglected. The government should not politicalise this issue. I support this resolution whole heartedly. Let this matter be settled once and for all.
