MINISTER

: Pu Speaker, Starred Question No. 78-na chhanna chu - a zawnha kha Rural Development Block NLUP in a la covered loh te hi chawi khawi te nge tih a ni a. Pakhatna ah chuan Bunghmun R.D.Block, pahnihna-ah chuan Hnathial R.D.Block, pathumna ah Darlawn R.D.Block, palina Lawngtlai R.D.Block, pangana Chawngte R.D.Block, parukna Sangau R.D.Block, pasarihna Aibawk R.D.Block, pariatna Tuipang R.D.Block, Additional R.D.Block Phullen tiamin pakua an ni.

Tin, (b) na-ah khan, heng te hi Sorkarin a la implement lohna-ah te hian implement tumna a awm em ? tih a ni a. Government chuanin heng ho a la dover ve loh ho hi NLUP a cover tir tum rih loh a ni, thil-dang ngaihtuah mek a nih avangin.

PU NIRUPAM CHAKMA

: Pu Speaker, Supplementary Question Pu Speaker, we had 24 development blocks in Mizoram, out of these, it is reported that 11 blocks have already been covered under this scheme, another 9 blocks is yet to be covered. Where as the people in the present 12 Development Blocks already enjoyed the implementation of this scheme, why should the new government deprive the same facilities to the others 12 Development Blocks, and a development blocks yet to be covered without formulating a new scheme for them. Why the government is impending to discontinue this scheme ?

PU F.MALSAWMA
MINISTER

: Pu Speaker, there is no question of depriving them. Better scheme are being formulated, being evolved and they would not in any case be deprived of these benefits and the remaining 11 including additional Sub-Block 12, would be covered. For these workshop also is already conducted and that scheme and effective means of implementation is under active considerations.

PU NIRUPAM CHAKMA : Pu Speaker, I would like to support the motion for the Private Members Resolution of Hon'ble Leader of the opposition.

Mr.Speaker, I think the mood of the House is that every Member of the House who have Spoken earlier had supported the idea of having a better planning for self sufficiency in Mizoram. There is no two opinion on this matter from the opposition bench and from the Treasury Bench-Every Members have supported. I must congetulate and thank all the Hon'ble Members. The very idea of having a better Planning for Mizoram in order to attain self-sufficiency is a conserve opinion that has been expressed in this August House. But, while almost the entire treasury bench Members, Hon'ble Members of this August House had supported the idea they are reluxtant to go for the Commission. Who will prepare the plan as proposed by the Resolution ? I think it is a re-jection of one's conscience it is very clear. When our conscience agreed for a better planning we want self-sufficiency And for that what is the harm for constituting a Commission ? The people of Mizoram will not be surprised that the Budget presented by the Hon&ble Chief Minister is today prepared without a sitting of the Planning Board. And I believe up-till now the planning Board of Mizoram would not be constituted we know that we have a Deputy Chairman of the Planning Board, Hon'ble Members from Serchhip Constituency-Vice Chairman of the Planning Board but as a planning Board of the State I believe we have not heard anything today, that there was a sitting of the Committee because it is not constituted. Therefore the planning of the Hoverment of Mizoram which was presented If you lóok into the Budget Provision and all the Priorities the Hon'ble Member have mentioned where is the increase in the budhet provision or in the priority sector ? I may mention Agriculture which is supposed to be the top priority Horticulture and Allied sector- where is the Budgetory support on this statement ? I think it is merely a statement. Hon'ble Chief Minister has mentioned manytimes that Mizoram would be made into a Switzerland of the East if a Commission is

constituted why not bring a Switzerland person to guide us ? But a few minutes ago, the Hon'ble Deputy Chief Minister had mentioned and in the morning Hon'ble Member of Serchhip constituency had mentioned that the previous Congress Government appointed commissions to prepare various schemes for Mizoram, especially relating to Agriculture sector and allied sectors. It ia a good new and which record is to be studied. I think the Government intends to go through it.

I think if these reports are studied by a Commission, it will be more fruitful, now one Government had engaged different firms, conservatives firm, they are experts, why ? Because it is not within our capacity to prepare such reports for us, we had appointed various firms to do the Job for us. If various reports will be studied by the commission and suggest the Government which percent to be excepted ? which suggestion will be accepted ? I think this will bear good result.

Now, the mover in the morning stated that the previous Government had adopted the garden colony by P.C. Ministry Jhum control programme by congress and ther MNF Government NLUP programme and then Congress Government There are a number of such a story. But as far as those policies are concerned. I think today the real position is that NLUP was most successful. But there are failures too, that you want to know, Now the people who have received from 5/4 years back. They will be reaping harvest in the field of Horticulture, it requires 7/8 years tim to get the harvest. Now many people are getting harvest and they are very happy, but those who have failed are unhappy. They are looking for the implementation or may be the people might have misused the money. The real figure will be know by Rural Development Department. I think it was mentioned in form area say 50%, 60%, 70% and there are even 80 percent success because success can not be hundred percent. Now this very policy the present Ministry is intending to discontinue depriving many rural Development blocks, the people of many rural Development block But where is the alternative policy ? i have not seen in the Budget book the increase of demand amount in the priority sector. What we say is not true otherwise self-sufficiency of Mizoram will never come, it will remain a dream.

Mr. Speaker Sir, I think it the Government is really sincere for the Development of Mizoram a comprehensive planning is required not only a statement in the House. Therefore, I think the resolution moved by Mr. Zakhru, Hon'ble Opposition Leader is appriciated by the ruling Party also is really interested in the idea of self-sufficienc with these few word I request all the Hon'ble Members to pass the resolution for the development of Mizoram and for the people of Mizoram, Thank you.
