Today, Pu J. Lawmzuala can not attend the session due to the demise of his mother.

The first business for today is an obituary reference to be presented by Pu Zoramthanga. As we are all aware many people have lost their lives in the Kargil was. After the presentation of obituary reference, the House will observe two minutes silence. •

PU ZORAMTHANGA CHIEF MINISTER

Mr. Speaker Sir, we all must have known the term "Operation Vijay" Kargil is located at Jammu & Kashmir State, about 5 or 6 kms from the Line of Control within the Indian side. Being a suitable place of

hideout for the enemies, the Pakistani armies have passed the Line of Control and occupied this area for sometime. In order to promote better relationship between the two countries India and Pakistan had made Lahore Declaration. Moreover, the case of the Line of Control has been shown in the Shimla Agreement while India has complied with this agreement, Pakistan has violated the agreement and crossed the Line of Control and settled within the Indian side. To push back the Pakistan armies 'Operation Vijay' was launched in which more than 300 heroes had given their lives to save the country. Besides, many were left disabled and thousands of innocent people have suffered. In this connection, General Malik, Chief of Army Staff, has invited Chief Ministers of each States to organise and collect assistance for the families of the Kargil victims. Following this request, a special Relief Committee was set up in Mizoram and asked the state government employees to contribute their one day salary to this cause. Besides, Kargil Marty's Fund Raising Committee is set up.

With the steps taken by the government formed Relief Committee, a successful public meeting was convened at Vanapa Hall on 12.7.1999 as an indication of our support to the war heroes. His Excellency, the Governor of Mizoram has conducted the meeting. Beside the Governor and the Chief Minister representatives of all political parties, Church leaders, leaders of Ex - Service League and representatives of the Kargil Martyr Fund Raising Committee had given speech. Their speeches have instilled a feeling of nationalism to the people. The Government of Mizoram is deeply concern with the sufferings of the brave soldiers who had given their lives to save the country. We prayed for the bereaved families and their dedication can never be forgotten.

The Government of India normally gives an ex-gratia of Rs. 10,000/to the next of kin of the deceased. Besides this, relief has been given to the invalid by providing employment and free education to the children of the war victims. However, this relief is found to be trivial in this generation and so the ex-gratia of Rs. 10,000/is increased to Rs. 1,00,000/-

We remember the soldiers who have given their precious lives to save their country. I would like to make an appeal and an invitation to the people of Mizoram to make financial contribution as an indication of our support to the cause for which they gave their lives.

PU SANGHMINGTHANGA : H. PAUTU

Thank you, Mr. Speaker Sir. As we are aware, I was appointed as the Chairman of the Kargil Relief Committee set up by the government. After deep consideration, the Committee made an appeal to the governex - gratia granted to the families of the soldiers who

ment to increase the amount of ex-gratia granted to the families of the soldiers who died in the war.

It is our misfortune that the Pakistanis have acted against us in this manner. No international country has ever caused any disturbances to the neighbouring state on the eve of an elections. It is hard to cope with the action of the Pakistan government. While it is expected that the two countries would have better relationship as a result of the visit of our Prime Minister to Lahore, the Pakistan government has acted in the contrary manner. This dispute has been designed by the Pakistan government to disturb our election. Therefore, it is appropriate that we have fought back the intruders. Though the operation is not fully completed, our participation as the people of Mizoram through donation is necessary for their inspiration whether big or small.

Mr. Speaker Sir, it is pleasing that the hon'ble Chief Minister has made an obituary reference to the Kargil heroes. We all know that Pakistan intruder and the

Pakistan armies have crossed the Indian border and settled within Indian territory. The Indian armies have fought bravely these intruders and more than 300 precious lives have been lost from the Indian side including several army officers. I would like to say that we deeply mourn the soldiers who died in the fight for the sake of this country.

Besides the deaths it has been shown that 493 soldiers have been injured. We pray for their immediate recovery. It is also our wish and hope that those soldiers who are missing would soon be found by the government.

It is great that our soldiers have come out victorious. As we all know, Kargil is situated in a high altitude area where movement is very difficult not to mention their equipments. As the Pakistanis had settled in the higher area they were in a better position, but the Indian armies never gave up and fought courageously and has now driven out most of the intruders out of Kargil. It is a great achievement what these soldiers have done. Many have lost their lives while there are many injured, we remember those who gave their lives. We respect them as heroes who have inspired the Mizo armies and it will be an encouragement for them.

We have mentioned the Fund Raising and with the fund collected we can help the families of the war victims. Many soldiers have sacrificed their lives for us to live peacefully. It is our duty to donate fund for the families of the soldiers who gave their lives for us.

PU N.K. CHAKMA : Mr. Speaker Sir, I ask starred question No. 1.

Will the hon'ble Minister i/c Health and Family Welfare department be pleased to state ~

(a) The reason for not delivery of Gypsy Ambulance provided for Tlabung Civil Hospital by the WHO under Tribal District Post - Partum Project.

(b) Where is the said vehicle?

PU K.L. LIANCHIA : Mr. Speaker Sir, the answer to the first question is that the Gypsy Ambulance under question is specially provided for Post - Portum Project. But, Post - Portum

Project has not been created in Tlabung and thus the ambulance was utilised at Saiha District.

As for the second question, the ambulance is presently in Saiha.

PU LALZIRLIANA

Mr. Speaker Sir, is there proposal for the purchase of more ambulance for Civil Hospitals?

PU K.T. ROKHAW

Mr. Speaker Sir, a supplementary question please. My first question is the number of vehicles alloted for Drug Control Administration in the Health Department for each District.

Secondly, the Male Medical Officer is not alloted vehicle and hence the department's ambulance is kept by him. As this is the case, the Ambulance cannot be utilised for the right purpose. It would be appreciated if a separate vehicle could be allotted for the Officer. Pool vehicle is also urgently required for the Doctor.

PU K.L. LIANCHIA MINISTER Mr. Speaker Sir, regarding the question raised by the member from Saitual Constituency, the hon'ble Chief Minister has taken steps to solve the problem. As a

result, three 407 type vehicles was recently purchased to be utilised as ambulance and one Gypsy soft top is also purchased.

I think the question raised by the member from Tuipang is not relevant to the Starred question. However, the matter will be looked into.

PU ZAKHU HLYCHHO :

Mr. Speaker Sir, I would like to ask the exact number of Ambulance alloted to Lunglei, Saiha, Champhai and Kolasib.

Secondly, does the Government of Mizoram expect more ambulance for Post - Partum Project from World Health Organisation ?

PU K.L. LIANCHIA MINISTER Mr. Speaker Sir, I have furnished my answer to the starred question and therefore, I will not give more answer to the other questions.

SPEAKER

Let us go on to question no. 2 to be asked by Pu K. Vanlalauva.

PU K.L. LIANCHIA

Mr. Speaker Sir, the answer to starred question no. 2 are as funish below -

- (a) There is no release of final bill before the completion of the construction of PHC, SHC and Sub - Centre buildings.
- (b) There are Health Sub-Centres with no Health Workers.
- (c) In Devasura Sub Centre, Chhimtuipui District, there is no Health Workers.
- (d) There is proposal for the posting of Health Worker at Devasura Sub-Centre.
- (e) Main Centres where microscopes are not installed are Chhuarlung, Chakhang Vahai, Vaseitlang, Borapansuri.

PU K. VANLALAUVA

Mr. Speaker Sir, a supplementary question please. Three Sub-Centres are being constructed at Bulfekzawl within Khawbung Constituency. Before the com-

pletion of the construction work, it has been said that final bill was released. The Health worker posted at Bulfek is also staying in Champhai as the Sub-Centre was not yet completed. It would be appreciated if the department could take action for the immediate completion of the said building.

Two months back, there was sanction for the reconstruction of Khuangthing Sub - Centre. But, only repair work was done to the existing building. Final Bill is also released to the contractor. It would be appreciated if this action is not repeated in future.

I would like to emphasize that there are Sub-Centres where there are no Health Workers as in Sialhau village, Bulfek, Vanzau and Khankawn. The people in these areas are facing difficulties due to the absence of Health Workers not to mention medical supplies. However, it is wished and hoped that the government fulfil its programmes in strengthening health care facilities in rural areas.

Lastly, the Sub - Centre building at Khawhung needs reconstruction as it was constructed way back in 1978. I request the Minister to note this and take steps for the immediate action in this regard.

PU NIRUPAM CHAKMA :

Mr. Speaker Sir, a supplementary question please. Does the hon'ble Minister know that there is no Health Worker in Khojoisuri and no Medical Officer in Chawngte ?

Mr. Speaker Sir, a supplementary question please. The Dental Surgeon posted at Saitual has been taking narcotic drugs. I have even asked the concerned Minister if he already has any knowledge about this. I have learnt from him that he had

come to know about the case of this Dental Surgeon. The people within my constituency have complaint of this case and in pursuance of this I appeal to the authority to transfer this Doctor. But, action has not yet been taken till date. It would be appreciated if this Dental Surgeon could be shifted from Saitual immediately.

PU K.T. ROKHAW

Mr. Speaker Sir, there is no Nursing Superintendent at Saiha Civil Hospital. It would be appreciated if Nursing Superintendent could be posted immediately for Saiha Civil Hospital.

Secondly, I would like to ask whether the government intends to reconstruct Saiha Civil Hospital building.

Thirdly, there are no specialised doctors at Saiha Hospital and so, the people have to come to Lunglei or Aizawl in case of severe illness which is a problem for them. Therefore, I request the hon'ble Minister to note this and specially consider this case.

PU SANGHMINGTHANGA : H. PAUTU

Mr. Speaker Sir, at Lungmuat Village, out of the total inhabitants of about 650, over 300 people have been suffering from various illnesses. The Health Workers posted at the Village were shifted out in January 1999.

I have brought this matter to the authority. However, the post has not been filled up till date. Can the Minister take immediate action in this regard so that Health Workers be posted at the village immediately.

PU ZAKHU HLYCHHO :

Mr. Speaker Sir, the construction of Chhuanlung PHC building was completed some time back. When will this PHC, be started functioning?

PU K.L. LIANCHIA MINISTER

Thank you, Mr. Speaker Sir. I will start answering with the case of the release of final bill against the construction of Sub-Centres. As a Minister I have no

knowledge of this incident. I will look into the matter and if necessary actions will be taken.

Coming to Khuangthing Sub-Centre, the construction of building was completed and the Doctor has verified the building followed by the issue of Completion Certificate. Then, final bill was released to the Contractor. However, there was complaint regarding the condition of the building, and so, Dr. Lalengmawia Khiangte was sent by the government to have spot verification. He even took photograph of the building. From his investigation, the Senior Doctor was satisfied with the construction of the building. From this report, the government found no problem at Khuangthing PHC.

According to the record, there are no female Health Workers in 24 Sub-Centres, and 23 Sub - Centres with no male Health Workers. It is expected that Health Workers be posted in every Health Centres and Sub - Centres in a short time.

As for the case of the Dental Surgeon posted at Saitual, for the case is a serious one, it demands careful consideration. There are even suggestions that the Doctor be posted at Aizawl and deprive of all his medical duties. Anyhow, the case will be given priority but I cannot assure you that he would be transfered within this week.

I would like to ask the member to raise only questions that are relevant to the starred question.

PU K.T. ROKHAW

Mr. Speaker Sir, we have raised questions relating to Health department with the expectation of his replies.

PU K.L. LIANCHIA : Mr. Speaker Sir, I ha MINISTER best I can.

;

Mr. Speaker Sir, I have furnished my replies with the best I can.

Emphasizing on the point mentioned by Pu R. Sanghmingthanga, there is posting of Health Worker at Lungmuat. If the Health Worker does not report himself to his posting, action will be taken.

Buildings for PHC have been constructed at several places like

Chhuarlung, Bungzung, Sesih and other villages. But, these PHC cannot function due to shortage of fund. The existing PHC will be maintained first and the rest will be considered according to the availability of fund. As for Chhuarlung PHC, the government had given commitment. Therefore, it will be officially opened as soon as possible.

PU K.T. ROKHAW Mr. Speaker Sir, the Nursing Superintendent of Saiha ÷ Civil Hospital has been attached to Aizawl Civil Hospital. Can the hon'ble Minister arrage for the posting of another Nursing Superintendent for Saiha?

The Civil Hospital of Saiha is badly in need of Medicine Specialist, gynaeocologist and surgeon while there are more than forty specialists posted at Aizawl Civil Hospital. Therefore, Mr. Speaker Sir, I would like to urge the hon'ble Minister to give priority to this case and assure us that specialists would be posted at Saiha.

PU N.P. CHAKMA Mr. Speaker Sir, the hon'ble Minister has not answered 1 my question.

The Medical Officer posted at Chawngte has been undergoing training outside Mizoram. The only doctor we have is Dental Surgeon. So, Mr. Speaker Sir, please arrange for the posting of another Medical Officer for Chawngte Hospital.

SPEAKER Many supplementary questions have been asked and it will be appreciated if the Minister can answer all of them. However, if replies cannot be furnished for all

the question, we must remember that the starred question is the most important.

PU K.L. LIANCHIA Mr. Speaker Sir, I have great respect for the member • for his dedication to his constituency. For the mo-MINISTER ment, I cannot give any assurance. However, I will look into the matter.

Coming to Chawngte Hospital, Sub - Divisional Health Officer was posted recently. There may be cases where the officer has been going on leave. Anyhow, the matter will be looked into.

SPEAKER Starred question no. 3 to be asked by Pu H. Rammawi. :

PU H. RAMMAWI Mr. Speaker Sir, I ask starred question no. 3. :

Will the hon'ble Minister incharge Agriculture be pleased to state -

Whether there is proposal for the supply of vegetable seedlings and seeds to the farmers.

PU ZORAMTHANGA Mr. Speaker Sir, the department of Agriculture intends 1 to supply seeds and seedlings to farmers before the CHIEF MINISTER end of winter.

PU H. RAMMAWI

Mr. Speaker Sir, a supplementary question please. I have raised my starred question because we have seen from the Governor's Address that the government has

programmes and policies to lift the farmers from poverty. In the meantime, the department of Rural Development has formulated new programmes and schemes and introduced new projects for the welfare of the farmers. Rural Development Department can also provide free supply of seeds to farmer. Formerly, the problem of the farmers was mainly their poor knowledge regarding the process of agriculture and how to find suitable market. As for now, knowledge has been imparted on the system of agriculture and they can easily classify the types of foodgrains to be cultivated. They have a clear vision on how to get profit out of their products. In this case, I ask the Minister what policy does the government have in economics.

PU ZORAMTHANGA CHIEF MINISTER

Mr. Speaker Sir, the government has differentiated our agriculture products into two categories, foodgrains and vegetable. The economic policy is also going in two ways. One is self - sufficiency in foodgrains and

the second policy is to focus interest on revenue earning crops. Crops and vegetables will also be selected on the basis of their value in the market.

The government intends to identify revenue earning crops to the people and necessary directions would be given as well on the method of cultivation. Supplies for seeds and seedlings will also be identified and the supplier will also be provided loans or grant - in - aid so that only good quality materials will be supplied. There will also be suppliers for every particular area to avoid the problem of transportation. It is also intended to supply only good quality seeds.

Starred question no. 4 to be asked by Pu K. Vanlalauva.

Thank you, Mr. Speaker Sir, I ask starred question no. 4. Will the hon'ble Minister i/c Health and Family Welfare department be pleased to state -

Whether there is proposal for the construction of Doctor's quarters and staff quarters of Sesih PHC.

PU K.L. LIANCHIA MINISTER Mr. Speaker Sir, the construction of Sesih PHC main building has been completed. There is also proposal for the construction of Doctor's quarters and staff quarters.

PU K. VANLALAUVA :

Mr. Speaker Sir, a supplementary question please. Primary Health Centres are constructed at Bungzung, Khanbung and Sesih but without kitchen. PHC cannot really function without kitchen.

I would like to mention again the case of Khuangthing PHC. As mentioned earlier, the building was planned for reconstruction but only repair work was done on the existing building. I have mentioned this matter to the community leaders of the village. I had even visited Khuangthing four times this year. The condition of the building is unsatisfactory. Is the hon'ble Minister aware of the fact that only repair work was done on the PHC.

PU LALTHANKUNGA

Mr. Speaker Sir, PHC main building at Sakawrdai has been completed but also without kitchen, Doctor's and Staff quarters. Is there any intention for the construction of the said quarters?

Er. K. THANGZUALLA :

Mr. Speaker Sir, the on-going construction of Serchhip Civil Hospital has an estimated amount of Rs. 24 lakhs. At present, the physical achievement is between

50-60 percent but the estimated amount was already spent up. I had a spot visit on 17th June and saw the condition. How is the government reacted to this matter?

PU K.L. LIANCHIA MINISTER

Thank you, Mr. Speaker Sir. Normally, construction works are to be undertaken by the Public Works Department. For the construction of the main buildings and kitchen for PHC at Sesih, Khumtung and

Khawbung, estimates have also been made and construction work is handed over to the Public Works Department. And if kitchens are not constructed for now, I can assure you that it will be done so.

Coming to Khuangthing PHC building as stated earlier, I have accepted that it was reconstructed and not just repaired. The official and doctor sent to have a spot verification were also satisfied with the construction. That is the report received by the government.

As for the PHC of Sakawrdai and Khawruhlian, construction work is handed over to the Public Works Department.

There have been various reports regarding the on going construction of Serchhip Civil Hospital. In the current year, additional fund is sanctioned for the completion of the hospital. Anyway, the matter will be reviewed.
