Kargil hi Jammu & Kashmir State a awm ani a, Line of Control atanga India chan lam Km.5-6 vel a awm ani a, Tlang ram chhengchhe tak, thlasik lai phei chuan vur tlak nasat avanga tlawh-pawh hleih theih loh hmun ani a. Hmelma tan inkhuarna remchang tak ani ang ngeiin, Pakistan sipai te hian hun engemaw chen atang khan LOC kal pelin a luah a. Kan hriat theuh angin hmanni lawkah Pakistan leh India chuan inkungkaihna tha zawk an neih theih nan Lahore Declaration te siam ani a. Hei bakah hian LOC chungchang hi chiang takin Shimla Agreement ah tarlan ani bawk a. Hengte hi India chuan thinlung inhawng tak leh rinawm taka kenkawh anih lain, Pakistan erawh chuan inremna te hi bawhchhia in LOC hi a rawn kan a, India ramchung ah awmhmun a rawn khuar a. Hemi bakah hian chanchinbuah, chanchinbumi mi thahnemngai zual thenkhat ten Kargil Martyr Fund Raising Committee an din a. Tanpuina engemawzat an hmu tawh bawk a.

PU SANGHMING IHANGA H. PAUTU: Pu Speaker, ka lawm e. Hei, Kargil chungchangah khan kan hriat tawh angin kan hotuten committee an han siamah khan Chairman turah min han ruat kha a ni a. Kha committee khan uluk taka an han ngaihtuahin sorkar ah ngenna kan thlen a, kan Chief Minister zahawm tak khan tunah khan a han sawi a, a thi a te, singkhat kha chu tun dinhmunah chuan a beitham ta deuh e, nuakhat hian tih dan awm thei se tiin committee chuan kan han ngen a. Tin, midang a te (hliamte) pawh kha chu chu a lawmawm chho zelin ka hria a, sorkar chungah committee aiawhin lawmthu kan sawi duh a.

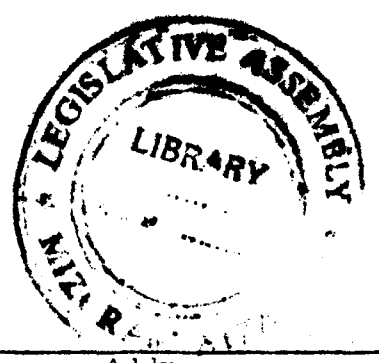

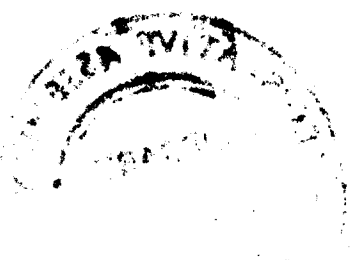
