MINISTER** : Pu Speaker, Saitual bialtu MLA zawnha, Transport Bus tlan thin, Lunglei atanga withdraw-a sawi hi enge a awmzia ? tih chhan chu:- Transport Bus 4 Lunglei atanga tlan thin, Lunglei atanga Aizawla lak phei a ni a. the zawk leh tluang zawka mipui rawngbawl anih theih nan-a tih a ni.

**PU R.LALZIRLLIANA** : Pu Speaker, tha zawk leh tluang zawka a kai theih dan tur kha enge min hrilh thei se ka duh a. Second Capital a ni a, Lunglei saw, mipui an tam ve em em a, nitin-a tlan chhuak tur chauh Bus va dah kha enge a chhan ? kan Minister zahawm tak, bialtu anih lai khan a va dah phei a ni a. A hnu amite thil tih dan hi a hma amite thil tih an thiah duh vang hrim hrim nge ? tha zawk leh tluang zawka tlan theih na tur tih kha.
