India leh government of Mizoram April 1999, a Memorandum of Understanding signed hi Mizote kan hmasawna kawng daltu, thangtharte leh lehkhathiam sing tam tak tunah harsatna an tawh mek a. Many members both from opposition as well as Treasury Benches have spoken about the resolution. Some members from the Treasury bench have been said that it is SRD, from the opposition it is said that it is MOU. Whatever may be the resolution is but it is very unfortunate that the government has signed this type of Memorandum by which as for my opinion common people will face a lot of hardship.

As the Memorandum of Understanding have been signed on 8th April, 1999 when the MPC members were a part of Ruling Government. So both the parties are responsible for signing this Resolution, because the Council of Ministers are collectively responsible for this. So, even MPC members have to bear on this issue. Pu Speaker, ka thu sawi lai hi kei chu tih buai a ngai lo, min tih buai chuan ka thu sawi tur pawh hi ka theihngihl zel a. Hei min tih buai tur lo turin ka ngen duh che. For example, it states about power revised increase, water tariff have also been increase, land revenue, Bazaar fee, has also been increased by which only common people will suffer Pu Speaker, although, let me just point out about power. Although power tariff has been increased but the improvement of power system in Mizoram as a whole has not been improved. It is very sad, therefore although power tariff has been increased the quality, of supply has not.....

been improved. It is very unfortunate. What is most unfortunate is that here it is written very clearly in the paras we can see the state government will face hiring of governments servants against any vacancy by issuing necessary government order. The position requires to be filled under the centrally sponsored scheme from externally, so this will curtail our educated unemployed from getting jobs. This matter is very serious. It is only after signing of this MOU as per my opinion goes this Peace Bonus has been sanctioned Rs.180 crores as a Peace Bonus. But it is clearly written in the newspaper that even without signing, some other states like Sikkim, Meghalaya and Arunachal Pradesh have also received money as a Peace Bonus. But they have not signed like this. I would like to say that whatever it may be whether it is SRD or MOU since it has been signed, when MPC were a part of the government. So, both the parties are responsible, we are not responsible, we don't know anything about this MOU. Only when this resolution has been moved, after then only we came to know about this MOU. So, only these two parties have to face the consequences. With these few word, thank you Pu. Speaker.
