I would like to know why the MLA's are kept in the, why we have not been issued or supplied with the Guideline, the transparent Government of Mizoram. Tumah kan hre thei si lo. This is the clear fact, where as the Central Minister could send us the guideline. What this State Government is doing here ? We are being kept in dark. Is it the functioning of this State Government here with the transparency ? Whether the Minister at or not ? It is the fact that the selection process is very unfair, we know our respective constituencies, but if the Minister want to defend himself here on the Department, it is up to him. But we know that the process is not fair enough. I would like to know whether the Government will review the list already selected.
