Did the Government aware that news paper like Vox, Zonunmawi, Khawpui aw and Thuthar which distribute 200 copies only and which have been run only les than three months were given advertisement ? Besides this, regarding the advertisement column there used to be three column, now it was into only one column, did the Government have any intention to change this ? For instance the hour-nalist gets Rs.200/- only where they used to get a sum of Rs.600/- Can this be right ? I shall be very glad if you give me the list of local news papers which the Government have given advertisement ?

Mr LAL THANHAWLA CHIEF MINISTER

: Mr Speaker Sir, Yes in the adver-tisement policy it states that advertisement must be given to any newspaper which has distributed at least 500 copies and run at least 3 months. As you know none is perfact the Officers who have advertisement are

also not perfact so after the Government is aware of it, they have corrected the mistakes Committed.

Regarding the advertisement column the Government didi not think for the profit of the newspaper alone. Giving advertisement in one column is a trial, so that the Government may curb the wasteful expenditure. But this is not practicable in all the cases, as some are display advertisement, some are impossible to give in one column. A review are made for this.

Although, the respected member did not ask about how advertisement are given, there is an approved list. But during the M.N.F. Ministry, the concerned Minister has abolished this, and made rules which allow to give advertisement to any newspaper. The present Government did not find appropriate so a review is made to make approved list.

A list which he demanded was given out when the opposition member was absent. The list is not with me now, he can be given later on.

In the Junior Administrative Grade MPRO and Fire S.P. are kept for technical persons. Nevertheless, from 1986 M.P.S. Officers are posted in the MPRO. It seems the work progress better than when there was technical person. It will be pleasing if more favour is given to the M.P.S. Officers and have them posted in this two vacant posts be filled up ?

Mr C.L.RUAIA MINISTER : Mr Speaker Sir, cur respected MIA of Khawhai constituency said that there are three Selection Post. Moreover, in the rules there are

Moreover, in the rules there are 5% I believe there are four posts out of which one is already filled up. To promote them to a selection Grade they must have 20 years service as a police Officer. But they entered M.P.S. in 1974 only, that means they have a service of 15 years only. To condon them may not be the best thing, for these reason the Government had a review.

For Junior Administrative Grade also 20 years service is required. These two posts are not filled up because it needs technical person. We are serching for such person, if we cannot find it, we may think of some other way.

: Mr Speaker Sir, on page 6 para-graph 13 line 6 runs, "Part from construction of culvert and Bridge, Mr H.RAMMAWI

roadside between Keitum - North Vanlaiphai, Tut - Mamit, Aizawl - Sialsuk, Thenzawl, Hnahthial - Sangau and Dilthang-Chawngte have been opened during 1989-90 some are not true. For instance roadside like Diltlang - Chawngte is true. But the road between Hnahthial - Sangau was opened by our respected Member Mr Zosiama Pachuau in the early spring of 1988. So, it cannot be regarded as open in 1939-90. I therefore, request our Leader, who is also in-charge of P.W.W. Department to clarify it.

On page 8, paragraph 20, "In fact more than 67,000 tonnes of rice was lifted and distributed to the Public since April 1989 till now". This contradicts the paper laid by down in the House by our respected Finance Minister Yesterday on page 18 under the heading of perfoe-Minister Yesterday on page 18 under the heading of perfoe-mance and Programmes of various Department for 1989-90 & 1990-91 upto December 1989, the Department has procured 64, 362 matric tonnes of rice of 64,362 matric tonnes is lifted from April to December. On the other hand 64,500 tonnes of **rice is** lifted since April 89 till now, around 7,500 tonnes of rice is our monthly allotment. What is the meaning ? Have the Government lifted only 2,000 tonnes of rice between January-March 1996 ? I want our Minister to clarify this. Beside, this on paragraph 20 last line "For the purpose of monsoon stocking 1500 tonnes of rice per month has been allo-ted during January-April 1990 to ensure that there is no sho-rtage during the rainy season". Moreover we are alloted rtage during the rainy season". Moreover we are alloted nearly 9,000 tonnes of rice per month. Did the Department lift just 2,638 tonnes of rice within these months ?

Mr Deputy Speaker, on page 1, about ture Department. Why is their budget so little this Are they successful ? Or are their budget more than Agriculture Department. year ? enough and distributed to other Department ? I request our respected Minister clarify why there is such a great fifference in their budget ? Most of the people of Mizoram are Agriculture needing help in every way. It will be pleasing if more fund is sanctioned in the Budget for Agriculture Department. I am very pleased with the intention of Ministry regarding the Education Department as found on page 3, "During 1990 - 91 Financial year my Government proposed to introduce various measures so that Mizoram could achieve the distinction of being the first state in the union of India to attain 100% literacy". Even though it may not attain its goal. I believe there will be more development and progress in the field of Education. But looking at their budget it grieves in as the increase of their budget this year is very little comparing to last year. Due to shortage of fund the Department could not provide subtitute teacher, as a result the children suffer greatly. Yesterday our respected member has told the House that there. is no teacher ar Luangpawn. How can we provide a good stu-dent without teacher ? It will be pleasing if more favour are given to the Education Department ans sanction more fund for their utilization.

Regarding Forest Department found in paragraph 8,2869 families has received assistance under New Land Use Policy. The Department takes too much step on waste- Land Development. The fund spent on wasteland divelopment and the waste-land development needs careful inspection. Besides, Social Forestry scheme also indispensably required supervision.

In my constituency, at Fungkah the earth cracks, which also seen an examine by Geological survey of India. The inhabitants have to leave their Village out of necessity. They shifted to Khawthar 20 km. from Fungkah with the help of our D.C. and Council. The poor people have to earn their livelihood at the same time, they need to re-construct Houses for their shelter. I request our Government to understand their condition and to give them rehabilitation in every possible way.

Under the heading of performance on page 15, the step taken by District Council we found 96 km Jeepable and 5 km. link road in our District Council Area ? I want our District Council Minister to clarify this ?

Old Age Pension is given to 678 pensions, it may be true in paper, but on the practical side this is not true. The number aid given to old age is informed to the Social Welfare Department by the District Council. The Social Department cut off of names of those who have already received the assistance. Nevetheless, the District Council did not distribute these to the old age people. The poorr old aged people face these problem I request our District Council Minister to be aware of the problem face by these people and think of the means to solve their problem.

Mr Deputy Speaker Sir, I am glad that mention are made on page 7 last line about one Mizo youth who represents India in Boxing Competition at Moscow. I hope there will be more persons who represent in the near future. Now we have sport Council to promote Sports. Mr Deputy Speaker Sir, thank you. Our Governor's speech is very pleasing but some are not agree-

able which needs discussion.

First of all regarding the maintainance of Law and Order, "H.P.C. agitating for an Autonomous District intensified their activities mainly in border areas adjoining Mizoram, Manipur, and Cachar". On page 5 also. However, with the firm and tacful handling and close supermision by the concerned authorities the over all Law and Order remained peaceful" can we call the area, "Peaceful"? Mr Deputy Speaker, Sir, you are also one of the members who clearly know that the area is not peaceful. Even the Government servants who work there have to leave their station due to P.H.C. Now t here is no teachers, no Doctors etc. Somehow, they handle the situation but it is not peaceful. At Phuaibuang there are about 523 Qtl. of rice in the Godown in the month of October, 1989. The P.H. C. destroyed the lock and took out all the rice costing around Rs. 1,60,000/- some they have taken to Manipur and sold it for Rs 5 per Kg. Mr Deputy Speaker Sir, I want the Government to see the situation carefully, and accept the situation, as it is.

Secondly, about the P.W.D. progress it was stated that, "My Government is committed to take all possible measures to make communication easier throughout the state". The progress made by P.W.D. is pleasing, moreover as our respected Chief Minister has said some of them are not true due to the wrong information he received. For instance, the construction of Tuivai Bridge he said that the work is in progress the engineer and labourers are at work day and night. In practical it is not so. The material collected for the construction of this brige are all sold out. The people are in great distress. I want the P.W.D. Minister to be aware of the situation.

Besides the above, the Government also issue so many permit for Bazar Bus, Town Bus and Taxi Permit. If all of them have bought it our towns will be full of vehicles. This will give us problem. So, the Government must be careful in issuing Vehicles permit in future.

Mizoram will be entittled to have a High Court of its own or if it so wishes? While the Peace Accord states, "Mizoram will be entitled to have a High Court of its own, if it so wishes" why did the speech state, "There must be a permanent bench of Gauhati High Court at Aizawl"? We want a High Court of our own like other state. I requested the Government to consider the matter more care fully.

: Thank you, Mr Deputy Speaker Sir, it makes me think that who has prepare the Governor's speech ? Be-

cause no mention is made about the progress and the development like Printing and Stationery, Information and Publicity, Economic and Statistics, Labour and Employment, Police and Social Welfare. There are also many controlversial question. This reveals that the speech is not diligently prepared. The Mizofed has taken mush effort and made many achievement. They have branch in Serchhip, Hawngtlai, Kolosib and Champhai they post three staff in each of these braches they have 24 hours duty. It will be good if the number of staff are increased in these branches.

Our Governor's address of last year i.e. 31st Pebruary, 1989 clearly stated that "The M.G.C. Pay Scale of Collage teachers was being introduced in consultation with the Government of India". According to the Governor's speech we can presume that the Collage teachers has already taken their pay as M.G.C. pay scale by now nevertheless, till today none of the Collage teacher in Mizoram has enjoyed this pay scale excepting those who works under North-Eastern Hill University. Therefore, one must be careful while preparing the Governor's address, otherwise the speech may be fallible.

I would like to critisize the way the Forest Department has taken step. The Department have lots of funds for New Land Use Policy, but the way they utilize these funds are inappropriate. They asked the people first to cut down the trees and Bamboos, then instruct them to plant new tress. It takes times and energy it is also waste of money. So, why don't the Department preserve the trees and the Bamboos instead of cutting if the Department give fund to those who preserve these trees and bamboos. The funds spent for the afforestation and the Revenue received are not tally.

I would like to the Minisrty to consider more carefully about Education Department. It is impossible to take Officiating Teachers, the School building especially Primary School are broken down, just fit for Cow shed or Pig Sty. It will be pleasing if the Department sanction fund for the pay of substitude teachers and the maintainance and reparing of School buildings.

The achievement made by industry Department is praiseworthy, they organised Industrial exhibition Industrial fair etc.

It is pleasing that the Government has sanctioned F.R.S. to the rural areas. Though it is very pleasing at the same time it bring grievances to the people. Because it never reaches the masses the reason behind these is that the Ministry have disclved the N.Y.C., non Congress (I) V.C. The Government appoint some people they favour or C.A. to take the charge of V.C. These people use the V.C.P. seal wrongly. The cooperate with A.O., the F.R.S. did not reaches the masses. For instance I was searching the F.R.S. of Kawlbem in paper it has already the Village but in practical the F.R.S. was utilized for the repairing of the A.O. vehicles. I request the Minister in-charge to be aware of these.

The I.R.D.P. is distributed in all parts of Mizoram. In my constituency, Ngopa has been selected for the beneficiary of I.R.D.P. Till today none has received the I.R.D.P. in whose hands is the funds? In the Governor's address also it states that the street lights are replaced by Sodia vapour light. If you visit different localities of Aizawl town you won't find this Sodia vapour light, To point out is easy, but in actual it is not reliable, this falsify the Governor's speech.

Mr Deputy Speaker, it seems that our Governor's speech pleases us

all. Inspite of the over draft force by the Ministry various Department made progress in different fields of work as revealed by the Governor's address.

I am also very gald that our Governor thank the Prime Minister and the Cabinet Coleagues regarding the 62 Constitution Amendment Bill. I am also happy with the progress made by the Agriculture Department and Animal Husbendry & Vety Department. In Mizoram we practise Jhum Cultivation which is very harmful for the soil, so with the effort taken by the Agriculture Department the land for Juhm cultivation was reduced to 1300 hectares and 1230 hectares of land come under W.R.C. At Zuangtui Sesame processing Plant is newly established. The Oil will be useful for the people and the oil cake for Animals food. The Government is taking step to promote the Industry. I hope we shall be self sufficient soon.

The step taken by Education under operation blackboard Scheme pleases me very mush. A.H. & Vety Department have some progress but in my constituency at Haulawng one Doctor was posted we were vry happy but before one month this Doctor wastransfered to other place, till now there is no doctor. How can the Governor said that Doctors are posted in different part of the state? At Pangzawl there was one P.H.E. quarter, and was occupied by Chowkidar. Now this quarter was destructed by some people what is the reason? There is also one Forest quarter, but none has occupied this I think this quarter will braledown if it is not occupied. In paper Agriculture Department has made many progresslike irrigating the field etc. At Zote on Mat valley there is a good place of rice field. The Agriculture Department constructed a road from Zote, but the grade was very bad it is not fit for truck road. Due to difficulty of transport facilities there good valley remain untouched. Mr Deputy Speaker Sir, I am regret to say that in Governor's address the works and progress of some

important Departments are not mentioned. It may be difficult to mention about G.A.D. and Vigilance, Planning and programme implementation Department. Judicial and Parliamentary Affairs but how can important Department like information and Public Relation Department, Social Welfare, Printing and Stationery, Tourism, Rural Development and Trade and Commerce Department are not mentioned. This reveals how much the Ministry have paid attention to the various Department.

Regarding High Court in the Governor's speech it was found that, 'In pursuance to the Peace Accord there shall be a permanent bench of the Gauhati High Court at Aizawl'. I cannot admit this tatement as it contradicts the Accord. According to the Peace Accord Agreement 12 (III) - "Mizoram will be entitled to have a High Court of its own, if it so wishes" Mr Deputy Speaker Sir, it will be pleasing if you omit. "In pursuance of the Peace Accord .....".

It seems that only Rs.61 lakhs are utilized by the Mizofed POL Division, can not the Ministry sanction more funds for this POL Wing ? The masses are facing great problem on Petrol. The consumption of Petrol is very high whereas its supply is limited. sometime we cannot buy petrol without special permit, with permit also we buy just 10 litres. So I request the Government to improve the petrol supply, and sanction more funds in Mizofed POL Wing to solve this great crisis

I also like to mention about paragraph 6 on Education. It was found that"20 circles Adult Education centres and 60 sub-centres have also been taken up". When I enquired about this, I found out that the above mention are not new thing. It will be good if they are mention in our achievement otherwise we are receiving the people.

I request the Minister to clarify the following - "Shikshan, Nilayans", Khansari Sugar Plant", and "Lime Burnt clay Pozzalana (Limpo)". Can you not write in bracket either in Mizo or English about what is it ?

I am glad with the release of Greater Aizawl Water Supply Scheme. In my constituency also there is a big tank connetted by this pipe line. However, there is scarcity of water supply, besides after the release of this greater Aizawl Water Supply Scheme. The supply of water by yebicles are all stopped we are in great difficulty. I request the Minister in-charge to notice our problem.

The opening of P.W.D. road between Keitum - North Vanlaiphai, Tut - Mamit, Aizawl - Sialsuk -ThenZawl, Hnahthial - Sangau and Diltlang - Chawngte in 1989. 90 are not true. Mentioning the achievement of P.W.D.

Department they fail to include the construction of road by P.W.D. at Luangmual, Tanhril and Sakawrtuichhun. I request our Ministry to be careful while writing achievement report.

On the centenary celebration as we all know, our respected Education Minister has said that Rs. 14/- lakhs are spent on the Aizawl Centenary Celebration. Does the Education Department has taken responsibility in bees the Education Department has taken responsibility in the Centenary Celebration ? Champhai is also going to Ce-lebrate its centenary, Will the Education Department sanc-tion five lakhs for them ? In the near future Lunglei also is going to celebrate its Centenary can the Department sanc-tion Rs. 10/- lakhs for the Celebration ? We must be coun-tious. The way we utilize our funds, otherwise we will create problem by our own actions.

Regarding Forest Department I'd like to advise the Government to form Timber corporation as we are facing problem while constructing House and cutting wood for fire. Before constructing a House we have to take Timber permit, sometime the place is very far, the orice for Timebr is very high. If Timber corporation are formed we can buy Timber at a low cost. According to me the Government are spending funds unnecessarily under Social Forest Scheme. In this Scheme trees are plant in the Forest without no one looking after them as a result most of this without no one looking after them, as a result, most of this newly plant trees died out. I request the Government to see the matter again.

Mr R.TLANGHMINGTHANGA : Mr Deputy Speaker, Sir, we are mainly discussing about our Governor's

address. The speech is packed with discussion, first of all I'd like to discuss about Animal Husbadry on page 2 paragraph 4 we found the opening of Rural Animal Health Centres at Marpara, Sailam and Venghlui. There is a big mistake here as there has never been Rural Animal Health Centre at Venghlui. I request the Ministry to find out who had commit mistakes and in future not to commit the same mistakes.

In supply Department also we produred 7500 tonnes of rice. Besides, this for the purpose of mon-soon stocking 1500 tonnes of rice per month has been alloted during January - April, 1990. Inspite of the huge amount we procure in practical there is no rice for the people. There is something behind this, so I request the Government to sort out the matter as soon as possible.

We are facing difficulty in transport system. The reason is we are issuing too much permit. Before issuing permit we must keep in mind the following -what is the population of Mizoram ? How many transport fa-cilities are there ? What is the area ? After considering the above we must make criteria How mush Taxi and Buses will ply ? Then only will it be good to issue a permit. But now the present Ministry has issued too much Taxi permit, Aizawl town Bus permit and Bazar Bus permit as if we are going to stop the M.S.T. Bus service. The private Bus has been plying in all the routes of Mizoram. Since, the time we are in U.T. we are following a wrong track. The time we are in U.T. D.C. Transport wing come under Transport Department why? Because there are too many vehicles. It was looked after by the smallest and unimportant Department the Motor Vehicles wing, D.T.O. at the head. Now there are two M.V.Is they deal with all the Transport Authority file, M.V. Act. Francing rules and Inter State Commission. They cught to be the enforce these rules only, but we are following the opposite direction. So, the Government need to consider this matter carefully.

I am deeply grieve with the problem faced by the Education Department, due to lack of fund the Department cannot provide substitude teacher, and some institutions have to be closed. 20 If we have passed their plan budget we might not face this problem.

To promote sport the sport Department has taken much step the central Government also supply many sport facilities. However the biggest Sporting Club in Mizoram is Departmental Sporting Club. Did the Government allow Department to form Sporting Club ? Is there any provision ? The fund spent by Department on Sporting Club resulted in great corruption. The efficiency of the Department also become low as the Department appoint some talented persons as S.A. or A.S.I. due to the talent they possessed. It is desirable if the Government frame rules and encourage non -Government. Sporting Club by providing them with sport facilities.

Afforestation is very important in all parts of the country. The way we practice afforestation in Mizoram is not suitable, first we deafforest it, then planttress which will be fruitful only in after 20 to 30 years. Im my opinion it will be more suitable if the existing Forest are preserved instead of destroying natural forest and Planting new trees.

Lastly, I am very sobry that the Government had place a permanent bench of Gauhati High Court at Aizawl. During the M.N.F. Ministry also the central Government have made this same proposal but we refused it. And in the Governor's speech it states that in pursuance of the Peace Accord there shall be permanent Bench of Gauhati High Court at Aizawl". Those who signed the Peace Accord are very conflous about the entiltement of High Court. About the entlitlement of High Court it is also found in Article 214 and 231. It is specially mention in the Peace Accord No. 12(iii) "Mizoram will be entlitle to have a High Court of its own, if it is so wishes". I request the Government to take initiative to have a High Court of our own in Mizoram.

Mr P.C. BAWITLUANGA : Mr Deputy Speaker Sir, I am very pleased by the Governor's address as he had mention the achievement made by the Government I also wish to some of the points.

It is comforting that the Government have tried to achieve Self-sufficiency in food grain. During the monsoon also the Government have stocked enough rice for all the people. As we know at Khawbung also their godown is stocked with rice as a result some of the rice are also spoiled. This is due to the abundant supply of rice by the Government in this region.

In cur state we practice Juhm cultivation which is very harmful for the Soil as it also consumes time and energy, which resulted in little harvest. In order to control this practice the Government had New Land Use Policy. Under this scheme families are selected to do different types of occupation like piggery, poultry farming, Cattle rearing, Fisheries etc. I do believe we shall be self-sufficient soon by adopting the various occupations.

Regarding Co-operation Department I am very pleased to mention their achievement and the Government intentions. The Co-operative Apex Bank has helped the people by lending loan to the people. With the loan they have taken they do different types of works thus, promoting their livelihood. As we found in the Governor's speech, the Government has plan to open 7 new Bank next year. Can we not call this as achievement.

The achievement of Education Department is praiseworthy, they have opened 73 schools under operation Black Board Scheme and 14 School were upgraded to deficited Schools. The Government also proposed to introduce various measures so that Mizoram could achieve the distinction of being the first state in the Union of India to attain 100% literacy.

The Revenue collected by the Excise Department is much more than the previous year. This shows their efforts and hard-work.

The cost of one Timber is around Rs 80| - and the daily wage of one carpenter is Rs. 100/and labourer Rs. 50/- It is very difficult for us to construct even Assam type building. To solve this problem as we found in the Governor's speech the programme of the Government "A new programme of longing operation is being proposed with the aim of lowering the rising prices of Forest products in the state". To solve our problem further the Health Department also plan to open an institution to study Diploma in General Nursing, Pharmacists and Medical Technology. Not only this the Government also open 'Vocational Training Centre' at Central Jail. The word Khandsaki Sugar Plant and Limes Burnt clay Pozzalana are Hindi word. I hope the M.L.A. of the Aizawl West II will be satisfied with my clarification on the above words.

Lastly, I want tomention that the wayside Restaurant at Chhiahtlang which is im my constituency is meant not only for the rich and well\_to-do people but also for all the masses. Everyone is warmly welcome in this Restaurant. Opening a wayside Restaurant is one of our achievement Thank you.

Mr LALRAWNLIANA

Mr Deputy Speaker Sir, it seems we are very pleased by the Governor's speech. I also want to discuss some of his speeches.

In the Governor's Address paragraph 10, it state that M.P. Election was dome under a peaceful condition. It may be true. But the election of Mara District Council was not peacedul. I am very sobry for that.

About P.H.E. on paragraph 10 "The Hmar People Canvention agitating for an Autonomous District intensified their activities mainly in border areas adjoining, Mizoram, Manipur, and Cachar. However with the firm and tacful handling and close supervision by the concerned authorities the over all law and Order situation remained Peaceful". This contradicts my question which the Health Minister has answer me this morning. Which is true the tovernor's address or the Health Minister's for my question ? As we all know Government servants have to leavetheir station for fear of the H.P.C. It is good to consider again the Governor's address.

In paragraph 2 of the speech wefound about Jhum control programme. In my constituency at Aibawk C.D. Block Jhum control programme has been implemented during the M.N.F. Ministey. About 200 families are selected to rear Cattle, some Poultry Farming and again some Pig breeding farm. These families have taken up the mention accupation by giving up the farming Jhum Cultivation. However, the present Government did not pay much attention to them. As a result they face many problems. I request the Government to consider their crisis otherwise the Jhum Control programme in these region may fail.

The desolution of Village Council by the Ministry is against the law. They have dissolved 200 to 300 Village Councils, many have sumitted a petition to the High Court. 12 of them have acquited by the Court. Most of the dissolved V.Cs are non Congress (I) V.C. Besides the dissolution, to take charge of V.C. they appoint the Congress (I) member or in some place the C.A. These people misuse the V.C. seal, they use it for their own benefit. This may hamper our growth and development.

The Congress (I) had promised to give Rs. 10,000/- to the farmer in the Election manifesto. Did any farmer receive, this money ? When I am in tour I asked the farmer so far none has receive it was it just for election campaign ? They are fooling the people.

However, during the present Ministry the number non-Mizo are increasing so much. What is the reason ? I request the Government to restrict the Inner Line permit and also to check the permit regularly even the persons who already possessed it.

In my constituency, the Darkhuang Project at Muallungthu as we found in news paper, the land for Jhum control ane acquired by Ministers and big Officers. As it is the case, the Jhum control is neglected. I also again requested the Ministry to consider this Project again.

Mr Deputy Speaker Sir, as we found in the Governor's address of paragraph 2, "My Government is comitted

to protect the right and privilege, of Mincrities according to the provision of the constitution of India and the value enshrined in the Mizoram Accord. The concerned of the Central Government for the welfare of Scheduled castes and Schedule Tribes as reflected in the 62nd constitutional Amendments is well appreciated for which we are thankful to the Prime Minister and his Cabinet Colleagues" Mr Deputy Speaker Sir, these pleased me very much. I believe every one will be happy about the protection of Minorities.

Mr Deputy Speaker Sir, on paragraph 8 it was running, "My Government is giving utmost importance to Agriculture with a view to achieve self-sufficiency in food grains". The reason for this is that the Government had a programme of New Land Use Policy.

Mr Deputy Speaker Sir, the step taken by the Industry Department is also very pleasing. As we found in the Governor's address Khandsaki Sugar Plan at Saitual will be open soon. Under Industry Department various Industries like Sugar Mill, Sesame Processing Plant, Carpentary, etc. are established through the Finance of ZIDCO.

I'd like to mention one of our achievements i.e. Greater Aizawl Water Supply scheme. This scheme at Aizawl is already released, at Lunglei also the work is in progress. In sport also we have made much progress, one youth has represents India in Boxing at Foreign Country. In Championship they participated at Agartala and at Shillong altogether they bagged 15 golds, 15 silvers, and 15 Bronze. The Local Administration Department also made many achievement in the near future they are trying to distribute side for Housing construction.

I am very glad for the speech about the Establishment of permanent bench of the Gauhati High Court at Aizawl. Now we have only District Council Court bench at Aizawl many of our hardship will be solved.

Lastly, I found the last paragraph of the speech very wonderful. I wish you all success in the common endeavour for the welfare and all round development of the state. It is great that the Government had wish its best for the state of Mizoram. Jai Hind.

Dr.R.LALTHANGLIANA : Mr Deputy Speaker Sir, it is pleasing that the Government had given help to the people through New Land Use Policy.

Recently, I went to the Deputy Secretary Aural Development Department and enquired about the beneficiaries of New Land Use Policy. Serial No. 75 to 210 and between 297-318 are all member of well to do family, they are not fit to receive NLUP. It seems that utilization of NLUP fund is not appropriate mention are also not made in the Governor's address. How many Bulldozer the Government had at present ? As already mentioned by our respected member Pu Lalrawnliana, did the Congress (I) fulfill their manifesto of supplying 10,000/to every farmer and also to give GCI Sheet for roof to all who do not have GCI roof. Or is it just that they were indulging in politics of votes.

On page 3, we found, "High Priority has been attached to the development of Education". Contrary to these, the Education Deptt. has faced many hardship, the T. T.I. building at Lunglei cannot be completed due to lack of fund, building grant are not sanctioned, not only these the Govt. is unable substitute teacher I am also glad to see achievement made by the Health Deptt. But due to the poor supply of Medicines many life are lost. In the case of Pu F. Rolala, the unavailability of the prevention of Tetenus injection, he lost his life. The Central Y.M.A. demanded an enquiry on his death. Till today the enquiry commission did not submit their report. What is the reason of taking so much time ? Also when I want to rural areas I visited the P.H.7. unfortunately I did not find any medicine I believe it will be good if the Government takes step in the stocking and suplying of more medicines. At Lunglei Civil Hospital there is not specialist Doctor it will pleasing if specialist Doctor are posted in this Hospital.

In response to the question regarding the Black Topping of road, the Chief Minister has told us that 40Km were Black Topped under Lunglei Division P.W.D. Moreover, as it appears in the Accord and Schedule of works 271/2Km under Lunglei Division P.W.D. were Black Topped. In the achievement made by the Government within 200 days we found the construction of work of the Mizoram Quest House at Calcutta which has been started since August 1989. It seems that the final agreement was signed by the Contractor only in 15.1.1990. Can the work be started before signing the final agreement ? Besides, mention are not made on the achievemen of P.W.D. of the Lunglei-Buarpui road. As we know the work is in great progress.

the work is in great progress. In additional to the above. What is the reason for not completing the construction of Lunglei Sabği Bazar ? I am sorry to say that in the Governor's speech nothing is mention about the Hydro-Electricity is our basic infrastruction which is very useful for our development. Thank you. : Mr Tawnluia.

MR VANLALNGENA DEPUTY SPEAKER

Mr TAWNLUIA

\* Mr Deputy Sir, It is pleasing that you have given me this opportunity to discuss our Governor's

Address in this Legislative Assembly. But it is sad to say that the speech was not carefully drafted computed and approved as in the case of High Court, in the Speech, \*In pursuance to the Peace Accord, there shall be a permanent bench of Gauhati High Court at Aizaw". If the speech was scrutinized before hand, these mistake won't be committed.

I was surprised that mention are not made on the Bairabi Hydel Project Power is utmost importance for the Development of the State, without it, progress and Development is hampered. Regarding Bairabi Hydel Project, in 1988 when we were under President's rule, the Governor said that the Government had sanctioned the clearance, the Ministry also back up this, as we found in our Chief Minister's Independence speech of 1989, "To meet our long term, Power need, the Government has also vigorously persued sanction of the Bairabi Hydel Project and headway has been already been made in tetting this major Project cleared at the Central Government Land", Nevertheless, it appears that this project is neglected I request the concerned Minister to clarify about this. The Rail Head at Bairabi was intended to commission in the month of March 1990. Can it be commission this month ?

In the Independence speech of our Chief Minister Broadcaste by the All India Radio last year. He said that the Governor will purchase all the Agricultural products of Mizoram. Contrary to his Speech the poor farmer could not find where to sell their product. I request our Chief Minister to fulfill his Speech.

MR VANLALNGENA DEPUTY SPEAKER Time is up we have to discuss whether to continue or not.

ONE MEMBER

: Mr Deputy Speaker Sir, let him finish his Speech.

MR TAWNLUIA

: Mr Deputy Speaker Sir, I also want to discuss about page 7 of 15 paragraph on P.H.E., "with

regard to Rural water supply each and every inhabited village will have at least one source of sustain drinking water by March 1990," This statement is unbelievable, I believe he is exaggerating too much.

The rehabilitation of the M.N.F. returnees is also not mentioned. To fulfill the Peace Accord it is the responsibility of the Government to rehabilitate the M.N.F. Returness. Besides, the achievement of the Social Welfare is also not mentioned. So, Mr. Deputy Speaker Sir, when I carefully examine our Governor's speech. I found many statements which are unreliable.

Mr. K.VANLALAUVA

: Mr. Beputy Speaker Sir, thank you for giving me this opportunity to discuss our Governor's

speech. First I repudiate the statement on page 3 regarding the opening of 23 Minor irrigation. It says that 23 New Minor ifrigation have been opened. This is prevaricate as some are not yet ready to be open. There is two cases in my constituency alone. So, I request the Minister incharge to see whether they are ready to open or not otherwise we may turned our Governor's speech meaninglessly. There is also something wrong on the distribution of I.R. D.P. and N.L.U.P. some had received both, and may did not received either of them. Why there is such a distinction ?

I also want to ask the Minister in-charge Mizofed why there is scarcity of Petrol, whose faults is it ? The Mizofed or the Petrol agent ? It will be pleasing if there is sufficient supply of Petrol.

During the M.N.F. Ministry the Government decided to provincialised three Colleges, agreement was made, but could not fulfill, so during President's Rules these Colleges were provincialised under Government. An order was released that the Principal and Vice Principal's seniority will be counted from 1st January, 1989. Again there was another order that the seniority of the Principal should be counted from 1st January 1990. What is the reason ? It means they will be junior by one year. We all know that seniority is very important in our service.

: Mr Deputy Speaker Sir, I don't know whether to be pleasing or not in the Governor's speech.

Being a member of the opposition party I will not just critisize the Ruling party. But I will discuss some of the points which I feel needs an improvement.

The Government did not maintain discipline in the Office, most of the Government employees did not attend their respective Offices in time. The Office hour is 8:45 A.M. till 5 P.M. at 10:00 A.M. also the Government servant's are not found in the Offices but leave the Office at 2:00 P.M. I request the Ministry to be strict in their attendent.

Every year our Agricultural out put are increasing, the funds spent are also increasing as we found in our Governor's Speech of page 1, in actual every year we are facing famine, what is the reason ?

The selection of the benificiary of N.L.U.P. is also very unfair. Only the member of the ruling party are selected, not only this the way they utilized the funds is also not appropriate. As in the case of one person of Thiak Village, he had received Rs. 20,000/only Rs. 10,000/- is for the construction of High School building and Rs. 10,000/- for the construction of his own house. Can new land use policy be meaningful in this way ? In the way we give compensation also we must be cautious.

Regarding Education it will be pleasing if the Government sent more student in foreign country to study Electronic, Physical Education, Music and Arts, so that there will be an all round development. Besides, I would like to mention also, that in Mizoram there are three Districts, among them the Government provide, not only provide their fees but also all their text Books in one District inspite of providing their Text Books. They use Text Book and syllabus from other States. What is the reason of using other States syllabus and Text Book ?

Mr VANLALNGENA DEPUTY SPEAKER : Mr J.Thanghuama its now recess period.

Mr J. THANGHUAMA

: As your wish but I wish to speak in place of our opposition Leader.

DEPUTY SPEAKER

: Let me ask the opinion of the mambers in the House. Then you can continue.

want to discuss the improvement mention in our Governor's speech of page 4, paragraph 9, all the M.B.B.S. quota at Assam is usually not fill up, in future it is desireable to have all the post filled up. Due to lack of fund there is a poor supply of Medicines, so the poor people from the rural areas required to purchase Medicine when they are in Civil Hospital also to solve this problem Ministry must sanction more funds for the abundant supply of Medicines.

The revenue Department also needs reform. They must be careful while giving no-objection certificate and they must also supervive those who construct House near the roadside. Our town road become narrower and narrower as private House near the roadside are ancroaching the road. If this practice goes on very soon we will be facing a great problem as vehicles are increasing day by day.

In the Governor's speech we also found that top priority shall be given to the road between Kanhmun-Zawlnuam and Kawrthah-Bairabi, this pleases me very much. Otherwise there will be road block during the rainy season. At Zawlnuam constituency there was a great cyclone during 1988-89, for the rehabilitation, the Government had sanctioned Rs. 10 crores, unfortunately, the rehabilitation was given only to one party member.

The Government also have to restrict the rising fare of Taxi and Town Bures. Some Government Officers also misused the Government Tehicles, the Ministry need to see this also. Regarding the distribution of G.C.I. Sheet, there is a great distinction, and the beneficiary of these G.C.I. Sheet are again belonging to one party and some of them already have G.C.I. Sheet for roof. My constituency is also one of the best places for silkworm, if the sericulture Department take initiative hope it will be one of the best sericulture farms in Mizoram, as a consequence many people will earn their living through it.

I am also very please that the Government is intending to increase the pay of IV Grade, Pharmacists and Market checker.

In 1962, 2nd Assam Regiment were disband, all the sepoys in this Batallion were sent to Jail, after a year their offence was changed as mutiny, later this was cancelled. They were also allowed to claim their pension unfortunately some did not enjoy their pension, I request our Ministry to see the reason why some could not received their pension ?

Regarding the supply of power, the power and electricity Department should be more cautious in the matter of bill, as the metre-readers are not efficient, there are some mistakes in their culculation of the bill, when we submit complaint, the Department reduce our bill by Rs. 100/~ what is the reason behind this ?

Lastly, I request the Government to be more careful in suspending the Government servants.

Mr. J.LALSANGZUALA MINISTER crease of rice supply. The decrease of rice lifted during December to March is that the worker in the F.C.I. maintain co-slow so the programs was work alow. The December to lifted the program was work alow. go-slow so the progress was very slow. The Department take much effort now we are allowed to take the rice in areas.

Secondly, Mr Zoramgthanga's question on the difficulty of L.P.G. connection. At present there are 14648 connection. Plan are made to open new agent at Lunglei, Serchhip, Champhai and Kolasib. The Cachar boting plan will be commissioned in April 1991, things will be a bit easier when C.B.P. will be commissioned.

Our respected member Mr Zo**st**ama Pachuau, Mr. Rualchhina and Mr K.Vanlalauva have raised question on the problem of petrol supply by Mizcfed. The scarcity of petrol is due to the increase of vehicles than estimated. To solve this problem the Government has taken much effort.

Mr Zosiama Pachuau have thanked the Government for maintaining sale proceed, I hope there will be much improvement in next year. As one member had asked, the Government has released funds as we have passed in this House. Up to February in non-plan the Government has released Rs. 75,14,90,000/- on plan 6,61,35,200/- The scarcity of money is due to the stopping of the central subsidy. On supply as our respected member Mr R.Tlanghmingthanga has asked, shortage of rice supply is due to natural calamities like landslide, flood etc. Now the Government is constructing F.C.I. Godcwn at Lunglei and Lawngtlai where 50,000 quintals of rice can be stocked. When these godowns are finished our problem will be solved.

Regarding the question of Mr J. Thanghuama, the increase of the pay of IV Grade, Pharmacists and Market checker, the Government is under consideration of their pay i.e. IV Grade; Pharmacist and Market checker.

Mr S. HIATO MINISTER

: Mr Speaker Sir, the charges of one member not actually opening Health Sub-Centre is untrue. The

fact is that the previous Ministry has opened 314 Health Sub-Centres where the Central Government had sanctioned funds for 260 centres alone. So for wants of votes they have opened more centres than permitted, More than 50 centres were without financed, as is required, the present Government has taken up these Centres.

The wayside Restaurants are under the Tourism Department it is meant for all the people. We have Tourist Lodge at Aizawl, Champhai and Kolasib and way-side Restaurants at Thingdawl and Chhiahtlang. The money we received from Tourist Lodges and wayside Restaurants are for Government revenue.

The Hmar People Council demanded area are not peaceful at first, they kidnapped and killed some police as a result there was a great crisis. Now the situation is peaceful many Government servants also returned to their post.

On the question of Mr R.Lalthangliana regarding the death of Mr F.Rolala of Tetanus. As demanded by the Central Young Mizo Association the enquiry commission was formed on the August 25, 1989, Pi Lalkungi Hnamte as chair person, due to poor health she takes Medical Leave. Then Mr Lal Khawbung A.D.M. (J) was appointed as chairman, he being a Judicial Magistrate it was not appropriate to have him as a Chairman in this Enquiry Commission, again Mr Lalmawia Chhakchhuak Executive Magistrate and Town Administration of D.C. Office was appointed as Chairman on 12 October, 1989. The member Dr Ringluaia, Medical Superintendent Durtlang and Zokhuma Chandmary. These team is now taking an enquiry. I hope they will submit their report soon; On the Supply of Medicines, the Government cannot Supply the Medicines required by the People abundantly due to lack of fund. When I went to rural areas I did not find any P.H.C. without medicines. I also did not know officially that there is shortage of Doctor and Specialists. The Government did not officially know that the M.B.E.S. quota are not fill up in Assam. The qu The quota are alloted to us by the Central Government.

Mr ZALAWMA MINISTER Mr Speaker Sir, as stated by our respected member Mr Zosiama Pachuau that there must be a proper

reason for the desolution of Village Counci. There are 460 village councils in Mizoram. Out of these 243 were dissolved refering to Village Council Act 1953 section 25. In the desolved Village Council Area, the Government appointed representatives to look after the affairs of that Village based on section 2 of Village Council Act of 1953.

There is a great progress in the Local Administrative Department. Our respected Chief Minister has also distributed more than 1,000 minor works to the rural areas. Not only this the Government also has given 2,500 House sites to the landless People, besides more than 6,000 families have received G.C.I. Sheet for rooff, this is wonderful. The Governor did not mention many of our achievement. One is the construction of footpath for pedestrain from Chandmary to Chaltlang recently the Cabinet also passed the construction of the aforesaid from Durtlang to Zemabawk. The L.A.D. has taken much step for Urban Development also.

Dr R.Lalthangliana's question regarding the construction of Sabji Bazar at Lunglei. For the Construction of this Bazar the Central Government had Financed Rs. 1,25,00,000/- Due to some reason we could not resume this work, I hope we can resume the work from next year. Besides this, the Government also plan to construct Market at Hrangchalkawn, Serkawn and Venglai costing around Rs. 1 lakh. The Local Administration Department (L.A.D.) also construct more than 20 road side market in Rural areas. The Finance Ministry also sanction funds for these purposes.

As Pu Tawnluia had expressed his concern, on the violation of Road reservation, and Pu J. Thanghuama on the encroachment of road by the private. This is a great problem, and there is no official report, if there is a report the Government will take action. The most important thing is that we all have to work together for the preservation and safety of our Town. Regarding the distribution of the House site the Government is very strict. If any person is given person House site who already possessed, please report it to the Government also, as Pu Lalrawnliana had stated, regarding the possession of land by some officers at Darkhuang Project Muallungthu the Ministry cannot take any action and there is no report.

Regarding sodium vapour light, as Pu Zosiama Pachuau and Pu J.Thanghuama had expressed the Government had made a plan to programme to put the sodium vapour like in all the town area in phrase I Chamdmary to Kulikawn, in phrase II, Bawngkawn, Chaltlang and Ramhlun and Electric Veng. Due to lack of fund all the programme are not implemented. I hope the Government programme for this purpose will be fulfill soon.

Mr C.L. RUALA : Mr Speaker Sir, I express my heart MINISTER felt gratitude on our Governor's Speech. It is impossible to men-

tion all our achievement anyway he had mentioned briefly some of the many achievement the Government had made in various field.

Mr Lalrawnliana, the M.L.A. of Sateek constituency had said that the situation of Hmar People Council demand area is not peaceful as express by our Governor. The Governor here means that though there are some perplexity the concerned authority can handle the situation peacefully. During the Lok Sabha election in some parts of India, there are many disturbances, people also lost their lives. But in Mizoram the Election is held under a peaceful situation. This is due to God's guidance and protection.

As express by the respected M.L.A. of Ngopa Constituency on Waste Land Development and Social Forestry, that it is better to prescribe the existing forest than destroy natural forest and plant new trees. The need-...91/- ness of planting thees lies in our system of Agriculture. In Migoram we practice Jhum Cultivation every year more than 40,000 hectres of land is destroyed, and forest are denuded. In the near future forest product will be our main source of Revenue. The Government also takes much step for the development of Forest Department.

Regarding the Forest quarter at Pangzawl as stated by Mr R.Romawia. The Forest quarter at Pangzawl is not occupied as it was located in an isolated place which is dangerous for human life. It will be suitable if the quarter is shifted to some paceful area.

It is good to plant new tress in the hill slope of Durtland, as express by Pu R.Tlanghmingthanga, but the hill slope of Durtland are all private land. So the Government cannot just plant frees.

Dr H. THANSANGA MINISTER Mr Speaker Sir, I am very happy that every member speeks freely. this shows that we are in a demecracy.

First, I shall clarify "Jan Shikshan Nilayam's," it means education for all. This year is international Leteracy year, 'to promote leteracy the central Government has taken many steps.

Secondly, many member have critisized about High Court. The critisize lies on the statement "in pursuence of the Peace Accord. There are two types of bench viz permanent Bench and Circuit bench. Before we have fullfledged High Court in Mizoram it is required to have either the aforesaid bench, due to lack of fund new we can not affort to have fullfledged High Court. In a permanent bench two judges will settle permanently in Mizoram and do all necessary works but in the later bench judges will came temporarily for a short time and will return to their states again. So, the cabinet decided that, it will be more suitable to have permanent in Aizawl. To have a permanent bench does not bar our saving a High Court of our own. Therefore, I request respected members to understand about the permanent bench of High Court at Aizawl It is possible to have a High Court, I hope we shall have soon.

Regarding the expenditure of the Centenary Celebration, the education department alone does not sanction all the funds, expenditure of Rs. 14,66,100/the funds were taken from various Department, the Art and Culture of Education Department act as the Host.

Regarding the appointment of the three provincialised College Principals, the date of appointment was the agreement with effect from ic. January, 1989. Moreover due to some problem the D.P.C. set only in September 1989. So, a review committee was formed to consider the matter

Mr ROKAMLOVA MINISTER Mr Speaker Sir, let me clarify about the issue of the Taxi per-

mit, it was said that the figure does not tally, it was the faults of the concerned Department. I request you please to forgive the Department. Regarding the fare of the take and buses there are a committee who consider the fare, they published a notification, to submit suggestion on the fixation of fare non has submitted any suggestion.

Secondly, the construction of Roads at Mara District and the Chakma District are Saiha-Tuisumpui 21 Kms, Chhuarlung - Ainak 14 Kms, Supha - Lungpho 8Kms. Link Roads Lungbun and Richat Project 8 Kms, Nisarih tlang and Chhiahtlang project 7 Kms, and also Kamala Nagar - Parva roads (which is under construction) 50 Kms When we add it come to 96 Kms. Besides, 5 Km Link Roads means, Lawngtlai - I Truck Road, Lawngtlai C.T.Road. All the three combined roads make 5 Kms.

I am very sorry to mention that there is a printing mistake regarding the achievement of A.H. and Vety. It was not Sailam and Venghlui where vetenary Hospital was opened, it must be Sailam Venghlui. I hope the same mistake won't happen in future.

Mr LIANSUAMA MINISTER : Mr Speaker Sir, as asked by Mr Zosiana Pachuau that some of the selected beneficiaries of the

.I.R.D.P. did not receive the fund, the reason for the delay is that half of the fund is contributed by the Central Government, and half by the State Government, the former released the funds in instalment as a result we could not distribute the fund in time. I hope the I.R.D.P. can be distributed soon.

Regarding the question of Mr Rualchina, the M.L.A. of Aizawl West-II about the word 'LIMPO' It is a material useful for the formation of Cement, it is some what like lime.

As some member has occured the present Government of actually not fulfilling the manifesto of giving Rs. 10,000/- to the farmer. We found the fulfillment of this programme in the speech of our Gover-nor on page 4 paragraph 8. In Forest Department alone also 2,869 families have received these funds. In the first instalment they are given Rs. 7000/- according to their progress the remaining fund will be given later on. The M.L.A. of Lunglei North Constituency said that there are well-to-do families in the selection of the beneficiary under the NLUP. At first, the names of all those unemployed who chooses different types of occupation were sent to the Government. This list was sent back to the D.C.Lunglei and B.D.O. Lunglei to make correction, the names of beneficiary and I.R.D.P. those who received G.C.I.Sheet for roof, and those who ate employed are all dropped. So, a new list is now made. 

Regarding the statement of Mr. J. Thanghuama the beneficiary of J.R.Y. Rs. 20,000/- at Thiak Village. He said that this person has used Rs.10, 000/- to construct his House and another Rs. 10,000/- for the construction of High School building. The Government will Examine about this.

Mr SAIKAPTHIANGA MINISTER Mr Speaker Mr. let me first clarify the statement of Mr H. Rammawi the M.L.A. of Sangau

constituency the Budget of Agriculture Department decreased this year as some of their project were taken by the Rural Development Department.

Mr R.Romawia's question regarding the Zote-Moto Link Road. The Government have made a plan, now the Finance Department also sanctioned fund for the construction of these Link roads. As some member has asked though there are successful harvest in paper, in actual, we have a poor harvest. The reason for this is that more of the W.R.C. area where there is successful harvest is in the border of Cachar and Tripura. So, the farmer sold most of their harvest to the Beighbouring states.

The accusition of the Mr. Lalrawnliana M.L.A. of Sateek Constituency regarding the Land cquired by some Officers in the Jhum Control area of his constituency is not true. There is a member who maintains register to record about the measurement of the Landm and the fund received and expenditure.

As we are in a disturbed area for 20 long years, it hampers the growth and progress of our agriculture greatly. I therefore, request every member present here to take initiative in promoting agriculture in Mizoram.

#### Mr P.SIAMLIANA MINISTER

Mr Speaker Sir, our respected Chief Minister will wind up in the end. I shall clarify some

of the statements. Firstly, the respected M.L.A. of Ngopa constituency Mr Zosiama Pachuau has said that the Administrative Officer of Kawlbem has misused the F.R.S. Fund. This is the first time I have heart about it, spot verification will be made on this matter.

Many of the M.N.F. Returnees were given rehabilitation some were given employment in Offices, and others contract work. I can not mention the exact members as they work in different Offices. The Mizo Liberation Army. When they surrender they were also given Rs. 10,000/for their rehabilitation. As Trade and Commerce Department is a new Department it does not make much progress. It is very successful in marketing the Squash to the neighbouring states.

MR NIRUPAM CHAKMA MINISTER

: Mr Speaker sir, first of all I would like to thank Pu Zosiama Pachuau for praising the Mizofed

and the Department of Co-operation. Mizofed achieve great success compaining to the previous years and I hope this Autonomous body will bring a success in the future also. The Co-operation Department also taken up the initiative to pay the challenge which we called self-sufficiency in meat and vegetables. As we all know Mizoram has procured meat and vegetables from Burma and the neighbouring states. Now various steps have been taken to tackle with the problem we have faced, a seminar had been organised at Aizawl and soon a seminar will be held at Lunglei and Saiha.

Regarding the problem of Petrol Supply our supply Minister has already answer the question but Pu Zoşiama Pachuau's questions was neglected as there was no time to answer that. But still I want to inform the House that there are 43 staffs in the POL Wing of Mizofed. According to their work load we feel that the present strength is sufficient.

I am sorry that in the Governor's speech the progress and a-chievement of sericulture Department is not high lighted. I hope in future it will be written in the Governor's speech.

Hon'ble member Pu J.Thanghuama has pointed out that he has does not like suspension, that may be his personal opinion. The suspension case in Sericulture Department is completely in accordance with the C.C.S. Rules. That should be my answer Mr Speaker Sir, regarding the point raise by respected member. But I would like to express my personal satisfaction on the initiative taken by the Agriculture Department, when we see page two of Governor's speech it goes like this, "During the next financial year emphasis will be given to Jhum Control Programme under the New Land Use Police for which suitable compact areas will be selected in Rural Development Blocks along the international and inter state boundary." The spirit of this programme which is likely to be under taken by the Agriculture Department pleases me.

Lastly, I would like to clarify some points which the District Council Minister have not answered, or the point raised by Pu J.Thanghuama. Regarding the District Council he said one District Council is referred he did not mention specifically which District Council it was but I presure it is Chakma District Council and of their Primary Education. When we see the provision of sixth scheduled in the constitution, paragraph 6 provide's power to the District Council in the establishment etc.

In the third paragraph the last two sentences goes like this, "May prescribe the language and the manner in which primary education shall be imparted in the Primary School in the District Council. Now it is very clear that it is the District Council Authority to decide their Primary Education policy within the District Council. And it is very clear that the Government has he right power to alter or to form policy. Therefore, the Hon'ble member should understand the situation in this specific District Council.

Mr LAL THANHAWLA : Mr Speaker Sir, if it is against CHIEF MINISTER the Rule I request our respected members to forgive me, that one of the most prominent persons of Mizeram Pu Sainghinga had passed away at 5.40 P.M. was 93 years of age.

Mr Speaker Sir, I am very please that the opposition members had detected many of the short coming of the Government, this shows that they take much initiative in the Government. When we all work together there will be progress and development.

It is possible to include all the achievement of various departments in the Governor's speech and there are also some printing mistakes in his speech I request all the members to understand this short coming.

Regarding a permanent bench of High Court at Aizawl, many members are not contented I am very sorry for this we all desire to have a fullfledged High Court in Mizoram but circumstances compell us to accept a permanent bench of High Court at Aizawl. Being a new State we do not have enough fund to established a High Court the Central Government cannot sanction fund now, cases are also not warrant to have a High Court. As, we are in this situation the Central Covernment, advise us to have a permanent bench of High Court in Aizawl. Justice also come and verify the place for High Court. I hope it can be opened by the month of April, Two Judges will settle permanently here and do all the necessary works, if required the Chief Judge of Gauhati High Court will also come and act as a care taker. Having a permanent bench of Gauhati High Court in Aizawl is one of the steps for achievement of fullfledged High Court. Due to our Financial position we cannot affort to have a High Court so I request our members to understand our position and to be contend with the permanent bench of High Court. Regarding the place for High Court we did not finalise any decision. Is Pu Tawnluia has suggested Remna Run may be suitable and we also proposed it, but when the Chief Justice visited us, with our Law Minister they verify the place and suggested a place near Assam Rifle at Khatla.

Regarding the shortage of electricity supply the reason is that from Nepco and Assam Electricity Board we produred 6 M.W. and 5 M.W. respectively but as the line outside Mizoram are not functioning we could not received power, due to heavy rain it cannot be repaired as we desire. It is out our purview we could not do anything I am very sorry for this. The Government is taking step to be self sufficient in Electricity by planning to construct Hyder Project in different parts of the state. The C.W.C. has taken investigation at Tuirial, Tuivai and Serlui (B) the responsibility of constructing Mini Hydel Project.

As some member has said about 'Bonus' in our present position it is impossible to give Bonus to the Government servants. In three or four states in the Union of India the Government servants are "Over Staff" Mizoram is among one of them. The pay of the Government servant is also among the highest. Last year also inspite of the poor Financial situation the Government had given Bonus to IV - Grade and Driver. Now we are at the end of the 7th five year plan we are facing great financial crisis besides the previous Government has left us with over draft.

It was said that some people hard borrowed Departmental fund. This is not a new thing, it had been practised from long time, the reason is that financial discipline is not maintain. So the present Government sent a team to audit the Account of various Department. Chief controller of Accounts at the head. These teams detecmany faults some corrupt Officers were suspended. Not only suspending them they were also order to repay the money they have corrupted, their property were also assessed. The Government no make a restriction in the expenditure of funds, 18 orders were also published relating to this matter.

The desolution of Village Council is due to the violation of Village Council Act, 1953. The number of dissolved V.Cs. appeared to be high as the Village Council dissolved during the previous Ministry were included.

Regarding the maintainance of Law and order in the H.P.C. demand area the in the Governor's speech we found that the situation remain peaceful. We said that the situation remain peaceful because it does not effect the masses, it was dangerous for the Government sevant alone, now by the firm and tactful maintainance of Law and Order by the concerned authority the situation is peaceful, the Government servants were also given order to return to their respective stations.

We are not relating the M.N.F. returnees, we are trying our best to rehabilitate them as much as possible. They are given financial assistance and employment.

Regarding compensation it is really difficult to receive compensation. We have discuss about it even in the House during the previous Ministry. Funds were also sanctioned many people hope that they will receive the compensation, but all their hopes were turned into ashes, they were compelled to go to the High Court in 1987 and 1988, when we form the Government we consider about this compensation, Rs. 1,95 crore were to be given to 374 people. Mr Speaker Sir, I believe this compensation will be distributed as soon as possible. There are also many application claiming compensation in the three districts of the state. In Aizawl, District alone there are 20996 applications, Lunglei District 7582 and Chhimtuipui District 540 which are already verified. So, there are 30117 verified applications and about 1000 unverified application, The Goment is sericusly considering about the compensation in the next financial year it is decided to give the compensation.

As we all are aware of that this year we are facing heavy rain, and treamendous landslide resulting the collapse of Houses and amny also lost their precises life Due to financial crisis we could not give them much relief and rehabilitation. I am very sorry for this, We sent a report to the Central Government a team come and verify the place of occurance of the natural calamities. I hope soon the Central Government will sanction relief fund for the damages.

I am very sorry that in the some cases in the selection of the beneficiary of NLUP and G.C.I. sheet there occur scandal. Moreover, the concerned authority did spot verification and select only those who deserved it. I request each member to be aware of that all those who do not deserved are detected and dropped from the List. If you know any one, please report it to us, we shall take a serious action.

Regarding the scarcity of the supply of L.P.G. and P.O.L. I am sorry that we cannot improve their supply. The reason is that there is agent who cannot supply properly, in this filling station there hardly is petrol or K.Oil. If their Lincence are cancelled and give it to other who can manage it, I hope there will be much improvement. As the vehicles population are increasing day by day it is impossible for Mizofed P.O.L.wing to supply our requirement. However the Government is trying hard to improve the supply of P.O.L. and L.P.G. in every possible way.

Lastly, I am very please to mention that some of the number have expressed their gratitude for maintaining sale proceed properly. I hope there will be more improvement in the year to come. As we all know in Mizoram there are 100% Christian. If we work together with one mind and development in our state. I thank God for his quidance. Whatever we did may be for the His Glory.
