: Pu Dy. Speaker, he amendment Bill putluh House-in min phalsak avangin ka lawm e. Tunah Mizoram Salaries, Allowances and pension of the members of the Legislative Assembly Act, 1987 Amendment Bill chu House-ah ka rawn introduce e.

DEPUTY SPEAKER

: Bill hming kha Secretary khan a sawi a ngai lovang maw, hmanni khan an phut deuh che a, sawi tho la. Hmannia Bill introduce kha sawihona nei ila. Bill neitu Pu C.L. Rualan ngaihtuah phalna House-ah rawn dil sela.

PU C.L. RUALA
MINISTER

: With your permission Sir, I move the Mizoram essential service maintenance Bill, 1990 to be taken into consideration. Pu Dy. Speaker, ka Bill rawn putluh hi helaiah hian a hrilhfiahna timai ila, explanatory note pawh kha kan nei a. Khatah khan thil kalhmang chu kan sawifiain ka hria a. Tin, chumi hma chuan Pu Dy. Speaker, hmanna correct ngai kan tih te kha minor mistake an ni tlangpui hlawn a. Khangkha min onsa kin ka ring a Member zahawm tak ten. Kha kha chu kan sawi zui tawh lo mai ang a. Khangkha a then kha Press-in a Gazette a an lo publish tawh naah khan printing mistake an lo siam vang te-in kan lo chhut nawn vc naah khan dik mang lo kha a awm ta a. Mahse a tlangpuiin spelling pakhat diklo te khatiang kha a ni tlangpui a, kha kha kan member ten min hriatthiampui ka duh a.

Tin, hmanna ka sawi tawh ang khan Pu Dy. Speaker, he dan hi a tak chuan Mizoram-ah hian U.T. kan nih atang khan timai ila, kan hmang chho zel a,

tichuan U.T kan nih loh hnu pawhin U.T. a kan dan hman te kha Mizoram State Act 1986-in a min phalsak angin kan la hman zui zel a, chutianga kan hman lai reng a chu ngun deuh hiekin kan han exam a, hei hi dan helai Mizoram-in a dan anga kan siam ve mai loh chuan a him tawk lo deuh e, tute emawin an sawi pawrh chuan a him tawkloh deuhna a awm niin a lang an tih avangin hetiang hian mahni ina Bill ang a kan pass ve tur a buatsaih chhoh a ni ta a. Mahsela, Assembly Session lai anih loh avangin Governor ordinance-in kan siam chho ta a. Chu ordinance chu tun tun kan Session-ah hian hetiang dan a kan siam loh chuan tun atanga kar rukah hian vawiin niah lo tawp ta ila kan Session hi, vawiinni atanga kar rukah he ordinance hi a validity a tawp ve mai dawn si a, chuvangchuan dan a kan siam law lawna, dan a kan neih theih law law na turin he Bill hi putluh a ngai ta a. Tin, hetah hian he dan ang hianin khirh takin Sorkar hnathawkte kan vawng reng ang tihna pawh a awm chuanga lova. Nimahse dan chu enggemaw hun bikah a hman a lo ngaih dawn chuan notified a ni leh ang a, chutiang chuan hman a ni chho ang a tih a ni a.

Tin, a then chuan a hremna pawh hi a na lutuk deuh ve, seven year imprisonment tih a ni a, tih te pawh kan sawi mai thei. Nimahsela, kha kha chu a maximum a ni a, a minimum engmah a sawi lova, kar hmih khat a ni mai thei a, a maximum erawh chu seven year tih kha ani a. DEPUTY SPEAKER

Tin, any service in connection with any affairs of the State not being a service specified in any of the foregoing sub-clauses an ti leh nghal a. A hmaa la sawiloh zawng zawng a han ti leh a, a duh thawh deuh a ni. Hei hi ziak tel kher loh a tha lawm ni ?

Tin, hetilalaiah lah hian la sawiloh zawng zawng tih mai loh hian Sorkarin a a mamawh dan ang zel a essential service-a a declare, a puan thar te tih a hi ni ta zawk selangin chuti nilo va hotia fun sa vek mai a specific engmah awmlo a hi thil hlahawm tak a niin kahria. PU H. RAMMAWI

: Pu Deputy Speaker, kan Bill hi clause hnihna sub-clause (a)-na pakhatna - Such other group of persons tih rikngawt

a kha Excise Constable kan ti dawn nge, forest guard uniform ha chi kan ti dawn ? Chutiang anih chuan mention law law a tha. Khatiing other group of persons tih rikngawt a kha Police leh Home guard chu a ziaak lang a. Specific-a heng hi ziahlan tur ani lawm ni ? Engatinge such other group of persons tih rikngawt? Uniform ha kan ti anih chuan tih law law mai turah ka ngai a.

Tin, hetah clause hnihna (b)-na pakhatna kha refusal to overtime where such work is necessary for the maintenance of any essential service tih kha, hemi hmang chiah hianin driver kha kan nawr bet dawn emaw ka ti a, a lo ni lo deuh hlek a. Miin overtime a hna an thawh chuan an welfare kan en ngun mai tur a ni a. Overtime a hthawkte welfare te kan en duhloh vang leh kan engui loh avanga hotiang problem lo chhuak ta ni si, intihluinna leh inbarh luinna ang a kal hi chu a tha ka ti thei lova.

Tin, clause thumna palina (b)-naah khan any strike declare or commence whether before or after the issue of the order tih laia kha, order issue hnuah emaw, a hmach emaw khatiing strike a awm kha chuan he order a hi wawin niah issue ta ila, nikum lama strike te kha kan hrem thei dawn em ni ? Helai wording a hi whether before or after tihah hian before hi paih tur a ni dawn lawm ni ? tih ka lo ngaihtuah a.

Tin, hetah clause pasarihna ah khan en ta ila. No switch prosecution or other legal proceeding shall lie against any person for anything which is in good faith done, tih a ni a. In good faith-in

kan thalai ruaito pawhin mi an um hlum tawh a, thubuai lian kan nei tawh thin a ni lawm ni ? Holai dasah hian engatinge in good faith-a kawng zau tak kan hawh ? tih hi min ngaihtuah tir a. Hengte hi kan enchian a tha dawn lawm ni ? A practical side-ah hei hi en ila a tha ang em ? tih ka ngaihtuah a. Tin, kan bala lo chubuhna bul hi Pu Deputy Speaker, Chemtatrawta thawnhu ang deuh a ni a, threatening a awm vang a tih a ni a. Driver-ho an nawrh dawn avang khanin hei hi hmanhmawh a tih chuk chuk a ni a, he ordinance a hi. Kan Driver-ho nawrh tua avanga he order hi siam a ni a. Tin, chumi anih tokah chuan department hranga service dangte pawh a huan tel ve chauh zawk ang a ni a.
