PU LAL THAIHANLA : Pu Speaker, I have three .bitua-CHIEF MINISTER ry references to make for tow of our former members and Pu Rajiv Gandhi, shall I make these references seperately or together ? (Speaker : Do it together)

Pu Speaker, thank you for giving me time to make obituary references for the Hon'ble former members of this House namely Pu F.Lalchhawna and Pu R.Zolia-

na and the great leader of Insia Pu Rajiv Gandhi at the begining of this session.

First I would like to say about Pu F.Lalchhawna. He was the eldest among the children of Pu Pachhunga. He was born at Muallianpui. Lunglei District in September 1923; he married Pi S.Lianbuangi. He started his cover as a teacher in Primary School in 1942. He joint Indian Hospital Corp as a Nursing Staff on December, 1941 at the time of II World War. During the II World War he got active service in Burma Front and visited various palo.

When the II World War was over, he left the Burma Front and worked at Lunglei S.D.O. Offiand he got pension as an Assistant Circle Officer. While he worked in Government Office and even after he got pension he was very active. In 1977 he passed B.A. at the act of 54. He was intelligent and deligent. Pu F.Lalchhawna entered in the field of politics in 1977 and joined Mizoran Congress. In 1980 he was elected as Vice President for Lury lei District. He got the nominated seat in the fourth Mizoram Legislative Assembly and took on oath of allegiance on the 20th August 1934. In 1990 he left Congress Party and joined an MNF Party.

Pu F.Lalchhawna was a religious man. He was also friendly and amiable to everyone. He was very succesful even in his various carriers. After he got psension from Government Service, he worked as a contractor. Even in that field, he could become 1st class contractor. He also used to be a President in Motor owner Association, Motor Workshop Owner Association and in contractor Association, at Lunglei Pu F.Lalchhawna had minor heart problem and went to New Delhi to have medical treatment. But before he could have proper medical treatment, he died at New Delhi and his body had been burried at Lunglei. It is a great loss for Mizoram and a genial persor. Today, I am glad I have the chance to make obituary reference and also that we can have a time to show our respect in this House.

Pu Speaker we also lost Pu R. Zoliana a former member of this House Pu R.Zoliana was elected as a member of the first Mizoram Legislative Assembly in April, 1972 by Mizo Union Ticket. When he died on 20th May 1991 he was 58 years old. His father was Rev. P.D. Sena. Pu R.Zoliana was born on 18th October 1933. He got his graduate from St.Anthony's College, Shillong. He married Pi K.Zothanseii in 1966 December and they have 2 sons and 2 daughters.

Pu R.Zoliana served the Assem Government 8 years after this he served the Central Government for 4 years. He entered into politics in 1972 by joining Mizo Union Party, he was elected as a member in the first Mizoram Legislative Assembly from Sateek Constituency, He used to be a scretary in the Mizo Union Youth Wing

Pu R.Zoliana also used to take part in various scial organusations. Even while he was a student, he was General Secretary in Mizo Student Association and hi pionered for the improvement of literature. He was also amongst the leader of the Estern Tribal cultural Union and the Mizo Thalfavang Kut Cultural Games & Sports at Shillong.

He was a Secretary in the famine Relief Committee during Mautam. He also used to be a Secretary in Mizo Cultural Club at Shillong. Mizo Association and M.Z.P. In Bharat Scout also he was a Fresident and Vice President in the Mizo Entertaiment Board at Shillong. He was Editor in the Cultural Maga, ine published at Shillong He was on he used to write various articles and also broadcasted his speech in All India Radio. Pu R.Zoliana left his wife and four Children when he died on 20th May, 1991.

Whe the Mizo Union and Congress merged, he worked faithfully for Congress Party and he became a President at Aizawl District. When he became a member of this House, he was one of the most active membrs and he was also a resourceful and expert member in various House Committee in social organisation like Y.M.A. he used to take active psrt and he was know as a permanent Presidnet in Y.M.A. at their localties. It is a great loss for this Hose to lose such a devoted person. Today, I am glad I have a chance to make obituary reference for Pu R.Zoliana and also that wa can have time to show our respect in this House.

Pu Speaker, another obituary reference is for Pu Rajiv Gandhi, a former Prime Minister of India and President of the Congress, He was brutally killed on 21st May 1991, at 10:20 P.M. at Sriperumbuduk near Madras in Tamil Nadu. He was 49 years old when he was kill As we all know, he was the elder son of the former Prime Minister, Smt. Indiga Gandhi and a great parliamentarian fore2 Gandhi. Pu Rajiv Gandhi was born on 20th August 194 at Bombay during II World War and at the time of freedom movement for which Quit India movement was started. His grandfather was Pu Jawaharlal Nehru, the first Prime Minister of India, who was in Jail when Rajiv was born. Pu Nehru conveyed his greeting on Rajiv birth from Jail in which he concluded 'before hundred million and first Indian'. Rajiv Gandhi spent his early childhood under the governess teacher of darious. After that, he studied in Doon School at Dehradun which is considered as the best School till today. Then he studied at imperial College at London. After that he studied Mechanical Engineer at Trinity College: While he studied here, he met on Italian Girl maned Sonia Mino who was also a Student in this College. They got married on 25th February 1968.

As we all know, Rajiv and Sonia have one daughter and one son. After Rajiv finished a training for Mechanical Engineer, he took a training course of pilot. When he had liscence, he served as a pilot in Indian Air lines. He was very keen in his work, while preised for

maintaining discipline and for his Co-Operation with his fellow calluege. Even his superior recorded him as best in his yearly remarks. As he was a mechanical engineer, he was very much interested in Mechanical works.

When his brother Sanjya Gandhi died in a plane crash in 1981, Rajiv Gandhi was persuaded by his mather and others to join politics. Though he was not willing to join politics he agreed to join politics at the end. So in 1981 at the age of 36, he even Lok Sabha seat from Amethi constituency which was Sanjay's constituency. After a short time, he was appointed as the General Secretary of All India Congress Committee. He tried his best to know the whole of India while he was the General Secretary. He was fascinated by the people of India because of his hard work. Even when his mother Smt. Indra Gandhi, the then Prime Minister was killed on the 31st October 1984 he was chosen to be the Prime Minister.

In the 1984 General Election, the Indian National Congress even the election under his leadership so he was re-elected as a Prime Minister. The people of India had high hopes in him. During his 5 years term as Prime Minister, maximum Security had to be given to him were made time and again. But he tried his best to be in touch with the people. Security failed during a visit to Sri Lanka. He was inspecting a guard of homour when a naval nating serving his rifle at his head. And in 2nd October, 1986 a sniper concealed himself in the bushes at Rajghat and opened fire as Rajiv and the then President Zail Singh were leaving. Unperturbed, Rajiv Gandhi walked on as though nothing had happened.

His party did not even the 1939 General Election, the victory beyonded to V.P. Singh, but Rajiv got the largest number of seats in the Parliament. He gladly accepted to be a Leader of the Opposition and he promised to co-operate and remain useful opposition in the House.

Minority Government has been format twice within 18 months, the Congress as the main opposition in Parliament appeared more coherent and stable than the factious National front Government and its allies, so the National front Government collapsed shortly. As there were none to form a stable Government, the President ordered for fresh General Election in the month of May.

The people of India had high hopes in him and it seemed the Hon'ble Country was prepared to vote him as Prime Minister and he himself also hoped to win back the Prime Ministership he had lost in November 1989 election. He campainged freely, hudless of Security barriers of warnings. This time determined to carry his message directly to the people, he went on punishing road journeys visiting 3 or 4 states in a day. While he was campaingning like this, he was brutally killed by the suspected LTTE pear Madras.

His death is a great loss not only for India but also for the world. Many Foreign dignitaries came to attend his funeral.

Rajiv Gandhi was a very informal person, easy to mingle with, He went out of the way to befriend people, make them feel very close to him. He was so effectionate, smiling all the time. He never got anneyed with anybody. He was amongst the one to champion the minorities, poor and downtrodden people in India. Even we, the Mizos, loved him because we feel that he too card and loved us.

While India is marching towards 20th Century, Rajiv was concious that in the world of Technology, India needed a technology fix.

Rajiv's role in the conduct of foreign affairs deserves a high rating because there were several positive achievements to his credits. His neighbour heod policy had a district stamp. Rajiv Gandhi's personal charisma found full play on the international stage. In the non-Aligned Movement of the Commonwealth, at the U.N. other international forums, in the inter-action with the big powers and others who mattered becaused of their political and economic clout in dealings with immediate neighbours or others in the region, but he was able to carry the full weight of India's prestige, size and potential and produce a powerful impact.

During his Primem Ministership he felt that every problem faced by the country could be resolved by means of politics instead of military power, for this, he signed many accords with various groups of rebillions like in the state of Punjab, Assam and Mizoram. It appeared that the spate of troubles that had engulfed the nation had abated.

I would like to the mention that he championed to bering peace in Mizoram. Unlike other Prime Ministers he visited Mizoram with his family members and stayed four days with us visiting the remote parts of our state. He also made a special plan for us so that we can catch up our neighbouring states in the field of development. He also sent a group of seven Ministers to know our exact position and also to know how to take steps in development. But before he could fulfill his plans, he was defeated and while the people of India had high hopes in him and the whole country was prepared to vote him as Primem Minister and he himself also hoped to win back the Primem Ministership, he was brutally killed. His death was a great loss not only for India but also for the world. He was cremated with full state honour.

Today, Pu Speaker, I am glad we can have few minutes to make an obituary reference for these three persons. I would like to point out that from their charecters we have many things to learn and it is our duty to follow the examples they had left specially in regard to their sacrification for the country. Thank you.

: The Hon'ble House Leader had made

statements about the two Hon'ble members of this House and the Hon'ble former Primem of India. New I shall call upon Leader of the opposition group if he has anything to say about these three people.

.PU ZORAMTHANGA

: Thank you Pu Speaker, for giving me a time to say few words in the obituary for our collueges

and our leader who had passed away. I willoot mention their personalities and charecters because the Leader of the House had already pointed out about these. But I would like to say few things. First of all Pu Lalchhawna was an active member in our state legislative. He was a happy, informal person, easy to mingle with. He was praised by his friends. He went to Delhi to have medical check up but his illness could not be subdued, so he died at Behi while he was having medical check up. We have many things to learn from him like his deligency and seal and his ability to do things heartily. It is a great loss for Mizoram and for this House to lose such a person.

Secondly, I would like to say few things about Pu Zoliana, I know Pu Zoliana since my childhood because he was my teacher. He was very active in various social organisation. He also had immence contribution in our state legislature. He died after working very hard forever country. His untimely death is a great loss for all of us.

In regard to the death of Pu Rajin Gandhi, the former Primem Minister of India who was known by the world, his death is regretted by the whole nations, The comment I heard from his colleagues while he was a pilo+ he was very polite and he was highly praised by his colleagues and supervisors.

Even in the filed of politics, he was very popular in the world and led India many years. Besides, thism we, the people of Mizoram, greatly admired and loved him because he championed to bring peace in Mizoram. We are very grateful to him. Even in our future, he will be remembered as peace maker in Mizoram history.

These three were young when they died. We are at a loss for their untimely death while they were serving the country, They deserve to have obituary in this House and I am gald to you Pu Speaker for giving me time to make obituary reference on their behalf

· : Do you have anything to say Hon' member Pu Zosiama Pachuau.

PU ZOSIAMA PACHUAU : Pu Speaker, I would like to say only few words, from the reference made by our leaders, we learn

that Legislators and Parliamentarian died while they were young. What I would like to say is that bearing this in mind, we also must know that we can die at any age, There. fore we must serve with all our might while we have time.

Thank you.

SPEAKER

: Let us all rise up and stand 1 minute silently to mairn and to show our respect for Pu F.Lalchhawna, Pu R.Zoliana, the former members of this House and Pu Rajiv

Gandhi, the former Prime Minister of India, (They all stood for 1 minute). Please be seated.

Now we shall take up question and answer. Since our time is very limited, I would like to request all members to be precise in your point. We will stpp at 12:15 A.M. Now I shall call upon Pu B.Tevo to ask starred question No.1.

PU B.TEVO

: Pu Speaker, starred question No.1.

Will the Hon'ble Minister in-charge Revenue Department be pleased to state -

When will the 1st Batallion Assam Rifles and Mizoram Range Assam Rifles be shifted from the capital ?

PU ZALAWMA MINISTER

: Pu Speaker, answer to starred question No. 1.

Step had been taken to shift the 1st Batallion Assam Rifles and Mizoram Range Assam Rifles from the capital but the exact date can not be fixed.

PU T.C.PACHHUNGA

ວ ວ Supplementary question. Pu Speaker. In regard to shifting of the Assam Rifles, it seems that there is a proposal to shift the Assam Rifles to Zokhawsang. My question, therefore is, whether they will be shifted to Zokhawsang or completely shifted from Mizoram ?

PU ZALAWMA : Pu Speaker, from the very begi-MINISTER abing Zokhawsang site had been alloted to the Assam Rifles. but attempts had been made to shift them out of Mizoram till today. The Government sanctioned more than 92 lakhs rupees

for their compensation and now we are asking re-imbursement from Home Ministry in the Central. While the state Government is taking steps like that, they made a complaint that to only 100% of the area alloted to them is buildable area and that they can not effort to build their complex which will cost about 33th Spetember, 1991. The Assam Rifles the sent us a letter stating that they will leave Mizoram if they are not given another areas for their complex. After that we told the Assam Rifles that we can not understand their objections to the areas given to them like S.Hlimen, Thingdawl Melriat and Zokhawsang areas for their complex. Now we are negotiating them to leave Mizoram if they do not like to build at Zokhawsang area.

PU P.LALBIAKA

: Pu Speaker, another supplementary Is there any intention question. to shift Lunglei Assam Rifles from

Lunglawn ? Does the Government know the check gate made by the Assam Rifles at the old Pukpui Village which was occupied by the Brigade ? And how long will the Assam Rilfes occupy this place ?

PU P.C.ZORAMSANGLIANA : Another supplementary question. Pu Speaker, It was pointed out t that large amount of money had been spent by the Government for Zokhawsang areas. Is there any way to re-imburse the amount spent by the Government if the Assam Rifles are to move out from Mizoram ?

PU H.RAMMAWI

Pu Speaker, another supplementary 2 question. In 1988. 29th November some portion of Khatla Lane had been handed over to Mizoram Government. Does the Government protect those portions ?

SPEAKER

Now I shall call upon the Minister to answer.

Pu Speaker, in regard to the PU ZALAWMA 5 question asked by Pu H.Rammawi, MINISTER

the Government still protects the portion of Khatla Lane. And Regard to Pu P.C.Zoramsanglia-na's question, At the Assam Rilfes and Home Ministry asked the state Government to accept building materials and assets of the Assam Rifles for the amount we have spent. But the state Government is negotiating to re-imburse those amount in cash.

Coming to Pu P.Lalbiaka question, the Government does not intend to shift the Assam Rifles from Lunglawn, Regarding Pukpui Village which is being occupid by the Assam Rifles, the state Government does not know about this.

SPEAKER

: Now I shall call upon Pu H.Rammawi to ask question No. 2.

PU H.RAMMAWI

: Pu Speaker, starred question No. 2 is :-

Will the Hon'ble Minister in-charge District Council Affairs Department be pleased to state -

- (a) Who created the three Autonomous District Councils Mizoram ? Government of Mizoram or Government of India.
- (b) What is the basic rule for creation of these three District Councils ?

PU S.HIATO

: Pu Speaker, answer for starred question No. 2 is -

- (a) The three Autonomous District Councils in Mizoram are created by the Government of India according to the provision of the Consitution of India.
- (b) It is based on Sixth Schedule Para 2(1) according to the provision of the Constitution of India.

PJ H.RAMMAWI : Fu Speaker, supplementary question. The Hon'ble Minister said that the three Councils were created according to sixth Schedule of the constitution of India. I would like to request the Hon'ble Minister to note as to why the Mizoram Government said on 30th July that it is a self-style Lai District Council if it was created according to Sixth Schedule of the Constitution of India ?

The Mizoram Government made the Minister to sign suspension order of Lai District Council violating Article 163, Para 2 and 3 and Sixth Schedule para 20-BB without the premission of the Governor. My question is why did the Mizoram Government snatch the discretationary power of the Governor without his knowledge. I can give the copy to each member as well as for House property Pu Speaker, if you allow me to give.

The Hon'ble Minister also sgined another order at Lawngtlai. In that order it is written-"Because the Mizoram Government extends suspension of, Lai District Council from May 7th 91. But till today there is no Government notification to extend suspension of Lai District Council. I would like to know from where minister quoted that order ?

And lastly, Pu Speaker, according to Transaction of Business Rules para 11, there is a place for signature for the one who issue any Government order including Chief Secretary and Under Secretary, Then why did the Minister sign that order ? were there no officials to sign ?

SPEAKER

: Now I shall call upon the Minister to answer.

PU S.HIATO MINISTER

Pu Speaker, in regard to the first supplementary question. There was printing mistake in the telegram. Instead of Self style Dis-

trict Council it should be written as self style Executive Committee. The correction had also been sent. And I would like to request all members by using parliamentary language.

In regard to the other supplementary questions I would rather not answer taken them as the cases are being taken up by High Court, Gauhati Bench.

PU H.RAMMAWI

Pu Speaker, the Minister said they are the cases of High Court Bench, but why does the Government of Mizoram detain the fund alloted for Lai District Council which amounts to more than 3 crore rupees ?

SPEAKER

: I shall call upon Pu Zosiama Pachuau to ask starred question No. 3.

PU ZOSIAMA PACHUAU : Pu Speaker, starred question No. 3 is -

Will the Hon'ble Minister in-charge Education and Human Resources Department be pleased to state -

- (a) Steps taken for improvement of qualities of School Text Books ?
- (b) Steps taken for reduction of the prices of School Text Books ?

SPESKER

: Now I shall call upon Dr H.Thansanga, Minister in-charge to answer.

Dr H.THANSANGA MINISTER : Pu Speaker, answer for starred question No. 3 is -

The following steps have been taken -

- (a) (i) Printing mistakes and Minor errors have been corrected.
- (ii)Some slight modifications have been made in some of the Text Books to improve their qualities.
- (iii)English Reader for class VIII has been thoroughly revised.
 - (b) (i) Policy, Norms and formula used by Central Board of secondary Education, New Delhi have been made the basis for pricing.
 - (ii)Prices were fixed by negotiating with the Publishers/Printers at the lowest possible rates.

PU ZOSIAMA PACHUAU

: Pu Speaker, supplementary question. In class VIII Social Studies page

No. 14, it is written - 'Namibia wich gains indenpendent in 1989 is the last to be freed from Foreign Yoke'. And in page No. 22, about Namibia is written as - 'Most of the Countries are now all indenpendent the last being Namibia which became free in 1990'. I do not understand whether there are two Namibias. It is also written about Namibia as - 'Thus we find the highest peak of the continent in Kenya. It is 190,340 Mts high. The next highest peak is Mt. Kenya 170,058 Mts'. This mean that they are highest than Mt Everest, But in page No 31 it is written -'Mt Kynya 5,197 Mts is the second highest peak in Africa'.

The objectives of teaching social studies to students for citizenship training and that they will be well informed students. But if we look at the social studies Text Book for Class VIII, there are many errors like the ones I have pointed out, Till today, no correction had been sent to the Schools. This Bokk had been published by Board of Education in 1991 and it was printed at the Hon'ble Minister's Press and it costs Rs. 15/-

Besides this, if we look at English Reader, Pu Speaker, in chapter 6 Lesson 8, the story of William Tell has been written. After writting about one page

William's wife was saying 'Never whether I go I take the cross go with me'. Here the husband was supposed to hold the corss but here his wife hold the cross, In the next line, the wife's speech had been written as - ' He had doth most who do what is right'. I think it should be written as -'He had most those who do what is right'.

In Lesson 15, about the good Samaritan spoken by Jesus was written. In this passage, it seems the speeches of Jesus are intended to be put inside inverted commas. It is written - 'A certain man went down to Jerusalem and Jeriko and felt among thieves - and after this the writers puts coma wherever he wants. Then an inverted 'passed by on the other side' when will these mistakes be corrected ?

Besides these, in rewrite the following sentences as directed, it is written in No 4 as follows - Near the pot or the pit there was foot of the say, here there were no foot hole. I think there is none who can correct this even in London.

All these show how bad is the English Text Book. While the print itself is good, the wordings and languages are hopelss, They are not worth for English Text Book. How will the Hon'ble Minister answer this ?

PU H.RAMMAWI

: Another supplementary question. Pu Speaker, I had already told the Hon'ble Minister in his office Chamber that in the text book of Class II, Nazareth had been

written as the birth place of Jesus. Had that been corrected?

Dr H.THANSANGA : Pu Speaker, the Hontble Members had pointed out only few among MINISTER

many mistakes. Now these Prin-ting mistakes and other errors are being corrected after having thorough recision. Even the author can make mis-takes in his manuscripts. The manuscripts are checked by the Board and only after that they are sent to Printers. After the Printers finish Printing, the copy had been sent to the Board to check again and only after the Board thoroughly checked them. The Printers start Printing for the actual Text Book. Even after taking such precautionary measures, there are some mistakes. Now the workshop is checking again and make necessary corrections. All will be corrected by the next year.

Text Books are made into three phases. In the first phase Books for Class I, II, V, and VIII are incheded. Now the second phase is being done which include Text Books for III, VI and IX and in the third phase books for class IV, VII and X will be included.

Ministers and Ministers in India should not call those who returned from Underground according to peace accord as surrender. As I feel this is National importance, I would like to pointed out today. The Hon'ble Chief Minister too, worked very hard to bring peace while we had peace talk. But to day we cannot accept in his speech that he said we surrender. Let us remember 30th June 1986 on which memorandum of settlement of signed. In that memorandum Home Secretary, Government of India, Secretary, Government of Mizoram and Pu Laldenga on behalf of Mizo National Front signed their names. Though we all have seen the document, I would like to give Memorandum of settlement as House property.

Today, I am also requesting Government of India to take steps in order to fulfill the Memorandum of settlement and in this regard even Government of Mizoram will have steps to be taken. I think Hon'ble Chief Minister and other Minister will know how to take steps in this regard. I am sure the Hon'ble Chief Minister did not mean when he said surrender. PU C.L.RUALA : Pu Speaker, according to our Rule MINISTER : The Mizoram Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly Rule No. 60, I told you that I would

like to say something about the explosion of bomb in a bus at Vairengte and I am glad you give me this opportunity.

In our list of Business, it is written 27 but it sould be 28 The MST Bus No.01/0771 driver on 28th September was Pu Chawngkhuma. The bus was coming from Silchar to Aizawl and there were 33 passengers including the driver and conductor Sapbela. Before the bus reached Vairengte Police Check Gate by 200 Metres, a bomb exploded inside the bus at around 8:20 A.M. Three persons- Chatuanhmahruaia, New Saiha, Zabuangpuii of College Veng and B.K. Paul under PWD died at the spot. Later, Honorary head constable S.P. Nath of Vairengte Police Station also died while he was taken to Vairengte Subsidiary Health Centre. Six of the influred persons were admitted to Hospital, three of them were admitted to Silchar Medical College Hospital, as one was sent to Masimpur Military Hospital and two of them were admitted to Aizawl Civil Hospital. Other passengers were discharged after they were given first-aid treatment at Vairengte Subsidiary Health Centre.

After post mortem had been done, the dead bodies were sent to their respective places. An enquiry had been taken at the spot where a bomb had been exploded. From the enquiry report at seat Nos 10 and 11 of this bus, a powerful time bomb had been deposited in a luggage truck and it is suspected that the bomb was controlled by alarm table clock. The bomb hit wall of the bus where it exploded and the passengers who sat nearby it. Bus engine was not damaged but all glasses of the bus were broken among the 33 passengers only two of them i.e. the driver and one of the passengers were not injured. In this incident, a criminal case had been registered according to Vairengte Police Station Case No. 53/91 Dated 28.9.91 under Section 3 02/307/326/435/120 B.I.P.C. R/W Section 111 (2) of Terrorists and Destructive Prevention Acts, 1987 R/W Sec 111 of Explosion Substantive Act. According to the-report of the investigation a time bomb was placed in the Bus before the bus left Silchar.

The spot where a bomb exploded, was visited by a Minister of State Transport Department, Police Department and some Senior Officers from administration. A proper plan had been made so that no passengers of this bus will not loose their belongings because of this unwanted incident. Even Superintendant of Cachar District was requested to give Police to guard Mizoram State Transport Bus Station at Silchar.

The Mizoram Government is planning to give Ex-gratia fund of Rs. 20,000/- to families of the dead and Rs. 5,000/- each to those who were seriously injured. That's all about my statement. Thank you. SPEAKER

: The statement given by the Hon'ble Minister was about the actual incident. It was written even in local

news papers but by making a statement, we can show to the people of Mizoram that this House does not neglect such incidents. Among the ones who had spot visit, I would like to request the Hon'ble Minister to note that Speaker of this House was also there.
