**Pu R.LALZIRLIANA, MINISTER :** Pu Speaker, thil hi kan tum phawt loh chuan, tumna a awm loh chuan engmah a tih theih lova; chuvangin kan ti thei ang em? Kan thei lovang a! tih nghal ringawt ai chuan khauh taka tum kha sorkar duhdan a ni a. Tin, chutiang piah lamah chuan nichina ka sawi tawh ang khan hei hian eizawnna tam tak Aizawl khawpui daifem deuh leh hmun...

**Pu LALRUATKIMA :** Pu Speaker, khawngaihin kan Rule 60 chapter 12-naah hian statement made by a Minister tih ah hian nikhat kalta khan a copy hi Speaker hnenah pek tur a ni tih a ni a, pek a ni em, kan Minister zahawm tak ten statement an siam kha? Kan bill kal lai a ni a, Rules-ah hian a awm lo a ni. Kan Rules ah hian ni khat advance in Speaker hnenah hian a dil tur a ni tih a nih laiin, chuvangin hei hi chu i discretionary a ni maithei, amaherawhchu kan Rules angin i kal ang u, kan hun a hek lutuk a.

**S P E A K E R :** Ngawi rawh, road fund chanchin kan ti a, chuvang chuan maw a inkaihhnawih a, a rawn sawi tel a nih kha.

**Pu LALRUATKIMA :** Rules kan nei a, hetah hian Rules of Procedure and Conduct of Business-ah hian statement a siam dawn reng rengin Speaker hnenah nikhat a ral hmain a pe ngei ngei tur a ni tih a ni. Chuvang chuan statement kha chu hun dangah naktukah pawh a ti thei lawm ni ka ti a ni.

**Pu R. LALZIRLIANA, MINISTER :** Pu Speaker, statement ka pe lova, for information atan sorkar-in a hmalak dan tur kha helai member zahawm takte hma ah hian ka'n puang chhuak a ni a. Tin, helaiah hian House Leader ka ni a, chuvangin i phalna in hei hi ka sawi a ni tih kha ka'n sawi duh a.

**Pu R. LALZIRLIANA, MINISTER** : Kan member zahawm tak interest hi a ropui thin khawpin ka hria a, ram a ngaihtuah a. sawlai pawh saw ama min sihhmuhnnaa kan lei ania. Congress sorkar ah hian hmanah kan hotu a ni tawh thin a, tunah pawh hian kan tan hian thil tha kan tih hi chu min duh pui a ni, a chungah hian kan lawm hle a ni.

Tunah hian kan thiat tan tawh a, a design siam tur pawh kha an tender a, empanelment tih vel ho leh company ho kha an in el a, khata nalh ber leh tha ber kha lawmman pawh nuai 3 lai an siam a, chutiang chu an dawng nghe nghe a ni. Hei Pu Speaker, khalai kha a ti tu deuh bik a awm a, i remtihna in khawngaihtakin han chhang lawk sela. (Pu Lalruatkima : Pu Speaker, kha kha chu kan Dan hi zah ang u, kan inkhualtelem chet deuh hlekin ka hria, kan fiamthu mah mah, a hlimawm a. A chhan chu tah hian Minister hian statement a siam dawnin i phalna leh i remtihna in chapter 12-na statement made by a Minister tih hi ka'n chhiar ang e Pu Speaker. Vawiinah hian Speaker zahawm tak i ni a, i rorelna hnuiah Dan-in thu a pek theih ang chin chin hmang turin khalaiah khan i thu a, kan House Leader-in mipuiten heti tak maia Aizawl traffic jam kan buaipui leh kan tawrhna rei lutuk tur hi statement kan siam ang e a ti lova, information kan pe ang e, sorkarin hetiang hi kan tum a ni e tih a sawi a ni a. Statement pe tur chuan a department chungchangah engemaw thil thleng awm se statement a siam te, white paper a pekchhuah te a ngai ang a, kan Danin chutiang chu a provide vek a. Vawiinah hian mipui tan a lawmawm dawn em mai a, enghawlina hun he traffic jam rei tak kan tawrhna, kan sal tanna atanga chhuah theihna khawp hial ni-a kan ngaih a rawn sawi avang hian kei chu kan lawm tlang viau tura ka ngaih laiin chutiang lo deuh hlek chuan kan dawngsawng lek lek niin ka hria a. **Pu R. LALZIRLIANA, MINISTER :** Pu Speaker, motor kha chu tam tak dah theih tura siam a ni a, a zat chu ka department a nih chiah loh avangin ka chhang mai thei lo che a, a pawi khawp mai. Party hi lungrual a tha khawp mai a, keini hi kan senior te hi kan zah khawp mai a, kei hi engmah ni lo ber, thiam nei lo ber ka ni a; amaherawhchu, kan member te hian min zah der em em a ni. Thu ka sawi leh engemaw ka tih hian min dal ngai lova, zawhna te ka siamin min chhang tur te chhan an remti lo ngai lova, chuvangin party hi inlungual a pawimawh a. Chuvangin aia upa zahna te, party-a inlungualna te hi member te hian mahni party theuhah hian hrechhuak ila a tha in ka hria.

**S P E A K E R :** A dul ai chuan tiang hi han inhnial buai deuh chang awm te pawh hi a tinuamtu ah ngai ila. He House ti ropuitu a ni ti zawng khan la thei ila a tha ang e.

Tunah chuan kan Minister zahawm takin “The Mizoram Road Fund (Amendment) Bill, 2016” a rawn putluh chu he House in pass pui a rawn dil a, pass remti zawng ‘Remti’ tirawh ule. (MEMBERS: Remti) Remti lo kan awm em? Aw, kan inlungual hle.
