Pu JOHN ROTLUANGLIANA, MINISTER : Pu Speaker, "The Mizoram Motor Vehicles Taxation (Amendment) Bill, 2016 chu he House zahawm takah hian ka rawn introduce e.

Pu Speaker, he Bill kan rawn introduce nachhan hi a hmain Ordinance kan lo siam tawh a, chu Ordinance chu thla ruk chhung chauh a nung a. Chumi rual chuan House-ah thla ruk hma-in Bill ah putluh tur a nih angin kan rawn pulut a ni.

Tin, Pu Speaker, hemi "The Mizoram Vehicles Taxation (Amendment) Bill, 2015 hi July, 2015 ah khan he House zahawm takah hian putluh a lo ni tawh a. Chutah chuan lungrual taka passed a ni a. Chumi ang chuan "The Mizoram Motor Vehicles Taxation (Amendment) Act, 2015 chu Official Gazette ah chhuahin February 8, 2016 ah khan hman tan a ni tawh a ni. Amaherawhchu, hetia kan han hman chhoh hian he "The Mizoram Motor Vehicles Taxation (Amendment) Bill ah hian kum 15 chhung commercial vehicle ten VAT pek hmaa 6% atangin tax pek tur tih a ni ta a.

Chu chu Lifetime Tax kan tih kha a ni. Chumi pe tur commercial vehicle te chu three wheeler kan tih, auto rickshaw te, taxi kan tihte leh maxi cab kan tih ho te hi an ni a. Ama'rawhchu, hetah hian vawikhata pek tlaka kum 15 atana pek kha Commercial Vehicle Joint Action Committee te hian, ‘ hei hi zawng vawi leh khata pek hi kan tlin lo ve, installment-a pek theih dan turin ruahmanna min siamsak rawh u,’ tiin an rawn dil a. Tin, anmahni pawhin rawtna an rawn siam ta a. Chutiang rawtna an siam zulzui chuan hetah hian installment thuma pek theih turin ruahmanna siam a lo ni ta a. Pu K. SANGTHUAMA : Pu Speaker, hei hi tlem-a-zawng zawhna mai bakah han sawihona awm se a tha lo maw, hun kan ngah tho bawk a? Sawiho lo chuan han ti dawn ila minute sawmhnih khatah kan tin mai dawn a ni. Chuvangin tlem-a-zawng sawihona a duh tan hawng ta la Pu Speaker, a tha lo maw tih kha ka'n sawi hmasa duh a ni.

Pu K. SANGTHUAMA : Pu Speaker, ka lawm e. Helaiah hian kan tax khawn dan hrim hrim hi central atanga kum 15 an rawn tih hi Pu Speaker, kei chu dik lova mi pawisa chhuhsakna niin ka ngai a. Motor kan han lei a, kum 15 nei hi chu ban phar teh u ti ila, vawiinh hian in awm vak ka ring lo. Kum 15 mahni motor tha taka hmang an awm lovang a, tin, tlan tir thei kan awm bawkin ka ring lova. 1984 vela Maruti car thar lo chhuak hmasa ber kha ka lei a, chu erawh chu Pu Speaker, ka hrallh ve leh hnu khan kum 20 dawn khawlaiah a tlan niin ka hria a, thingtlangah ka hrallh a.

Pu Speaker, han sawi ta zel ila, motor kan intlan chhawk te pawh hi taxi chauh hi ti lovin, kan ti rau rau a nih chuan a zavai hian sorkar motor leh Chief Minister thlengin, MLA thlengin, kan zavaia motor hi intlan chhawk tir ta ila, thla khat chhung emaw, kar khat chhunga vawikhat din, thla khat chhunga vawi hniih khat din ringawt chu, kan din ni chuan Pu Speaker, taxi te kan hire ve mai ang chu, harsatna a awm lo hrim hrim hetiangte pawh hi.

Sumdawng motor chauha kan tih tir chuan, a dik chiahin mi an lungawilo thin a, buaina a awm a, a lo kal a, a dik lova. Chuvangin keimahni pawh hi kan in surrender a ngai ve a ni, hetiang chungchangah hi chuan. Hman atangin kei chu ka rilru tak tak inTaxi ngawr ngawr va mawhchhiat te hi dik ka ti thei ngai lova. Chuvangin, miin an eizawnna, tha taka an eizawn ve na, mi rethei zawk in an eizawnna, thla khata vawi 2/3, vawi 4/5 lai din tir a, duh duha nuam tawl thei hovina engatinge ni hniih khat chauh pawh kan tih ngam loh?

Chuvangin, hei hi kan sorkar hian ngun takin ngaihtuah ula, in ti rau rau, kan ti rau rau dawn a nih chuan a zavai hian in-tlan chhawk dan te ngaihtuah ta ila, chu chu a that ka ring Pu Speaker. Kha kha a kaihhnawih vek tho va, chuvangin niminah kan House Leader zahawm tak pawhin Pu Speaker, i phalna dil lem lo khan a rawn sawi tawp a, kei chu i phalna ka dil e, tunah hian. Chuvangin hei hi a inkaihhnawih vek a, vawiina House-a kan sawi loh

chuan khawlaia sawi mai mai kha chu thil awmzia nei tehchiam a ni lova. Chuvangin, motor intlan chhawk chungchangah pawh hian ngaihtuahna thar kan sorkar hian han hmang leh thei sela a that ka'n ring a, vawiinah hian ka'n sawi chhuak veleh a ni e.

Private motor zawng zawng, heng hian kum 15 kan la pe dawn a ni a, kum 15 thleng kha kan hmang dawn lem lo a ni, hman loh pek ringawt mai kha chu mipui vantlang hian association kan awm ve lova, complaint ngaihna vak a awm lova, kan sawi a kan sawi lungawi ve leh mai thin a. Chuvangin, vantlang association te hi han siam ve zawk tur emaw chu aw tih te pawh a awm rum rum thei ang a. Chuvangin, sawiselna a awm lo em alawm an ti a, Association awm lo hi chu han sawisel a, sorkar han nawr vak hi a tih hleihtheih lova, mimal hi chuan an sawisel tho mai, a dik chiah chuan Pu Speaker. Kum 15 hi chu a lutuk deuh lawm maw ni le, chumi a nih loh pawhin 15 an tih rau rau pawhin hetianga kum 5-a pek a, kum 10- ah pek leh a, kum nga dan zela pek ve te hi chu hetah hi chuan tlahniam ve thei ila a tha ang a, an ti deuh a ni.

Chu chu Pu Speaker, vawiinah hian kan House zahawm tak hian hria ila, a then commercial vehicle te chu han thik chi ni lovah in ngai a ni maithei a, mahse motor theuh theuh a ni a, motor theuh theuh a nih kha chuan in hrut rual ta ila, kum nga-ah public pawh hi pek tir ni sela, kum nga dangah a la that chuan an pe leh mai ang a, kum sawm, kum sawm panga a lo nih chuan a la that chuan an pe leh mai ang a. Chutiang chuan hei hi nakinah a la tih danglam theih chuan, vawiinah kan ti danglam thei kherin ka ring chuang lova, ngaihtuahna thar Pu Speaker, sorkar hian han nei leh ula chuan mipui kan lungrual zawkin ka'n ring deuh hlek a. Vawiinah hian khang tawite kha han sawi ka'n duh ve a ni e, ka lawm e.

Dr. K. BEICHHUA : “The Mizoram Motor Vehicles Taxation (Amendment) Bill, 2016” kan Minister zahawm takin he House zahawm taka ngaihtuah ho tura a rawn chhawpchuah hi a hmasa in lawmawm ka ti a.

He kan Bill amend tur ka ngaihtuah hian Pu Speaker, Mizoram Motor Vehicles Taxation (Amendment) Bill, 2016 hi nikum 2015 a kan passed pawh khan kei chuan tha ka ti lova, vawiin thleng hian kei chuan tha ka ti lova, tha ka tih theih hi ka ring lo a ni.

Chutihlai chuan Pu Speaker, vawiinah hian he Bill hi kan Minister zahawm takin amend a tul nachhan te pawh a rawn sawi tawh a. Amendment a

tulna a rawn sawiah khan tiang hian ngaihtuah ta ila, pakhatna-ah chuan non-transport vehicle, private vehicle neitu ten sorkar hnena ngenna kan siam loh emaw, rawtna kan siam loh vanga life time tax min pek tir reng ringawt kha thil dik a ni dawn em ni tih min ngaihtuah tir a. Association angin kan ding ve bawk si lova, mahni mimal angin han sawi ta ila, kan phun kan phun a, lungawilo chungin tax kan pe leh ringawt thin a. Chutihlai chuan commercial passenger vehicles ten Joint Association ang ten sorkar hnena ngenna, lungawi lohna te pawh an thlen tih kan hria a. Khang lungawilohna tlentu te rawtna ang zulzui khan vawiinah hian he tax hi, he Bill hi amend a ni tih te pawh kan hria a ni.

Chutihlai chuan Pu Speaker, kan ram vehicle atana kum 15 life time tax kan han tih hi kan kalkawng nena han ngaihtuah chuan Mizorama thil inhme lo zinga inhme lo pawl tak niin ka hria. He House-a kan member zahawm tak tak te hian kan motor hi kum 15 a tlan lo tih hi a hrechiang ber bertu kan nih ka ring. Chuvangin, hei hi tuna amendment rawn siamah phei chuan one time tax tiin rawn siam a ni a, a hming chu life time tax tih ai chuan one time tax tih hi chu a mawi deuh hlekin ka hria a ni. A tir atang khan life time ti lovin, one time tax te kha tih ni ta sel a chuan mipuiin kan rilrua kan perceive dan pawh hi kan perceive thiam deuh zawkin ka ring a, mahse one time tax leh life time tax kha danglamna a awm hran lo a ni tih a chiang a.

Ordinance hi ni 21.7.2016-a gazette ania, ni 20.1.2017 thleng a daih dawn a ni. Chutihlaiin vawiina he session emergency anga kan koh chhan zing ami a nih tel chuan a vanduaithlak ka ti a, vawikhat session neih hi sum nei lo sorkar tan chuan thil hautak deuh a ni. Chuvangin, hetianga emergency-a in koh hi a tul ber em tih te pawh min ngaihtuah tir a.

Tin, Pu Speaker, Amendment of Schedule I Principle Act in Group II, the description of motor vehicles, after the words motor vehicle and before the word “operating”. Operating tih lai hi Principle Act-ah a awm lo, ka hmu lo, Kan Minister zahawm takin min hrilhfiah se a lawmawm hle ang. Amendment of section 4(a) tih hi Principle Act-ah a awm lo. New insertion turin a theih dawn em ni? Schedule 111 hi a awm lo bawk. Heng zawng zawng hi Pu Speaker, Minister zahawm tak Bill amend tura rawn chhawp chhuaku hian chiang takin House-ah hian min hrilhfiah se a lawmawm hle ang. Chutiang chuan he amendment vawiina kan rawn siamah hian mipui thliar hranna a awm deuh hlekin ka hria a. Private-a motor nei tam takte hi chu loan nena nei lo chung chunga lei te kan ni a, life time tax kha one time tax anga pek tir bik tur kan ni lem em ni tih kha Pu Speaker, he House zahawm takah hian ka rawn sawi chhuak duh a. A theih chuan hei hi kan Minister zahawm tak hian ti danglam se, hrutrual vek se tih a pawimawh hlein ka hria. Pu Speaker, ka lawm e.

Er. LALRINAWMA : Pu Speaker, ka lawm e, session hmasaa kan han pass pawh khan 6% chu ‘ a to dawn mang e’ kan ti kan ti a, a to ta mai reng a. A lehlamah Mizo mipuite hi thil kan chiang lo nge ni, ka ngaihdan tak chuan khang kha pawn lama rawn rik deuh luih luih tlak niin ka hria a, mahse kan ngawi tlangin keini lam pawh khan kan pass ta dial kha a ni mai a. Kan han hmang a, a lo buaithlak viau mai a. Engpawhnise vawiinah amendment te pawh a rawn kal a, mipuite tan remchan zawkna turin, a lawmawm khawpin ka hria a. Amaherawhchu, tah hian thil pakhat ka’n sawi ve duh lai chu hetilaia kan amendment bill phek 4-na scheduled 2-a one time tax ah khan ‘At the time of registration of new vehicles’ tih a one time tax ah khan 6% kha kum 15 ah kan han ti phawt ta a. Two time tax-ah khan 4.2% kum 10 atan kan han ti leh ta phawt a, a piah leh three time-tax ah khan 2.2% kum 5 atan kan ti ta a. Kha kha han then hrang chho ta thliah thliah ila two time-tax ah kha chuan kum 5-ah khan 2.1% vel pe ang kan lo ni tihna a ni ta a. Tichuan 3 a kan puntir chuan za zela cheng 6 aia tam, za zela 6.3% kum 15 atan kan pe tihna ang a lo ni ta a ni. Tichuan three time tax ah hian 6.6%, kum 15 atan pe ang kan lo ni ve leh ta a. Tichuan kum 15 pe tla chu 6% ang an lo ni ta a.
