Chuvangin, heng Dan hi kan hun hmasa lam pawh khan ka lo rawt ve tawh thin a, kan Chief Minister zahawm tak hnenah te, he Dan hi Assembly ah ti ve rawih mai ila tiin.

Ka han sawi tum tak chu, NDPS Act hi miin rawn zir chiang ta se, i veilam ami te pawh khan chu chu rawn ti se, mahse'ng keini hian kan workforce, kan hnathawktute inchhanna tur leh anmahni tana tlawhchhan tur kan lo siam ve phawt hi a ngai a ni ti a (ngaihtuahna fingo te mah ni se), lo seng ve thin ka nihna laiah khan, hei hi a lo chhuak ta hi lawmawm ka ti a. A ngaihna hre zawk leh tha zawkin thil an rawn ruahman a. A chhung thu thui tak ka han en a, lunglen thlak ka tih avangin ka rawn thlur lo ang a.

Kan Minister hian a move thiam a, a move tha a, engemaw sawi leh belh tur chu a awm ang. Amaherawhchu hei hi hna hmanhmawh a ni tlat a ni. Kan Police, kan Excise, NGO te leh thawktu hrang hrang hian tlawhchhan an neih a ngai a, chu chu kan siam a ngai a ni. NDPS Act in a rawn sawi lem loh, khang hrang hrangte pawh kha kan belh luh zel chuan, chu chu keimahni siam a kha a ni dawn a, chungte chuan a puih theih ka ring a. 'I thu in thiam i chang a, i thu vekin thiamloh i chang ang' tih angin, hei hi tanchhan min chhiar thlak khum leh thinna a nih avangin tuna 'The Mizoram Drug (Controlled Substances) Bill, 2016 a lo chhuak hi lawmawm ka ti a. A buatsaihtute zawng zawng an hah hle in ka ring a, kan Minister pawh ka fak a, a nihna anga pass pui turin ka support a. Ahmasa bera din ka chuh a, min pek avangin ka lawm e, Pu Deputy Speaker.

DEPUTY SPEAKER : A lawmawm e. Dr. K. Beichhua i lo sawm ang.

Dr. K. BEICHHUA : Pu Deputy Speaker, ka lawm e. Mizorama ruihhlo hman suauna hluar ta em em hi kan vei tlangin ka hria a. Kan thalai duhawm tak tak ten hun lovah mual min lian san a, chhungkaw tam takin kan tuar a, kan rum a ni. Chutihlaiin, kan thalai tam tak rehabilitate ngaite pawh an la awm mek bawk a. Chutiang a nih laiin, he Bill vawiina rawn lut hi tha ka ti a, ropui ka ti a. A puluttu kan Minister zahawm tak hnenah lawmthu ka sawi duh bawk a.

He Bill hi a tha a, chutilai chuan tihdik famkim te pawh hi a lo har a, chuvang chuan kan sawiho ang a, i vei/i ding tih pawh awm lem lovin, diklo lai anga kan hriatte kha chu he House-ah hian kan zavaia hman tur leh kan ram tan a nih avangin siamthat tul ngai angte kha chu siamtha mai ila, pawmpui tul lai pawmpui mai ila tih te rilru-ah ka lo nei a. Siamthat ngai leh ka hriatthiam loh lai tlem ka han sawi ve ang a, a changtu Minister pawhin ngun takin min lo chhinchhiah sak se, ka hriatthiam loh laite pawh min hrilhfiah se tih ka ngen a.

Chapter 1, Section 2, sub-clause 2-ah khan, ‘addict means a person who has dependence in any drug having abuse potential and consumes the said drug’ a ti a. Helaia, ‘who has dependence’ a tih hi ka hriat danah chuan a sap tawng hi a dik lo tlat. Chuvangin ‘dependent on’ tiin thlak ta ila, chu chu english dik zawk niin ka hria a. ‘Dependent on’ tih kha chuan a adjective a, ‘dependant’ kan tih chuan noun a hman tur ni ta se, ‘ent’ khan thlak ta ila tih rawtna ka siam a, pakhatna ah.

Pahnihna ah chuan, Chapter 2, Section 3, sub-section a awm thla zel a, 2(a) kha, ‘co-ordination of action by various officers, departments and other authorities’ a tih lai tak kha, ‘various officers’ han tih tawp kha a dik ber em tih rilru ah ka nei a. ‘Concern Officers’ ti tein emaw thlak ta ila a dik zawk lovang maw ka ti a. Ka ngaihnan hi a dik lo a nih chuan min lo hrilhfiyah mai turah ka ngai a.

Chapter 2 tho, Section 3, sub-section 6 kha, ‘with a view to adopt uniformity kha han chhiar thla zel ta ila, a tawpahn ‘... place of drawal of sample etc’ a ti a ni. ‘Etc’ khan Dan tha tak siam nan chuan a ti zahawmlo deuhin ka hria a, ‘etc’ kan tih khan thil dang tam tak a kaw thei a ni. Damdawi tam tak hi a nih dan tur aia ei tam chuan substance abuse theih thil te a nih deuh vek avangin he lai ‘etc.’ hi paih theih ni se tha in ka hria a.

Chumi bakah chuan Chapter 3, Section 4 (b), ‘State Fund for Control of Drug Abuse’ tih kha headline a ni ta a, ‘the sale proceeds of any drugs seized or property forfeited’ tih khan eng nge ni a kawh chiah tih kha, heng thil damdawi leh ruihtheih thil kan man ho te kha a nihna ang ang leh a man ngai ngai ang khan kan zuar leh dawn, a ngai ang ang khan em ni kan zawrh leh dawn tih te kha min hrilhfiyah theih chuan ka hre duh baw k a.

A tawpna berah chuan Chapter-4, Section-23 kha han chhiar thla leh ta ila. Para chung tawp lamah khan ‘which has reason to believe’ a tih ah khan ‘reason’ tih a nih ka ring a. Dan kan siam tawh chuan hetiang anga kan pawm tawp mai chuan spelling mistake leh patent error te pawh kha kan pass hnan palh ang tih te pawh kha ka’n hlauthawng deuh a, ‘which has reason to believe’ tih tur ni awm tak a ni a. Khang lai te te siamthat a tul lai te kha siam tha mai ila, he House zahawm tak hian. Tin, in hrilhfiyah a tul lai te kha in hrilhfiyah a pass mai tur chi ah ka ngai deuh a, khang karawn sawi ang te te chi te kha min lo chhinchhiah sak ta se, paih leh siam that tul lai kha chu siam tha nghal mai ila, tichuan pass mai kha tha ka ti mai e. Pu Deputy Speaker, ka lawm e.

DEPUTY SPEAKER : A lawmawm e. Dr. Ngurdingliana.

Dr. NGURDINGLIANA : Pu Deputy Speaker, ka lawm e. He Bill “The Mizoram Drug (Controlled Substances) Bill, 2016” kan Minister zahawm takin arawn putluh hi a hmaa sawi tawh ang khan kum nga kal ta vel khan nei tawh ila chu wawinahn kan bula dam tura kan duh tak tak te hi an dam ka ring a. Chuvangin he Bill tha tak mai kan Minister-in arawn putluh hi waw sawmhnih vel ka chhiar chhuak tawh a, keima experience atangarawn sawi ka tum a.

Kum sawm tal tawp JAC-ah te, Village Council Member ni a kan veng chhunga kan phak ang tawka rawng kan lo bawl tawhnaah veng chhung thenfai kawngah

kan hnungkhirh thin na zawng zawng veng kilkhawr, kan vengchhunga in kilkhawr ber bedroom-a kan kaltlang theihlohna zawng zawngte mitthla a han chhui let pawh hian he Dan hian minrawn um char char mai hi khatih hunlai khan lo nei ve ila chu aw tih ka rilruah arawn lut a. Sawisel tur hi a awm lova, a Dan siamtuten in lo zirchiang tih hi a langchiang hle mai a. Chuvangin a section wise pawhin kal ngai ka ti lo, a inthuan tha em em a, a in ban let tha a, a tawpah delegation of powers kha Assembly, rorelna sang berah arawn pulut leh bawksi a. A kar laklawh inrelbawl danah State funding, engtingge funding kan hmuh ang? Tin, a officer te ngei pawh hrem theih a ni ringawt mai te, a controlled substance quality leh quantity te pawh in han thliar a. Khang zawng zawngah khan in ngaihtuahna in seng hle a ni, a lawmawm ka ti.

Kan Minister zahawm tak hi a department chanah sorkar atangin MLA-te tu tu emaw order a hmuh hi thil buaitlak deuh mai hi awlsam deuh mai hian arawn tichhuak thiam a. NDPS Act, a taka hman dawn chuan a khirh lutuk a ni, nichina kan ngaihthlak ang khan. Mahse Mizo society, Mizo context ang hian mawlmang deuh, khuap em em maia arawn phawrhchhuak thei hi a lawmawm ka ti a. Chuvangin han sawi vak ai chuan a taka khawtlang thenfaina kawnga hma latute zinga kan lo tel tawhna ah tunah chuan full power-in min thuam dawn a ni. Veng hrang hrangah, khaw hrang hrangah tlawmngai pawl a ni emaw, NGO a ni emaw, JAC, VDP-te an ni emaw heng Bill kan pass hnu hi chuan ngaihngam takin kan mi man te darkar hnih khatah anrawn chhuak, vengkawn ah kan la duty, a then chimawm deuh pheichuan minrawn nuihsawh. Khatiang ang te kha kut han thlak ngawt dawn ila dan kan bawhchhe bawksi a, tullo deuhah kan insehruh tul te pawh kha a awm tawh lo deuh ang a, khawtlang tan pawh hmalak te pawh a chakawm tawh ang. Tin, kum leh maiah drugs nge kan hmansual dawn? Dendrite te pawh kan hmansual duh a nih chuan hming mak pui pui pawh a lo thleng leh ang, khang thlenga an huamchho te kha inngaihtuahna in va seng hnem em, a va lawmawm em tih hi ka sawi duh a ni a.

A nodal officer chungchangah khan kan Minister zahawm takin arawn clarify atana ka duh chu Joint Secretary level kan tih ah khan a staff, a backup tu tur kha a kengtel turah ka lo ngai ve a. A chhan chu a department concern hian Health a khawih dawn a, Excise, Police, Paramilitary Force, NGO; chu lo pawh a lo piang teuh ang. Khami daily-a monitor tur khan engtingge a staff leh office set up hrim hrim kha helaiah awm lo mahse a awm dawn tho a, power hetah awm tho a, kha kha hriat a chakawm ve hrim hrim a, nakinah a wind up hun ah minrawn hrilh theih chuan. Kha kha sawi tur a tam mai a, ka sawi ang khan mahni inchan ila, he Bill vawiina kan pass tur ka ti tawh mai a, pass ngei ngei chi a ni a. Khang kan hunlaia mahni veng theuh, mahni khua theuha (kan member zahawm tak tak te pawh in ni ang,) in kalchhuah nikhuaa inhnungkhirh ang te, khingbai deuha khawtlang thenfaina kawngah hma in lakna kawnga khang diptu zawng zawng kha an awm ta lo ringawt mai hi, in chhiar thlak pawh khan in hre thei ang. Vawiina hetiangafelfai tak, Mizoram context mil bawksi anga kan Minister-in arawn pho chhuak hi lawmawm ka ti a. Heta Memorandum of Delegated Legislation-a thu arawn khaikhawm dan kha a thlamuanthlak ka ti em a, i phalna in Pu Speaker, kan chhiar hial teh ang, “ Moreover there will be a provision to simplify the procedures of conviction to raise the conviction rate and quality treatment of addicts. Hence, there is delegation of power involved in the proposed Bill” a ti a. Hei hian vawiina kan Bill kan Minister zahawm takin arawn ken, arawn putluh “The Mizoram

Drug (Controlled Substances) Bill, 2016” hi he House zahawm tak hian pawmpui ngei turin ka rawn dilpuiin ka rawn thlawp a ni e. Ka lawm e.

DEPUTY SPEAKER : Midang tunge? Aw Pu RL. Pianmawia

Pu R.L. PIANMAWIA : Pu Deputy Speaker, helai chapter 6-na Procedure , Section 21-na sub-section 2 tlar tawp lampanga a man thei tu tur atana peon leh helper or constable tih hi a him dam ber ang em kan kal zelna tur atan hian? Minister-in min han hrilhfiah deuh sela, a pawl lem dawn loh chuan ka pawm thei tho bawk a. A dang hi chu pass atan a tha ka ti vek mai e. Ka lawm e.

DEPUTY SPEAKER : A lawmawm e. Tunge han sawi leh ang? Pu Lalthanliana.

Pu LALTHANLIANA : Pu Deputy Speaker, ka lawm e. Kan Minister zahawm takin he Dan a rawn putluh hi a hmasa in ka pawmpui a, pass pui pawh ka duh a, a tha ka ti khawp mai a. Amaherawhchu kam hnih khat lek han sawi ka duh a.

Pakhatna ah chuan Chapter 5, Section 10, Clause (a) leh (b)-a small quantity tih leh commercial quantity tih te kha eng chin hi nge an nih ang aw tih kha ka ngaihtuah a. Hei hi tuna sawifel chi nge nakinah Rules in a rawn sawifel mai ang tih kha, rules in a sawifiah zo dawn lo a nih kha chuan sawifel nghal law law a va tha awm ve tih ka ngaihtuahnaah a awm deuh a.

Tin, tha ka tih deuh chu Section 9, Clause (b) hi a ni a. Drugs hman sualte tana detoxification te, rehabilitation te awm tur hian jail-ah khung mai lova chance tha tak mai mihring siam thatna hna thawhna tur atana helai clause rawn in hawng hi a tha ka ti em em a.

Tin, Section 14-a hremna kha a turu ang reng riau mai ka ti deuh a, amaherawhchu ka sawisel lem hlei lova sawisel phei chu. Twice tih vek kha a ni a.

Tin, hriatthiam ruai ruai hriatthiam chian loh ka nei a. Section 16 kha a pum khan min hrilhfiah chiang deuh se ka duh khawp mai a.

Tin, Chapter 6, Section 21, sub section 2-a tuna ka hmaa member zahawm tak sawi kha tlar hnuaihnuung tawp lampang ami ‘any officer subordinate to him but superior in rank to a peon, helper or a constable’ tih hi a extra mai mai lo maw, officer an ni lo tih chu a chiang tho si a ‘but superior in rank to a peon’ tih hi a tul kher em tih ka ngaihtuahnaah chuan a awm a, ‘any officer subordinate to him’ tih ah hian a tawk mai lo em ni? Tihdan te ka thiam ve lem lova, ka ngaihdan ka sawi ve a helaia section 25, sub-section (2)-ah pawh hian an sawi thla an sawi thla a, a dap thei tu mihring chungchangah khan, a tlar hnuhnuung ber sub-section (2) ah khan , Magistrate proceed to search a person as provided under Section 100 of the Code of Criminal Procedure, 1973, hei hi enge ni ang aw tih kha ka rilruah a awm deuh a, a tum leh a kalphung hrim hrim hi chu a tha ka ti a, hei hi kan thlawp a ni. Ka lawm e.

DEPUTY SPEAKER : A lawmawm e. Tunge han sawi ve leh ang le. Pu H.Zothangliana.

Pu H.ZOTHANGLIANA : Pu Deputy Speaker, ka lawm e. The Mizoram Drug (Controlled Substances) Bill, 2016, hetiang taka tha a kan Minister zahawm takin a rawn pulut hi a lawmawm ka ti em mai a, kan ding ve duh hrim hrim pakhat a ni.

Mizoram mamawh tak mai Dan tha em em mai, kan mamawh a ni tih kan hriata kan sawi ve fo thin, mahse engtiang taka siam tur nge ni ang aw ti a, a ngaihna tak keini ang chuan kan hriat loh kha kan Minister leh a thawhpui te, officer leh kan mithiamten thahnemngai taka buaipuiin, tha deuh maiin an rawn duang chhuak a, an rawn chhawpchhuak ta hi a lawmawm tak meuhin ka hria a ni. Chutih rual chuan member zahawm tak thenkhatten an sawi tawh ang deuh khan, tha em em ah pawh hian, han keu han keu takah chuan helai te hi chu heti deuh tur hi a ni lawm ni, han tih zeuh zeuh tur hi chu a awm ve tho in ka hria a. Chungte chu a te tham deuh viau na in a tha em a, thil lian pui pui sawi tur a awm lem loh avangin te tham deuh te te pawh kha Pu Deputy Speaker, han sawi mai ila. Thahnemngaihna vangah min lo ngaihsak dawn nia.

Pakhatnaah khan Section 2 (iii) “controlled substances” means any substance declared by the Government by notification, tih kha a awm a, kha kha, “controlled substances” means any substance declared as such, tih tur a ni lawm ni aw, ka ti a, ‘as such’ tih kha tel se a kim leh zual awm mang e, ka ti.

Tin, Section 3, sub-section (iii) The Government may, if it considers necessary or expedient so to do, tih a awm a, ‘so to do’ ti lo in, ‘to do so’ tih kha a ni zawk em aw, ka’n ti deuh a ni. Tin, kha mi sentence kal thla zel ah khan, tlar tawp ber dawttu ah, ‘taking measures with request to such of the matters’ tih a awm a, ‘with request’ ni lo in ‘with respect’ tih tur chhut sual palh mai a va ni awm em, ka ti a ni.

Tin, chapter-IV ah khan ah section VII, clause (a) ah khan, ‘possess, sale’ khami ‘sale’ a kha S-a-l-e a ni a, s-e-l-l , ‘sell’zawk kha niin a lang. Chubakah chuan chapter V, Section 9 ah thil te tak te bawk, clause (c) ah khan, a line parukna ah khan, ‘both, and the vehicle as used’ ‘ as used’ tih a awm a, ‘and the vehicle so used’ tih ni awm tak a ni, ‘ as used’ ni lo in.

Tin, khami chungah khan ka’n sawi hmaih tep a, a sub clause (b)-ah zawk khan line 4 na ah – ‘ chemical form, such person shall undergo with’ tih kha a awm a, ‘such person shall undergo with compulsory detoxification,’ tih a ni a, ‘with’ kha chuangtlai palh mai mai a ni em aw, ka ti. ‘Shall undergo compulsory detoxification’ ni mai awm tak a ni.

(DEPUTY SPEAKER : Eng section maw i tih tun ami tak kha?)

Pu H.ZOTHANGLIANA : Section 22 sub-section I, clause (d) proviso tlar hnung ber kha, between sun set and sun rise a rawn ti ta hlauh a khatah khan, kha kha sun set and sun rise ni lo in, sun rise and sun set tih leh tho tur ni ngeiin a lang. A kawh tum kha a letling, a inang lo hlauh a ni.

Tin Section 27, sub-section I-ah khan, ‘ The Government may’ tih kan hmu a, tichuan a kal phe i zel a, sentence kar zeh kan ti mai ang chu, a kal phe i zel a, line 5 na ah khan gazette tih kan hmu a, gazette tih zawh coma zawhah khan, shall, tih kha a awm leh a, ‘ shall specify’ tih a ni leh a, kha kha a tlar hmasa bera ‘may’ a awm tawh avangin, ‘shall’ emaw ‘may’ emaw kha a engemaw zawk zawk kha chu chuangtlai ni ngeiin a lang. Sub-section (i) of section 33 tlar tawp lamah khan a punish dan tura kha “6 months or with fine or with both” tih kha a awm a, “with fine” tih lai taka kha sawifiah zui a ni ta mia h lo a, hmun dang zawng zawngah kha chuan a fine-a kha cheng engzat thleng nge ni thei ang tih kha a awm vek a, helai bik a awm loh chhan hi enge ni ang aw ka ti a. Sorkar lam mi te hremna tur a nih avangin cheng 1 lek pawh chawi tir kan duh maithei a, tihna avang em ni ang aw ka ti a. Chutiang a nih chuan a fair bik chia h dawn em ni? Midang zawng zawng hrem theihna pawisa bituk a awm vek si laia, helaia a pawisa zat specify a ni ve lo hi, a fel lo deuh em tih kha ka rilruah zawhna lianpuin a awm a ni.

A dang leh ah chuan Pu Deputy Speaker, Section 34 pumpui kha ngun takin , khawngaih takin Pu Deputy Speaker, saptawng thiam takin han chhiar la, a saptawng kha a khingbai a, sentence kimchang a ni lo tih min pawmpui ka ring “Whenever any offence punishable under this Act” tih atanga a piah lam zawng zawng kha chu thu tlazep ang a ni a, a zawmtu chu a line hnung ber “shall be liable to confiscation tih kha ani “Whenever any offence punishable under this Act shall be liable to confiscation” tih a ni a, sentence kalhmang kha a kim lo a ni, engemaw hmaih a awm niin a lang a. Chu chu kimchang deuh taka ka hriatthiam ve dan a kan ziah that dan chu hetiang hi a ni. “Whenever any offence punishable under this Act is committed in respect of controlled substances, articles, documents, etc. or animal or conveyance used in carrying controlled substances. The substances emaw, such substances, articles, documents etc. or animal or conveyance so used shall be liable to confiscation” tih duah a ngai a ni, a kim tur chuan. Anih loh chuan a sei lutuk, a tul lo kan ti a nih chuan, heti hian tawi deuhin kim zawk, dik ve thovin a dah theih em aw ka ti a “Any controlled substances, articles, documents, etc., or animal or conveyance involved in any offence punishable under this Act shall be liable to confiscation” tih khan sentence tawi fel deuh zawkin a dah mai theih bawkin ka hria. Tuna inziak ang ngau ngau kha chu a kim lo a, a dik lo deuh em ni aw ka han ti ve a ni.

Tin, Chapter 7-ah khan Pu Dy. te, member thenkhat han sawi a man-tuten an man a, an thil man drugs te han hal ral mai kha chu uihawm tak te a lo awm thei a. Khang ang kha court in a confiscate ang a, hralh a, kha sum kha hemi atana hman leh theihna tur zawk a ni.
