a month-wise a, thla tina projection kha a rawn dang nual a, then khat chu January, February, March angah khan 3% vel emaw kum khata inhlawh tur emaw kha projection ah khan an rawn dah avangin a pek tam ngawt theih lova, July/August velah chuan thenkhat chu tuna, entirnan Saiha te chu ni 3 inhlawhna tur ang lekin kha January/February velah khan an rawn ti ta a. Amaherawhchu a thla leh June/ July te chuan ni 6 ni 7 inhlawhna tur ang khan an rawn ti chho veleh ta a, chutiang ang chu a ni a.

Ka sawi turte ka sawi hmain nichinah khan kan member zahawm tak khan vai te nena inneih chungchang kha a rawn sawi a, he Dan kan pass tum hi Mizo Marriage a ni tih kha hre chiang ta phawt mai ila, tichuan vai te nena inneih kha chu kan kal tir thei lo a ni tih kha hriat ni ta mai se.

Ka ngaihpawimawh hmasak ber mai chu man chungchang hi a ni, ₹ 420 tih hi a ni a. ₹ 420 hi kan hmang rei tawh em mai. Nupa thenkhat chuan an fate man hi mi kan han ei tir a, man ei turin kan han in ko khawm a, mi 50 te, 100 te ₹ 20 te tea han ei tir pawh khan ₹ 2000 zet mai an sem leh si a, man an sem lo tih hi chiang takin a hriat a ni. Nichin lawk khan member zahawm tak te khan Mizo hmeichhia leh mipa chanvo vawng tura kan han tih mek lai khan, mipa chauh mizo tur ang khan helai sentence 2- naah hian a nih chuan a nupui kha mizo a ni kher lo ang deuh khan a sawi em? A nih chuan ti lai hian a him tawk kim em? Tin, a Dan siamtu applilcation, hemi dan ‘Application of the Act’ ah hian, helai sentence 2 te hi min tibuai nge ka sap tawng thiamin a dah lo mai thei a. Hrilhfiah ka ngen deuh a ni. Ka lawm e.

DEPUTY SPEAKER : Pu Piana chu hun a la awm. Minute 5.
