Complex hi black top na a rei tawh a. Nikum hmasa lamah pawisa awm ang angin tlem tlemin re-surfacing tih a ni a. Kumin maiah a khuar chhe zual a, hei hi siamthat deuh reng a ni.

**Pu JOHN ROTLUANGLIANA, MINISTER :** Kan member zahawm tak, Pu Chalrosanga zighthna nichin khan ka lo chhang kimlo deuha, sun control hi a permissible chin a awma, khami bak kha chu a bel leh theih dan a awm chuang lova, dan lova an bel anih kha chuanin dan lovin an bel a ni mai. A bak kha chu a permissible chin bak kha chu dan ang chuanin a bel theih loh.

Tin, Sangau kha Christmas dawnah bus service an ti a, ni e, hei bus service hi tunhma atang khan Sumo hian min luahlan nasa khawp maia. (c) na chhanna : Agreement ang chuan thla 24 chhunga zawh tur a niin 1.8.2011 a zo tura ruahman a ni a. A huna zawh theih a nih loh avangin ni 1.4.2014 tleng kha pawhsei sak an ni. Sanction amount chu ₹ 795.85 lakhs a ni. (c) na chhanna : Revised a la ni lova, revised tum mek a ni. A thlakna tur lei khu a dawh chhung a rei em em mai a, kan sawi belh duh a chu Pu Speaker, hei department in chhanna min pe a, Session hmasa khan ka zawt tawh a, March ni 20.2014 a min chhanna ah hian hnathawh zawh hun hi ni 17, July, 2011 tiin min chhang a ni. Tunah hian hnathawh tan hun a rawn danglam leh ta daih mai a. Kan House property a ni dawn si a, eng hi nge ni kan kalphung department enkawltu kan minister zahawm tak hian mawh a phur lo thei lova. Chulaiah chuan hnathawh zawh hun tura min chhanna hmasa pawh hi July ni 17,2011 a ni a extended upto 1<sup>st</sup> April,2014 tiin session hmasa ah khan min chhang a ni. Tuna zawhna nen a lo danglam ta daih mai hi enge a awmzia ni ta aw tih ka zawt duh a. ah reng reng soil investigation hi tih hmasak tur kha a ni a. Chutiang chu tih a ni lo em ni? Engatinge project tan hma in soil investigation an ti uluk lo em ni? tih ka zawt a. Tin, chu lo leh ah chuan tun session ah khan question hour ah tho hian Pu Speaker, kan minister zahawm tak khan contractor kha terminate la ni lo, thawk tawh lo ang khan kan ngaithla a, a bik takin Tantia ho kha. Chulaiah chuan, nimina zawhna unstarred ah khan contractor hi a in withdraw em ni? contractor hi a in withdraw lo tih a ni bawk si a. Khalaiah khan kan House-ah hian khawi zawk kha nge thu dik? Ban an ni ta nge tihtawp an ni ta nge? Termination Nilo tiha chhanna awm bawk si a ni e tiha chhanna awm bawk si kha engeni thudik kha he House zahawm tak hi min hrilh thei em ka ti a. Tin, zawhbelhna dang leh chu contractor te hi tun dinhmunah khulai lei dwh na atan khuan sum engzat nge kan pek tawh? tih ka zawhbelh e.

**SPEAKER** : Awle, kan Chief Minister i sawm ila.

**Pu LAL THANHAWLA, CHIEF MINISTER** : Pu Speaker, a zawh hun leh khatiang tahrik neuh neuh kha a diklo a in contradict a nih chuan a hmasa ami nen pisa lampang inthlahdah vang a ni tih a chiangin ka ring a, a pawi khawp mai. Mahni hnna tui vaklo te hi kan ngah khawp a, kan sorkarah hian tui tha tak tak an awm teuh rualin tui vak lemlo phuailuai deuhte hi an awm thin a, thil pawi tak a ni.

Tin, contractor te kha an in withdraw lova, tun thlenga contractor hnena pek chu nuai 357, sing 9, 150 a ni a. Tin, tun hnai deuh ti mai ang, sorkar hmasa sa leh atang tawh pawhin heng lei dawh vel ho hi, ‘a dik lo, a chuti khati’, tih hi a tam hle mai a. Hei hi thil pawi tak a ni a. Redseismic zone-ah kan awm a. Khawvela lirnghing rapthlakenglai pawha thlen theihna reng ram kan ni a. Chubakah mithiam te chuan kan ram leilung formation hi a loose a ni an ti bawk a: chuvangin, landslide prone area te pawh kan ni a. Heng zawng zawng hi chipchiar taka en vek a, hetiang leihlawn, hnam ro ang chi te hi chu tih tur a ni a. Chu chu an ti lo tihna em ni ang ka hre lova, khulai lei te, Bairabi a kan dawh ang te pawh hi, ‘a foundation a dik lo, chutiang khatiang, chuvangin tih that leh a ngai’, tih hi a ni deuh reng mai a. Chuvangin, ngun taka Redseismic zone a kan awm tih hria a, kan ram leilung formation te pawh a dup a ni, a

nghetlo a ni tih te, lei tlahniam te pawh hmun tinah kan nei a, heng ang te hi ngaihtuah thuk hle a ngai a.

Tin, lungchang hetianga hman tur tha te pawh hi nei lo ram kan ni a. Heng atang hian hetiang leihlawn uluk tur, hnam ro tur ang chi hi chu ngun lehzual, uluk lehzual a tih a ngai, en a ngai a ni tih hi a chiang a. Chuvangchuan, tun hnuah chuan fimkhur turin kan Engineer te leh hetiang lama mawhphurtute chu tunah pawh hian ka rawn nghal a. Tin, chutiang an tih loh chuan nakinah khu tuna lei chim ang te khu a vanduaithlak a, mahse khutah khu chuan kan engineer-ten mawh an phur vakin ka hre lova. Thenzawl leh Sairang inkara Mat lei te pawh saw an ru thin tih hriat a nih in chowkider kan dah ringawt a. Mahse, chowkider awm lohna lamah sAWN an la ru zeuh zeuh reng e an ti a. Chuvangin, mihring tan a hlauhawm ang em tihte pawh hi check zeuh zeuh a ngai a, kan check tir zeuh zeuh bawk a, chutiang chu a ni a.

Chuvangin, khulai khu tunah hian kan harsat phah hle a, a pawi khawp mai a. Tun hnu zelah pawh helai mawhphurtute chuan an fimkhur hle a tul a ni tih an inhriatna tur atan pawh hmang nghal se a tha ang. **Pu K. SANGTHUAMA** : Pu Speaker, hmanni lei a chim khan ka zu kal ve a, ngun takin kan zu thlir a. Tuna kan Chief Minister zahawm takina an sawi a kilhna ruk tih leh thil kha chu alo awm anih pawhin chiang takin kan en vek hman lova, khalam kha chu thudang ni sela. Kan hmuh dan pakhatah chuan a lehlam lehlamah a foundation a tan chhan tur kha a chahbi engmah a siam lova, a kilhna pawh a awm lova, fit 2 awrh kha helaiah hian a inphah phei a. Chu chu heti laiah hian kilhna nghet tak awm ve tur awm tak kha a ni a. Chu chu an tihdan phung a lo nih loh pawhin tihdan phung atan chuan tha awm tak niah kan ngai a. Chuvangin, hetia tlema alo fual tak khan sawlam ami leh helam ami sairang lam leh lengpui lam kha an lo inpawt ta a, tichuan awlsam takin a tla ta mai a tih kha chiang takin kan hmu a, rei tak kan zu awm a. Chuvangin, kan Engineer te hian leihlawn dawh chu an thiam lova kan ti hauh lova, khulai an dawh khuan an enpui tawklo deuh a ni lo maw? Hei hi tun hnuah chuan fimkhur tawh sela, a that kan ring a. Khuti lai

khu engati nge nichina a zawh ang deuh hlek khan athlangta, tuna thawh mek khu a rei tawh viau va, tunah kan zawt chiang a, a foundation hnuaiah hian khuarkhurum ti hian kurung ang deuh a awm phei a, chuvangin, en ngun leh loh chuan chhunzawm tlak a ni love an ti leh a, chuvangin, an dawh dawn hian nichina zawhna pakhata an sawi ang khan ngun takin an en lo em ni? tih kha ka zawhna pakhat a ni a. Tin, engatinge a lehlam lehlamah khan chahbi awm miah lo a contractor hian Lei a dawh theih? tih kha ka zawt a ni, zawhbelhna atan.

**SPEAKER** : Dr K.Beichhua khan zawt nghal mai se.

**Dr K.BEICHHUA** : Pu Speaker, kan House leader chhanna ah khanin ka vei deuh mai a awm a, kan Chief Minister meuh chhan tur khatia contradict deuha session hmasa leh tuna mi answer an pek kha pawi ka ti a, mi an inthlahdah hian achhan hi engvang nge tih kan zawn fo a ngai a.
