Awle, tunah hian kan President hlui sunna kan nei dawn a. A chanchin tlangpui min hrilh turin kan Chief Minister zahawm tak Pu Lal Thanhawla i lo sawm ang.

**Pu LAL THANHAWLA, CHIEF MINISTER** : Pu Speaker, vawiinah kan President hlui Dr.APJ Abdul Kalam, President lar tak, People's President kan tih mai, mi inngaitlawm, mithiam chungchuang sunna thusawi a lo ngai ta hi a vanduaithlak a, channa rapthlak tak a ni a.

Dr. APJ Abdul Kalam hi 27 July, 2015 zan dar 7:45 khan lung lam thatlohma avangin Bethany Hospital Shillong-ah kum 83 mi niin a boral tih kan hre vek tawh a. Pu Avul Pakir Jainulabdeen (APJ) Abdul Kalam hi Pu Jainulabdeen leh Pi Ashiamma-te fapa a ni a. 15<sup>th</sup> October, 1931 ah Rameshwaram, Tamilnadu-ah chhungkaw rethei takah a lo piang a. Pianpui unau mipa 4 leh hmeichhia 1 a nei. A pa hian lawng a enkawl thin a, an chhungkua an harsat avangin naupang te a nih lai atangin chhungte puiin hna a thawk a, chanchinbute a sem thin a ni. Lehkha a zir lai hian thiam thei fal nilo mahse, a hrat a, a bei ngawrh hle thin a ni.

Ramanathapuram Schwartz Matriculation school-ah class X a zagh hnuin Pu Kalam hian Saint Joseph's College, Tiruchirappalli-ah Physics ah a graduate a, he course a zagh dawn hnai hian a subject lak hi a tuipui zui lo hle a, a hnu thlengin a zirna atan kum 4 lai a lo hmangral chu a ui hle a ni.

Kum 1955 khan Aerospace Engineering zir turin Madras a pan a, fighter pilot nih a tum nachungin a hlawtling ta lova. Kum 1960 ah Madras Institute of Technology atangin a graduate a, Defence Research and Development Organisation (DRDO)-a Aeronautical Development Establishment-ah Chief Scientist angin a lut a, kum 1969-ah Indian Space Research Organisation (ISRO) ah sawn a ni a. Kum 1992-1999 chhung khan Prime Minister Chief Scientific Adviser leh SRDO Secretary hna te a thawk.

Kum 2002-ah NDA (National Democratic Alliance) in India President turin a hming hi an rawt (propose) a, party dang zawng zawng deuh thawin an thlawp bawk a ni. Ni 25 July, 2002 ah India President 11-na atan thlan tlin a ni a, he hna hi ni 25 July, 2007 thleng a cheh a ni.

Pu Kalam hian India hmasawn nan a thiamna leh a tha leh zung tam tak a seng a, Indian Satellite Programme, Ballistic Missile Project, Nuclear Weapons Programme leh Light Combat Aircraft (LCA) Project lama a thawh hlawk em avangin "Missile Man of India" tih a nih phah hial a ni.

India President a nih lai hian mipuite tana a thawh nasat avang te, a mize tlawm tak avang tein mipuite President “People’s President” tia vuah a ni hial a ni. Naupang leh thalaiten an ngaina a, kum 2003 leh 2006 kumah, kum 70 a tling tawh chungin MTV Youth Icon of the Year atan nominate a ni.

Dr.APJ Abdul Kalam hian chawimawina hrang hrang a dawng hnem hle a, a kum 79 na tlin champha-ah United Nations chuan a piancham, October ni 15 chu World Student Day-ah a pawm a ni. University 40 in Honorary Doctorates an pe bawk. Chawimawina(Award) chi hrang hrang sawmpariat (18) lai a dawng bawk a ni.

Pu APJ Abdul Kalam hian ni 24.9.2005 khan Mizoram Legislative Assembly pawh rawn tlawhin House a rawn Address a, Mizoram tana pawimawh leh kan bawhzui theih mai tur thil tam tak a sawi a, chung a thusawi tlemte chu han tarlang ila.

“Mizoram hian ram awl thil chin nana hman theih la hman loh hectares sanghnih zaruk (2600) a la nei a, heng ram awlah te hian senso tlemte in tlhai tam tak a thar chhuah theih a. Thlai thenkhat chu kum 50 vel a dam thei a, thei thenkhat phei chu kum hniih (2) chhunga ei tling thei pawh a awm a ni. Hengah te hian tan lakna tur hma eng tak in nei a ni.

Mizorama Mau awm tam takte hi tun aia tangkai zawk hian a hman theih a, heng maute hi industry tan hmanraw tangkai tak a ni. Mau hian thil tamtak a siam chhuah theih a, Mau hmang hian sumdawnna hautak lo hlawk tak si a siam theih a ni. State tam takin heng thil hi an kalpui mek a ni. He sumdawnna hian 30 crores vel a huap thei dawn a, heta tang hian 10 crores vel chu a hlep theih dawn a ni.

Thei lamah pawh serthlum, ser, lakhuihthei, thingfanghma, a sawngbawlna hmanrua pawh din ni se, tun ai hian a hlutna hi a zualin sum lakluh tam nan a tha hle a ni. Mizoramah Anthurium hi a tha duh hle a, Anthurium hi Delhi-ah kau khat (piece) hi ₹ 6 to ₹ 25 a ni a, an thawn chhuak bawk thin a ni. Anthurium Market hi kum tinin 10 crores vel a ni a. Anthurium hi ching turin ka ti ringawt lo che u a, tun aia a hlutna tipung turin leh sum tam lehzual lakluh nana hmang turin ka duh che u a ni.

Mizoram hian Nursing College mi 200 vel tum khata training theihna in din thei a, Damdawi lam training te hi certificate tha tak pechhuak thei turin leh international standard mil thei turin tan kan lak a ngai a ni. Kum 2012 ah chuan khawvelin nurse maktaduai tel a mamawh dawn a, India ramah pawh health lamin an ruahmanna ang chuan nurse nuai li (4,00,000) vel a mamawh dawn a, chuvangin Mizoram pawhin he ruahmannaa telve thei tur hian Nurse Training lamah hian tan lo la turin ka duh che u a ni.” Hengte hi House a address tuma a thusawi thenkhatte chu a ni.

Tin, Sairang a tlawh tumin Sairang khawtlangin an mangannate an lo thlen a. Sairang balu mahal system-a sorkarin a tih thin chu titawpin, Dr.APJ Abdul Kalama'n a tlawh atang hian Sairang mipui kutah an balu te chu a awm ta a ni.

Lehkhabu tha leh rotling tak engemaw zat a ziak a, chung zinga thenkhatte chu 'Wings of fire', 'India 2020 - A Vision for the New Millennium', 'My Journey' leh 'Ignited Minds - Unleashing the Power within India', tih te a ni.

Dr. APJ Abdul Kalam hian President hna a chelh tawh loh hnuah pawh zirtirna hna a thawk chhunzawm zel a, 7<sup>th</sup> July, 2015(Thawtanni) zana Shillong-a Indian Institute of Management a zirtirna hna pea a thusawi laiin zan dar 6.30 velah chauin a tlu a, Bethany Hospital-ah hruai nghal a ni. Damdawi ina thawktute chuan a nunna chhan tumin theiawp an chhuah a, mahse an chhan zo ta lo, zan dar 7.45 ah lunglam tha lo avangin min lo kalsan ta a ni.

Dr. Kalam hian unau a neih zat chu kan sawi tawh kha, tunah hian a unaupa Mohamed chu kum 99 mi niin an khua Amisuar-ah la khawsain a hna a la thawk mek zel a ni. A thi tih hriat a nih veleh sorkar laipui chuan President hlui hi ram pumah ni sarih chhung July ni 27<sup>th</sup> atanga 2<sup>nd</sup> August thleng sun tur thu a puang a, Mizoram pawhin hemi hun chhung hian a sunna lantirna flag pawh a ngul chanve (half mast) in a zar a ni. A thih zan hian a ruang hi Military Hospital Shillong-ah dah a ni a, a tuk ni 28 July-ah Air Force Helicopter-in Guwahati-ah phurh thlak a ni a. Guwahati Airport-ah sorkar mi pawimawh thahnem takin an uizia lantir nan zahna chibai an buk a, Guwahati atangin Delhi-ah Special Aircraft-in an phur thla leh a, Delhi-ah hian sorkar chawimawina famkim nen an thlah leh a, mi tam takin zahna chibai an lo buk a, ni 29 (Nilaini) zing karah a pianna Rameswaram-ah phurh thlak leh a ni a, a tuk ni 30 ah Sorkar chawimawina famkim nen vui liam a ni. Chutiang mi ropui kan ramin kan chan ta hi channa rapthlak tak a ni tih hi ka sawi duh a ni Pu Speaker ka lawm e.
