Khami a nih kha chuan kan state economy hi central lam atang pawn min rawn hmuh san pui ve hle em ni aw, tihna te pawh hi ka nei a. Chuvangin he budget kan sawiho mek hi a tha hlein ka hria a. A hrang hrang han en hian sawifiah pawh ngai lovin kan Finance Minister zahawm takin a lo sawifiah tawh avangin khalai te kha ka'n sawi duh chauh a ni e. Ka lawm e.

Helai Fiscal deficit GSDP atanga teh a, 3% aia sang lo ngei turin min beisei a ti a, Minister-in 0.77% nei tura ruahmanna a rawn siam chhuak te hi a ropui ka ti a.
