KUM 2016-2017 FINANCE MINISTER BUDGET SPEECH

Pu Speaker,

1. I rem tihnaid he House zahawm takah hian 2016-2017 chhunga Mizoram sorkar sum hman tur, Regular Budget for 2016-2017 leh, 2015-2016 Budget Estimate-in a huam loh sum hman ngai si, Supplementary Demand for Grants for the Budget Estimate 2015-2016 te hi uluk taka sawi ho a nih hnua lungrial taka min pawmpui turin ka rawn pharh dawn a ni.
2. Nikumah khan harsatna eng eng emaw vangin kan Budget kha October, 2015 ah ka pharh thei chauh a. Kuminah erawh a hun taka 2016-2017 Budget puitling ka pharh thei tur hian min tilawm em em a ni.
3. Fourteenth Finance Commission hun bul a intan avanga harsatna kan tawh te, sum min petu Central lam NASA taka an insiksawi avang leh kalphung thlak danglam a tam avangin nikum khan March thlaah Budget pumpui kan pharh thei lo a. Kuminah erawh thil a dik zawngin a inher rem ta a, ka Budget pharh tur, 2016-2017 Budget zet hi chu chhuang takin ‘Budget tak tak Mizoramin kan neih hmasak ber’ tiin ka sawi duh a ni. A chhan chu; a vawi khat nan kan sum hmuh leh hmandan tur chungchangah zallen pumhlum deuh thaw kan nei ta a, kan sumhmuh tur zatte fel taka bithliah a nih tak avang hian a hmanna tur lam pawh kan duh angin fel takin kan bithliah thei ta a ni.
4. 2015-16 Union Budget chuan Sorkar laipui atanga State Sorkarte hnena sum pekchhuah dan chungchangah thil NASA takin a ti danglam a, chung zinga pakhat chu Government of India Sponsored Schemes te thawhna atana sum intumsem dan chungchang a ni. Centrally Sponsored Schemes kan tih hote kan kalpui thin dan tidanglamin kalphung thar, State leh Sorkar laipuiin 50:50 a intumsem tawh tura hriattir kan ni a, he thil vang hian a hma, 90:10 a nih lai pawha kan kalpui tawk tawk thinte chu kan kalpui thei tawh dawn lo mai ang tih kan hlau hle a ni. Vanneih thlak takin Central Sorkar chuan a tira rawtna awm chu 90:10 leh 80:20 anga kalpui turin thu a titlu leh ta a, kan lawm hle mai. Heti chung hian Mizoram sorkar chuan eng scheme-te nge kalpui ila tha ang tih chu fimkhur takin a la ngaihtuah reng a, State Matching Share (SMS) te tha taka pe chunga sorkar sum harsatna NASA tak thlen lo tur zawngin remruatna kan siam thin a ni.
5. Thil pawimawh tak ka hriat thar chu, hun rei vak lo liam ta atang khan he House-a kan Legislator zahawm tak takte, kan journalist rual te leh mipui nawlpuiten kan Budget hi a hma zawng aiin an ngaihvenin an zir uluk peih ta

hi a ni. Hei hian kawng dik kan zawh chho mek a ni tih a entirin ka hria a, min tilawm takzet a ni. Tin, khua leh tui duhtakte hnena hriattir ka duh ber pakhat chu kan Budget-te hi kan mamawhte a tha thei ang bera min phuhruk tura uluk leh fimkhur taka duan leh buatsaih an ni tih hi a ni. Mizoram mipuite hnenah ka kova mawhphurhna tlate hlenchhuah a nih theih nan leh Mizoram sum dinhmun a lo that chhoh zel theih nan tha taka min thawhpui zel ka ngen a ni bawk.
