**Pu B. LALTHLENGLIANA** : Pu Speaker Food & Civil Supplies Consumer Affairs Minister zahawm tak chhan atan ka Starred Question No. 41-na, Gas harsatna hian ziaawm lam a pan thei dawn hnai em ?

**S P E A K E R** : A chhang turin a enkawltu Minister zahawm tak Pu H. Rohluna i lo sawm ang.

**Pu H. ROHLUNA, MINISTER** : Pu Speaker Member zahawm tak Pu B. Lalthlengliana zawhna chhanna chu hetiang hi a ni. Gas harsatna hian ziaawm lam pan zel tura beisei a ni.

**Pu B. LALTHLENGLIANA** : Pu Speaker he zawhna ka zawh na chhan chu Gas Distribution System nikum vel atanga tihdanglam a nih atang khan namen lovin phai lam atanga kan hmuh hi pangngai reng mahsela, a hma aiin nasa takin Mizoram mipui hian harsatna kan tawk a, kan House Leader khan nimirpiah lamah sumdawngte leh company inkar thil a ni a, keini lo inrawlhna tur a awm lo a ti na a, amaherawh chu heti taka thing, chaw chhum nan a kan lo bansana hetiangna Gas alo harsat takah chuan sorkar awm ve na fam chu mipuiin harsatna an tawh chuan a inrawlh ngei tur a ni. A distribution system hi a diklo, a felloh vang niin a lang a. Entirnan, connection 10 nei leh pakhat nei kan inang reng te hian harsatna a thlen niin a lang, keini vengah chuan Consumers Union-in a distribution hna hi an thawk a, chhungkaw tin theuh Card pakhat theuh min siam sak a, Cylinder 10 nei leh 1 nei kan inang reng a, Gas a lo thlen a, kan number a huam hma chu kan la thei lova. Keini pawh January-a kan lak kha tunthla khan kan chhonzawm thei tawk a ni. Kawnpui leh Aizawl inkar via Sairang hi Gas tihchingpenna hmun ni a sawi a ni a, hei hian black-a lei tur a tipung nasa a, hei hi sawrkarin ngaihvenin a rang lama tihtawp ni thei se ka duh a ni. Minister zahawm takin Gas cylinder 10000 chuang lai a lakluh belh tih kha ka pawm thlap a, a lalut ngei ang tih ka ring. Amaherawh chu engzat pawh lalut sela a distribution system hi tihdik a nih loh chuan a chingpen a tam ting dawn niin a lang a, helaihia hian kan Minister zahawm tak hi thuk zawka inrawlhin tihfel a tum thei em tih ka zawt a ni.

**Pu P.P. THAWLA** : Pu Speaker, ka lawm e, ka zawhbelhna chu Saiha vela ka han zin thin lai hian Gas hi an quota an chan, an zuar chhawng em chu ka hrelo va, Cylinder pakhat hi Rs.1000/- vela an in lei sak thawm riva ka hria a, a semna MIZOFED lama an black ruk thin nge ni a nga, tin flow taka lo dawng tam deuhin an zawrh chhawna mai nge chu ka hre chianglo, chuvangin ka zawhbelhna tak chu hetiang a distribution centre atanga black-ah an lo hralh ruk thin angte hi man a awm tawh em? Chutiang chu engnge a hremna ni? tih hi ka zawhbelhna pakhatna ni sela.

Tin, nikum hmasa khan District pali velah khan distributors thar lak belh tur kha a ni a, khangho kha engnge tunah hian hmasawna, a distributors-te khan an tih tur chin te an tifel zo tawh em? An distribute thei dawn tawh em? tih ka zawt e.

**Pu H. ROHLUNA MINISTER** : Pu Speaker ka lawm e, member zahawmtak a zawhna neituin arawn sawi kha, a distribution system hi a diklo a ni a ti a, mahse, hei aia tha hi Mizoram tan chuan a har khawp mai tih hi vawiinah hian House-in min hriatpui ka duh a. Tunhma area neilo a distributors an awm khan kawngpui dung leh a awlsam deuh laiah chuan an tlan khawm deuh thin a, veng kilkhawrah hian an dawng phak meuh lo a ni, chu chu chiang taka han thlir let pawhin in hre theiin ka ringa. Tunah erawh chuan Gas hi Distributors hovin area an nei a, veng hrang hrang Aizawl bikah chuan, an area theuhah rotation-in an sem a, chutiang chuan tih a ni a, tin, Local Council te helaiyah hian min lo enpui turin Sorkarin a ngen a, chumiah chuan thahnemngai takin annin min lo enpui a, chuvang chuan a rual khai thei ang bera sem dan tur hi Local Council-te pawhin an ngaihtuahna a ni a. Tin, veng thenkhatah chuan Member zahawmtakin an veng a sawi ang khan Consumer Union-te pawhin an ti bawk a, Local Council-in an tih loh chuan chutiang chuan kalpui a ni a, a rual khai theih dan tur ngaihtuahin chhungkua pakhatatah card pakhatatah kalpui a ni a.

chuan hei chu mi rate aia sang uchuak takin a black pawh a ni silova hei hi, black ni lo black anga kal a ni a, a dik lo hle maia buhfai te nen khan, hei hi,ka zawhna in lo hmuh atang khan ati ti chu, chu tiang khatiang a ni a, action kan lo la tawh e tiin min chhan ka lo beisei tehlul nen Pu Speaker, hei aia chak hian hma min lo lak sak teh se.

**Pu H. ROHLUNA, MINISTER :** Pu Speaker, chutiang chu mimalin an tih hi sawrkarin kan hre lo hrim hrim a, chuvangin agent- te pawhin a hmunah motor 207 te 407 te in kan va sem thin an ti a, chu chu an sem dan ni turah kan ngai mai a, Rs 430/- in kan sem an ti a, chu chu lo commission palh te an lo awm chuan hengte hi chu kan lo enfiah ang a, dan ni lova mimal thuneihna anga kal hi chu sawrkarin a duh hauh lo a ni. **Pu LALRINLIANA SAILO, MINISTER** : Pu Speaker, member zahawm tak Pu Lalduhoma zawhna chhanna chu–Mizoram atanga ram pawna thirchhia hralh chhuah zat leh a hlut zawng hi Trade & Commerce Department khawih anih loh avangin hriat a ni lo tih a ni a. **S P E A K E R** : Zawhbelhna, Pu Lalduhoma.

**Pu LALDUHOMA** : Pu Speaker, an chan anih miau loh khan chuan tihngaihna a vang khawp mai a, amaherawhchu, hmanah khan hetiang member-ten an chan emaw kan tih lo ni si lo kha chu a changtu department hnenah lo pek thin ni mai sela kha kan ti deuh kha niin ka hria a, keinin heng te te hi tunge chang tih kha kan va hre vek tawh si lova. Khatiang anga chhanna kan hmuh miah loh ai kha chuan siam rem dan kha chu awm thei selangin a tha hlein ka hria.

**S P E A K E R** : Awle, engnge i sawi tur Pu Lalrinliana Sailo.

**Pu LALRINLIANA SAILO, MINISTER** : Pu Speaker, a dik khawpin ka hria a, hei Assembly lam pawh hi an buai khawpin ka ring a, Transaction & Alleviation of Business Rule-ah hian 1987-ah engmah hi a lo awm si lova, keini pawn kan department anih si loh avang khanin Taxation-ah te kan han zawt a, an niin an lo khawih si lova, DC te kan han ti leh a, a ni bawk si lova, Industry te, chutiang ang zelin. Chuvangin, zawhna pawimawh tak ram tana pawimawh tak pawh a ni a hei hi. It is seen that the State Government did not consult the Central Government at that stage, and the case was defended without any prior consultation with the Central Government.
