(b) Vaivakawn to Mizoram University kawng laih mekah hian – (i) widening-ah sum engzat nge dah a nih ? Widening atan hian 2.99 crores (vaibelchhe hnih nuai sawmkua pakua) dah a ni. (ii) Pavement-ah sum engzat nge dah a nih ? Pavement atan hian 9.15 crores (vaibelchhe kua nuai sawmpanga) dah a ni. (iii) Culvert, Side-drain, Retaining Wall etc., ah sum eng zat nge dah a nih ? **Pu LALDUHOMA** : Pu Speaker, hemi chungchangah hian Calling Attention kha ka neih dawn tho avangin pakhat chauh kan zawt ve ang a. Hemi widening chungchangah hian a area in a huam chin Joint Local Council leh Joint YMA te an din a, Sorkar tan kan tualchhung hruaitute khu an tangkai em em mai a. Sorkarin a nek ngam lohte leh a sut ngam lohte an sut sak a, hna pawh an thulh hnem khawp mai a. Kan Joint Local Council leh Joint YMA ho hnathawh khu fak tlak khawpin sorkar tan an tangkai a ni.

Ka zawhbelhna chu tun sorkarin Muthi kawng tha taka a laih zawh tawh hi black top tura hma lak a ni em tih leh Aizawl Lunglei road National Highway atanga Airfield panna kawng hi black top tum a ni em tih chumi pahnih chu kan zawhbelh e.

**SPEAKER** : Pu Hmingdailova zawhbelhna thleng kan la ang a, amaherawhchu heti lai thleng, kan Mizoram University kawng kha a ni a, in zawt kai kha a ni a.

**Pu HMINGDAILOVA KHIANGTE** : Pu Spekaer, ka lawm e. Serkhan-Bagha Road-ah hian Compensation atan cheng engzat nge a dah tih hi kan Chief Minister zahawm tak department a ni bawk a, min chhang thei turin ka beisei a. Tin, an chawl rei ta viau mai a, tun hi working season a ni a, a uiawm hle mai a. Eng vanga chawl nge an nih tih leh engtikah nge an chhunzawm ang tih hi min hrilh thei em tih ka zawt e, Pu Speaker.

**SPEAKER** : Aw le, Pu Liantlinga pawhin a rawn phar a, mahse kan ko lo vang a. Khatianga a nih chuan kan MLA zahawm takten Bial chhungah hnathawh a awm vek a, vawiin nileng pawhin a daih lovang a, a changtu Minister tan pawh heti lai Mizoram University kawng zawt na naa kha tiang lam pang kha chu a lo inbuatsaih loh takin

khatiang lam kha chu chhang thei tho pawh nise. Tunah a theih ang angin zawhbelhnate kha han chhang teh se.

**Pu LAL THANHAWLA, CHIEF MINISTER** : Pu Speaker, engkim hre bera min ngaih avangin ka lawm khawp mai. Zawhbelhna Member zahawm tak Pu R. Lalrinawma zawhna kha Zuangtui –Muthi PMGSY kawng black top-na tur hi tunah hian DPR buatsaih mek a ni a, hmalak thuai tum a ni.

Tin, Lunglei National Highway atanga Airfield panna khawchhung kawng hi black top tum a ni em? Tih hi black top tura ruahman mek a ni a, nuai sawmthum zet ruahman a ni. Hei hi inthlan lehah chance pawh a tihthat hle ka beisei.

Pu Speaker, Pu Duhoma, Member zahawm tak zawhbelhna kha, hemi supplementary note ka neih hi House-ina a hriat ve hrim hrim atan thain ka hria a, kan sawi lawk ang a. Widening and Improvement of Vaivakawn to MZU kawng hi Ministry Urban development hnuaiah JNNURM hnuaiah ka sawi tawh ang khan ₹1907, nuai 64 lai hmuh a ni a. Nimin lamah pawh kan sawi a, kan kawng chhia hi kan vei a, mahselangin kawng a chhiat chuan siam that a ni dawn tih hi hriat thlap tur a ni a, mahse, a hun leh a ni erawh chu sum zemah kan duhtawk neia kan duh zat zat, remchang zat zat va lak mai theih a ni lo a, kutdawh hnam kan ni a, khulampang chawmhlawm kan ni a. **SPEAKER** : A chhang turin a changtu Chief Minister zahawmtak, Pu Lal Thanhawla.

**Pu LAL THANHAWLA, CHIEF MINISTER** : Pu Speaker, Ramrikawn to Sihhmui kawng hi laih tan kan chak khawp a, sum pawh a awm a, lai thei mai kan ni a. Mahse, kut tlinglo deuh pawha compensation lak tum kan ni a, kan tam a, sum ngaina hnamah kan tlu lut mek em aw ka ti a, sum ngaina hnama kan tluk luh chuan Bible-in soal tinreng bul a ni a ti, sum ngainat hi. Tin, sum ngainat chuan soal tinreng a thlen avangin tunah hian kan ramah soal tinreng a awm mek a. Tin, duhamna pawh a lo tel ta a, kan duham em avangin Aizawl khawpui hi kan chep mai mai a ni a, Ringtu, Rawngbawltu, vantlang tana hnawksak nih pawisa miah lo kan tam em em a. Chutiang chuan thenawm khawveng tana hnawksak nih pawisa lo kan tam a, mahni ram chhungah kan duham vangin kan motor te, JCB te, building materials te dah duh a ram pawh kan awm tawh lova, hnawksak takin kan dah ngam a, chuvanga chep chu kan ni a. **Pu LALDUHOMA** : Estimate zat kha min chhang ta lova. A alignment hi vawi thum thlak a ni tawh a, a tirah kha chuan Sihmui khaw chhungah khuan khaw tawn tirhah khuan a chhuak a, chu chu khuain an chhawr ber tur a ni a. An kal an kal a, khaw pawnah a chhuak ta a, tihdanglam theih tawh loh a nih chuan pawm loh theih a ni lova. **Pu K.LIANTLINGA** : Pu Speaker ka lawm e, kan zawhbelh duh chu PWD concern em em pawh a ni bik lova, amaherawhchu House Leader leh kan Chief Minister zahawmtak chhan tur anih avang khan ngaihtuahnate pawh a siam theih em tih kan zawh duh chu, hei land compensation hi a nasa em em mai a, Mizoramah engemaw han tih dawn hlekin hydel project emaw, kawnglaih emaw thildang reng rengah compensation claim hi a tam a. Hei Railway task force-ah hian kan awm a, a tirah kha chuan a tam lovin ka hria, amaherawhchu tu tute emaw an zawng chawp a, an siam chawp a, mi 500 deuh thaw chuanin an han claim ta mai a, vaibelchhe 50/60 vel a kai ta mai a. Heng-te pawh hi a ram /a hmun en chuanin a dik chiah lo a ni, thil chian sa a ni. Chuvang chuan, ram compensation kan lak hian department hnenah emaw Central ah emaw kan hralh tihna a ni ta a. Compensation ber kan lak tawh chuan hemi hi rented-in emaw rent out tur zawng hian a kalpui theih em? tih hi ngaihtuah ta ila. Minister Urban Development-in arawn sanction-na anga a hnathawh turte chu a hnuai mi angte hi a ni a. Formation cutting 16.7 kilometre pavement 16.7 kilometres, tin drainage work a awm bawk a. Tin, slab culvert 55, hume pipe culverts 3.4, side drain 15 kms, protection work – retaining wall 123 running metres, 210 running metres, Universit kal tlanga kawng laih hi University hotuten an phal loh avangin kawng survey that a ni a, Zihngthal kawng chhimlamah survey a niin, survey hna hi zawh leh phawt a ni a, amaherawhchu zawh leh phawt a ni a.
