Tichuan kan MNF group leader te, ZNP group leader leh MPC group lam atangte pawhin sawi duh nei in awm ka ring a, khang a group thliah thliah ang chauh khan ti ila a tha awm e. Tunah Dr. R. Lalthangliana.

Dr. R. LALTHANGLIANA : Pu Speaker, tukinah hian ka ngaihtuah thin a, tun kan term hi a danglam riau hian ka hria a. Tuntumah pawh hian kan MLA zahawm tak takte
