Khatianga bill helaia order an pekte khanin a thlenna turah te an tih thlen loh si avang leh sorkar ah bill an rawn pek tawh si avangin pawisa pe lo kha court ah an khing a. Tichuan tunah hian chhui a ngai ta a ni. Hei hi kum 2004 lam thil kha a ni tawh e, tih kha ka chhanna nise langin.

Pu H. Tin, heng Kolasib te leh hmun thenkhat, a chi anmahnia inngaihtuah duh zawk awmnaah hian a potential leh a dil zau nei pawh awm mahse langin Fishery ami la lem lova mahnia lo inngaihtuah te an tam avang a nih ka ring a. Chuvang chuan tuna kan han sawi ang chi a hi chu a District atanga demand lo awm, tin, chu demand pawh chu nichina a water area behchhan deuha tih a nih

Tuna kan Minister thar ina hun rei vak lo chhunga helai thil a rawn ruahman nghal hi lawmawm ka ti riau mai. A puitlin vat vat pawh a tha a. Pu Speaker, kawtchhuah pali – Chhim, Hmar, Chhak leh Thlangah hian awm diat diat thei selangan, bawlhhlawh pahna hrim hrim pawh hi a tha hlein ka ring a.
